**DELANEY BUTTE LAKES  
OFFICIAL ICE FISHING CONTEST  
RULES**

➤ **The bag & possession limit for trout is two fish for all three lakes combined. Brown Trout 14 to 20 inches in length must be returned to the water immediately. Rainbow and Cutthroat Trout 18 to 22 inches in length must be returned to the water immediately. All lakes are fly & artificial lure only. NO BAIT or attractants may be used. All Colorado fishing rules and regulations apply.** Please consult your 2019/2020 rules and regulations and be aware of rule changes.

➤ Only one major cash prize will be awarded to any entrant. Winners of major cash prizes are also eligible for hourly cash prizes.

➤ Contestants must show valid contest registration receipt to enter fish for measurement. Official

measuring station centrally located at the Delaney Butte Lakes SWA.

➤ Prize payout will be held at a location TBD in Walden, beginning at 6:00 p.m. on Saturday, February 1, 2020. Winners of cash prizes do not have to be present to win, and if not present at the prize payout will receive prizes by US mail. Drawing for door prizes will be held after payout. Winners of merchandise prizes must be present to win.

➤ Official time keeper is at the Lake John Resort Office.

➤ In the event of a tie, the first fish registered wins. For example, if three (3) 35-inch fish are the largest fish entered, the fish registered earliest will take 1<sup>st</sup> place, the second fish registered will take 2<sup>nd</sup> place, etc.

➤ Fish under 16 inches will NOT be eligible for measurement if brought in by an adult entrant. NO FISH INSIDE THE APPLICABLE SLOT LIMITS will be measured if brought in by any entrant.

➤ Only fish caught during the contest hours between

6:00 a.m. and 5:00 p.m. on Saturday, February 1, 2020 are eligible for prizes. \$75 hourly cash prizes will be paid for highest scoring fish measured during each hour from 6:00 a.m. to 5:00 p.m.

➤ Any violation of contest rules, Colorado fishing rules & regulations, State or County laws brought to the attention of the Chamber Board of Directors will subject the violator to review for prize eligibility by the Board.

➤ Only registered anglers may win prizes. Unregistered anglers in your party may jeopardize the validity of a fish caught by a registered entrant and will disqualify all persons in your group.

➤ Irresponsible use of motor vehicles or OHV (including ATVs & snowmobiles) by any member of a fishing party WILL result in disqualification of the entire party.

➤ The North Park Chamber of Commerce and its Board Members accept no responsibility for accidents or injuries on either thin ice areas or the surrounding areas of the Lakes as a whole. You are on the premises at your own risk.

➤ Pre-registration entry forms must be received by the Chamber via US Mail no later than 1/22/20. All fields must be completed, and payment must be enclosed. An official contest registration receipt will be mailed to entrant via US mail. Registration in person requires completion of Entry Form and payment of Entry Fee. Official contest registration receipt will be given to entrant.

# PRIZES

Scoring consists of calculation of length plus girth of each trout caught by individuals during the contest.

Fish under 16 inches will NOT be eligible for measurement if brought in by an adult entrant.

NO FISH INSIDE THE APPLICABLE SLOT LIMITS will be measured if brought in by any entrant.

To be eligible for the cash prizes, a contestant must have a valid Colorado fishing license, must be registered, & present paid entry fee receipt.

## ADULT CASH PRIZES

Grand Prize: \$1,000

2nd Prize: \$750

3rd Prize: \$400

4th Prize: \$300

5th Prize: \$200

\$75 per hour paid for highest scoring fish measured during each hour from 6:00 a.m. to 5:00 p.m. on Saturday, February 1, 2020.

Top prize-winning fish are included in hourly payoffs.

## PRIZES FOR YOUTH UNDER 16 YEARS OF AGE

Youth anglers under age 16 pay a \$10 entry fee,

And compete for separate cash prizes

1st Prize \$100 2nd Prize \$75

3rd Prize \$50 4th Prize \$25

Youth anglers age 12 and up may compete for adult cash prizes by paying the \$30 adult entry fee, purchasing an Adult Fishing License, and following Adult rules in the Contest.

The 16-inch length restriction does not apply to registered Youth anglers
