

#### ITEM 2: Report of the Secretary

9/11/2024

Mr. Sanjay Malhotra, Secretary of the Society read the Secretary's Report. Secretary extended gratitude to all the members for entrusting the Mc the responsibility of society and serving the society. Secretary presented an update on the work and project the Mc has undertaken since April 2024.

- (a) **Shaft Repair:** Shaft repair work is nearby completed. Through negotiations, we were able to reduce the contract cost substantially
- (b) CCTV Maintenance and Contract: We have completed repair and servicing / CCTV system .A comprehensive contract has been finalized for Rs. 70,000/- per Annual with flexibility of payment in instalments to service provider. The service provider has agreed for extension of annual Contract on same terms (without escalation) for further period.
- (c) Water crises in June between 11<sup>th</sup> and 14<sup>th</sup>:-Which was challenging for all. Measures have been taken to address and present similar issues in future. We have implemented water saving measures that resulted in notable saving on water charges
- (d) Water tank restoration:-Two 5000 litters water tanks near the shop have been serviced and are now operational and being used for for water storage towards any water shortage.
- (e) Electrical Accident: Unfortunate electrical accident in DG room resulted in an injury to Mr. Devraj. A timely first aid and thereafter quick treatment resulted in safe and faster recovery measures have been taken to present such incidents in future.

(f) Marriage of Rajesh's Daughter:-Contribution were made by members directly / ladies committee and gift were handed over to Rajesh family.

(g) Monthly expenses (Planned vs. Actual):-We are maintaining a close check on expenses, an overview of money spent in the past 6 months and collection from monthly maintances fund will be shared as against income of Rs, 33.32 lacs there has been an expenditure of Rs. 32.06 Lacs leaving a surplus of Rs. 1.6 Lacs.

ITEM 3: Adoption of Audited Accounts of the Society for the year Ended 31-03-2024:-Audited accounts of the society for the year 2023-24 were already circulated to all members. The audited accounts from the year ending 31--03-2024 were approved, unanimously and by majority members present by show of hands and No objections and/or dissent was raised by any member present.

ITEM 4:- Approval of the proposed annual budget society maintenance and sinking fund for the year for the FY-2025-26::-Proposed Annual budget, Society Maintenance and sinking fund for the FY 2025-26 was already circulated to all members. There was a proposal in proposed budget for increase in monthly maintenance charges by Rs. 250/-per month. The proposed budget along with increase in monthly maintenance @Rs. 250/- per month was approved unanimously and also majority member present by show of hands. NO objection and / or dissent was raised by any member present.

ITEM 5. Approval expenditure towards change of Dg sets as per new Norms:-It was put up before AGM that as per Govt. norms/ regulations DG sets prior to 2004 are to be replaced. All members present unanimously and by majority approved that DG Sets be replaced at the earliest. However, some member were of the opinion that quotation's be taken for PNG generators sets also along with diesel DG sets and after costs are finalized (Including value for selling of old installed DG Sets) a special General Body Meeting (GBM) be called for approval of final price. The members however, unanimously and by majority approved that 2Nos. DG sets be purchased as presently working / installed in the society.

ITEM 6. Any other items:-Utilization of fund from Sinking Fund towards repair of roof top and pipe leakage of internal pipe in all balcony. All members present unanimously and by majority approved that repair of roofs and pipes be changed to sinking fund and not by way additional cost from members.

#### Items 7. Any other items with permission of chair.

- (a) Members present were of the view that there is inadequate staff to assist the Manager and members have been facing problems due to shortage of staff. Members unanimously and by majority approved that one full time staff, who should also do account work, be engaged and for this necessary applications be invited.
- (b) Mrs. Vaishali Deshpande (Flat No. 543) present raised an issue regarding severe damage caused to her car due to children playing football in the lawn. Members present were of majority view that MC should take a call on this and issue instructions as to what to be allowed and what to be prohibited.
- (c) One member raised an issue for making a mandir in the society premises for convenience of members and their family. However majority members had divergent views on this, thus this proposal was not put to vote.
- (d)MC Members (Smt. Veena Tiwari) raised the issue that parents needs to educate their children's to respect the elders and decisions taken by MC. She raised the issue of damage to her windows by children, playing football and other sports.
- (e) Mr. Chawla raised the issue that society website should be renewed and updated.
- (f) Dr.Krishna Agarwal also raised the issue of damage to her car caused by children's playing football in lawn.
