## Candidates for State Representative for House District #37



**Alex Dominguez** - I am a Cameron County native raised in La Feria. I am the sixth of ten children from a migrant farmworker family. I am married to Jill and have one son, Tobias.

I represented you in HD37 before Redistricting in 2021 changed the map drastically. I was the Vice-Chairman of two committees and General Counsel for the House Democratic Caucus. If elected, I would retain my Seniority when returning to the House and be Ready on Day 1.

I served as Cameron County Commissioner from 2014-2018 and was a Board Member of CASA of Cameron & Willacy Counties for six years. As president of Los Diez Education Foundation, we gave scholarships for 25 years to first generation college students.

I have passed bills to improve public education funding, create jobs, and during the 87<sup>th</sup> Legislature, the most pro-veteran bills. I passed the law creating the Cameron County Flood Control District and helped fund the Texas A&M RGV Advanced Manufacturing Hub. I have passed bills to help the disabled, retired teachers, and first responders and to lower taxes.

I graduated from La Feria High School, Rice University, and the Sandra Day O'Connor College of Law. I was a teacher for three years teaching English, ESL, and Texas History.


I received numerous awards from the Department of Justice, FBI, and Department of the Treasury.
