

## Limited Warranty for Aluminum "Arora Series" Garage Doors

Skyridge Garage Doors LLC warrants to the original purchaser of the aluminum garage door that the product and all components thereof will be free from defects in materials and workmanship under normal use for the duration of the warranty period, starting from the date of pick-up, subject to the terms and conditions hereof.

Warranty period applies to the following:

Warranty applicable only if:

- The defective section(s) of the Product are returned to the Seller prior to installation, along with proof of purchase and a written notice of the defect including description and pictures of the faulty product through email. Skyridgegaragedoors@gmail.com
- The Product is not damaged due to installation, such as drilling into the door, which will void the warranty.
- The Product is properly installed, operated and maintained according to standard installation practices..
- The Product is not damaged due to neglect in loading or unloading, strapping or securing product to racks, misuse, abuse, accident, vandalism, fire, flood or other natural disaster.
- · The Product is not altered, modified or repaired by anyone other than the Skyridge or its authorized service representative.

Warranty does not cover damage as a direct result from:

- Paint not applied per the Seller's specifications.
- Salt damage or corrosion.
- Normal fading or discoloration due to age and UV radiation.
- Poor installation or alignment of the Product or its components.
- Accident or casualty that damages the Product or its components.
- If replacement of an entire section is desired, the section must be free of damage as a result of installation including holes drilled for hardware.
- Evidence of Product cleaned with a power washer or other cleaning agents.

This Warranty does not apply to any damage or defect resulting from: (a) any repair or alteration taken by you or any third party without prior written notice to and approval from Skyridge; (b) any use of parts, accessories, or attachments not authorized by Skyridge for use in its products; (c) any routine maintenance and related items, or minor adjustments or damage caused by your installer during delivery or installation; or (d) any minor scratches that do not affect the functionality of the product. The customer will be responsible for the sole cost and risk of any such repair, alteration, use, maintenance, adjustment, or damage. Skyridge Garage Doors liability under this warranty is limited to the repair, replacement or refund as described above, and does not include any incidental or consequential damages, such as loss of use, property damage or personal injury.

The Manufacturer warrants that, for the duration of the warranty period specified above: (a) the Sections will not crack, loosen or sag excessively; (b) the Glass will not delaminate or crack due to defective manufacturing; (c) the Anodization will not peel and will fade with in the normal effects of weathering or UV aging; and (d) the Hardware will be free from manufacturing defects.
