Dear Councillor Ferretti

Firstly apologies for the delay in not replying to your email sooner.

I can confirm that the local Council HUBs are now open and free dog poo bags are available from these buildings only. There is no consideration being given to providing supplies of free poo bags to other buildings or private establishments. I can also confirm that we would not support dispensers being installed in any area across East Dunbartonshire.

I would advise that it is the responsibility of dog owners to act responsibly and pick up after their dogs making sure that they always have a supply of dog bags on their person. The Community Safety Team do monitor and patrol across the Council area in relation to dog fouling. They are able to take enforcement action by way of issuing Fixed Penalty Notices under the Dog Fouling (Scotland) Act 2003. The Notices are to the value of  $\pounds$ 80. If there are specific issues within the Milton of Campsie area then we would be happy to receive the details of these and we can then arrange for the Team to do some targeted patrols to try and identify alleged offenders and speak to the dog walkers in the area.

Complaints of dog fouling can be reported direct to the Community Safety Team by email - <u>antisocialbehaviour@eastdunbarton.gov.uk</u>, by calling the main Council telephone number 0300 123 4510 or online via the Report It process.

I note your enquiry and suggestion from the Community Council regarding the distribution of free dog fouling bags.

I am of the view that dog owners should purchase their own supply of dog fouling bags and responsible owners will do this. The supply of free dog fouling bags via the Hubs is not something that Roads & Environment are involved in. I have taken the liberty of copying in Mrs. Bauer to comment on the suggestion of pole mounted dispensers and the supply to free dog fouling bags in the Milton of Campsie area.

From an R&E perspective, I would have reservation on attaching dispensers to Council assets based on the fact that pole mounted bins can get vandalised and would want to know who would take ownership of the dispenser. I would also be concerned about the content being removed and ending up as litter in the local area.

I trust this information is of assistance.
