They're armed with an array of clever kit like the Cleanfast machine, which can lay up to 1km of fibre cable in a single day (compared to just 20m using traditional methods). They're also using drones to fly fibre across rivers and valleys, and ground penetrating radar to guide our diggers.

Openreach make wonderful statements and have all the right buzz words but when it comes to action they are just a big corporation where profit comes first.

EDC planning and council leaders should be formally objecting to Openreach taking the area back to the dark ages in an attempt to provide the broadband that the Scottish Government Guaranteed and I believe are paying for.
