Afternoon Brian,

Sorry for the late reply but I was waiting on some information to be able to share with you. Below are the details on the waste that is currently in Birdston Coup.

The waste is from our Glass manufacturing site in Derrylin, Co. Fermanagh and is designated with EWC code 101304 (cement based soil stabilising material). It was removed from our site by a fully registered waste removal company called Skip Services Enniskillen Ltd based in Co. Fermanagh, who then used a company called Practical Waste Solutions based in Newtownabbey in Co. Antrim, who are a SEPA registered waste disposal company for Scotland.

They, in turn, have licenses for the site at Birdston Coup from SEPA for the disposal of this category of waste. I cannot send you copies of the licences, as they do not belong to us, but I can provide you with the detail of the SEPA reference for each of them, see below:

WML/XC/1196806 – Paragraph 9 Exemption

Hi Paddy,

The photographs were taken of your products on an Old coup which was licensed many years ago when conditions were not so strict. It is known to have asbestos buried and unspecified nuclear waste from Faslane and Rosyth, along with other unmentionables. The work is currently supposed to be returning the land to agricultural use which should be bringing top soil on the site but large quantities of materials such as yours and other industrial products are appearing and in our eyes and the local communities this is blatantly illegal. We have been asking all authorities for copies of the licence but none are forthcoming at present.

The contractor has been excavating the original cap of the original site as he either doesn't know what's buried there or doesn't care, I have attached some photographs for you, no 3 should let you zone in immediately to the purchaser as it is the barcode and supplier / manufacturer information.

We will be very interested in knowing who originally bought this from your company, where they are based and who they contracted to dispose of it. From your own technical sheet the product if inhaled can be carcinogenic. The way this lot has been dumped so far doesn't look good for the bags not bursting open.
