- 10. Did you ask why they have text and photographs on their LinkedIn site indicating receipt of product from the new Kirkintilloch football site which is being built on an old Nickle works and the SI and Remediation strategy clearly indicates that the whole site is heavily contaminated.
- 11. They are also taking product for a Euro Central site, is that waste clean?

13. You could not see evidence of pits being dug, not surprising as when they are done they cover y them over and spread muck all around.

Not so long ago house builders in Lenzie allowed soil spillage to enter the Bothlin Burn, SEPA reported them to the Procurator Fiscal and they were found guilty in court of contaminating the water supply and fined yet you are happy to put on a pair of wellies have a stroll around, have a chat with the guys on site and then leave. We congratulate you on a job well done.

Last year, one of your colleagues pointed out to you that he spotted they were running a business on site, your response, call them and tell them they cant do that. Today they are still running a business on site not returning the land to agricultural use, that would have taken a maximum of a year to bring in fresh soil to cover the site and reseed with grass or make ready for planting.

All of the attached images are taken from the Birdston Management LinkedIn page and clearly show they are operating a waste recovery business.

We are now in the process of raising this issue with MP's and MSP's.

Have they even provided you with the delivery notices that should be provided when a vehicle comes in and dumps who knows what or are you still feeling sorry for the guy who apparently has personal issues and has already been given a grace period to get his story correct.

Given the recent resignation of the CEO we are not surprised at this level of input from SEPA but rest assured as soon as contamination is proven we will let the general public know who the uninterested parties were.

Hi,

I visited the site at Birdston on Tuesday. There wasn't any waste disposal noted that would lead to SEPA removing the exemptions. There was material on site, blaes and the glass/cement material that the operator claims is product, not waste. Information on this has been requested so I should get some clarity with the response. Only other waste that had been brought onto site was topsoil, subsoil and some off-spec compost, no C&D as per operator. I did not evidence any dug pits, buried waste or landfill capping breached but again the site was heavily waterlogged with some areas impossible to access.
