Thanks for copying this e-mail to us. I afraid that the response from EDC is not acceptable and it should be made known as such.

It seems that Kirkintilloch, Lennoxtown, Bishopbriggs and Twechar all have Hubs and as such can obtain a supply of bags. So basically as Milton of Campsie, Torrance and other small villages who do not have a hub we do not get free bags issued.

Milton of Campsie Community Council are more than happy to act as the village hub for delivery and distribution of free poo bags as no doubt Torrance CC would be also. This is not a difficult proposition for EDC to accept and it would allow us to distribute the bags where needed.

We would request that you take this proposition back to the "Place and Community Planning Place, Neighbourhood and Corporate Assets" and let them know that this Community and relevant Place would like to be given the same Assets as other areas with Council Hubs.

I have copied in Torrance CC just to let them know that their free supply of poo bags is ending. I'm sure they will make contact with you.

We simply can't believe that it is a difficult proposition to load boxes of poo bags into a van and drive round 12 areas which have community councils and distribute bags to keep the area clean and safe. I'm mean, really, 1 person, 1 day every two or three months. Either that or build us a Community Hub as other areas have, we all pay the same council taxes and deserve the same service.

We trust you will bring this proposal up at council meetings and with relevant departments and sure that Provost Pews will support you and us in this matter.

It now seems that a supply of bags were delivered to the Pharmacy in Torrance by our Pest and Dog Control Officer back in October, due to a complaint that was received. This was when Diane Kane, Team Leader was on annual leave and a direct attempt was made by our officer to assist.
