Good morning Paul,

Thanks for passing on the e-mail.

On behalf of the village I must say that having worked in government bodies before I don't think I have ever come across a body that is as slow as East Dunbartonshire Council at getting anything done but as has been put to me before in these words "EDC have been sticking it to Milton of Campsie ever since Charles Kennedy passed away". I would hate to think that is true but given we submitted our report of concerns and a traffic number study back on the 11<sup>th</sup> June 2021 (7 ½ months ago) and were told there would be a traffic study carried out in October if my memory serves me correctly, needless to say this didn't happen, there always seems to be an excuse.

When are the concerns of this village going to be taken seriously, once a child has been killed by a speeding driver, a driver avoiding potholes or a massive articulated vehicle passing through the village turning at junction where crossing the centre line is the only option. Here have been a few accidents in the village in the past year mostly from Speeding drivers, I almost got hit side on last night while exiting Glenburn Crescent onto Birdston Road. When is East Dunbartonshire Council going to take this issue seriously and get their finger out.

Even the simplest of requests remain undone, the pavement from Birdston village into Milton of Campsie has a length of three or four hundred metres which is less than half its actual width for walking on due to bushes over growing the pavement and soil spill on the actual pavement tarmac. To walk this pavement you need to walk virtually on the kerb line as I have witness a young woman with a pram doing, one false step and she is on the road in the line of traffic which generally speeds along this section of road. This hedge used to be cut at least twice a year but as a villager has said since Charles passed it hasn't been touched.

We would request all councillors and MP's apply the appropriate pressure to EDC who provides services to Birdston and Milton of Campsie to get into gear and gets our issues sorted.
