**GUEST INDEMNITY
RELEASE AND WAIVER AGREEMENT**

The undersigned, guest or invitee, of the Crewe of Bobbie C. Davis, Inc. This release agreement shall extend to all claims, demands and causes of action whatsoever arising wholly or in part from any act or omission of the Released Parties, their members, officers, directors, agents and employees or any one or more of them.
