DEPOSITS

By placing a deposit, you agree to the terms of this contract. A \$1000 deposit is required to hold a puppy or reserve a spot on a litter wait list and will be applied to the price of your puppy. Breeder Offers 100% refundable deposits. If at any time you have a change of heart, something happens to the litter, or you are no longer interested, **prior to reserving a specific puppy** you may either request a full refund of your deposit or transfer your deposit to be on the wait list of an upcoming litter. Once you have selected a puppy a refund will no longer be issued unless something happens to the puppy you reserved.

PICK OF LITTER

Pick of litter is guaranteed in order of deposits received. Breeder reserves the right to First Choice on all litters.

GUARANTEED REGISTRATION

Breeder certifies that this puppy is of AKC purebred quality. Breeder will register the litter, and individual dog papers will be issued to the buyer upon receipt. Please note, papers are processed via a third-party registration company. Processing time may vary however, papers are guaranteed.

HEALTH GUARANTEE

Breeder certifies that this puppy is, to the best of his/her knowledge, healthy at the time of sale. General health information will be provided verbally by the breeder, which includes information on diet, shots, worming, bathing, and any other treatments given this dog at the time of sale. The buyer must bring the puppy to a state licensed veterinarian within 72 hours for an examination for our health guarantee to be valid, at buyer's expense. If this puppy is diagnosed with a genetic disorder which is attested to by two unassociated veterinarians, thereby causing buyer and breeder to agree that said puppy cannot ethically be sold, breeder will, upon provision of veterinary reports, offer a replacement breed quality puppy. Buyer however must pay any shipping or miscellaneous charges associated with the transport of the replacement puppy. The originally purchased puppy must be returned before any corrective action is pursued. Breeder shall not be held responsible for the development of non-genetically derived faults, diseases, or disorders, which are due to the Buyer's negligence and/or abuse. This health guarantee is good until the puppy reaches one year of age. Please note that any form of mange, allergies, hernia, grade 1 and 2 patella, and skin disorders are excluded from the liability of the breeder. Buyer must have pet insurance for the first year for the health guarantee to be honored.

ADDITIONAL PROVISIONS AND TERMS OF SALE

A) Breeder shall not be held responsible for the actions of a puppy that are due to Buyer's negligence. Breeder reserves the right to retake possession of the puppy without reimbursement, if at any point during the first 6 months the seller demonstrates an inability to care for the puppy to include injury, abuse, neglect, incompetence, or falsely accuses the breeder of wrongdoing. Additional legal action may be taken.

B) Buyer agrees to provide for this dog's emotional and physical care, including annual physical examinations and recommended vaccinations by a licensed veterinarian.

C) Breeder strongly recommends that Buyer attend obedience classes with puppy and provide proper socialization opportunities for puppy once fully vaccinated or at your own risk. Doing so prior to being fully vaccinated by a licensed veterinarian voids the health guarantee.

D) Breeder requires neutering (males) and spaying (females). Altered dogs typically live a healthier life and generally have fewer behavioral problems. Breeder recommends spay or neuter at six to nine months of age or at your state licensed veterinarian's recommendation, unless dog is intended for breeding purposes and seller purchased full AKC breeding rights and is registered with the AKC by the breeder to indicate so. As indicated in the

(puppy contract) section of this legally binding contract. If breeding has taken place by the buyer without breeder permission or consent here in this contract or alternately documented, the breeder reserves the right to reposes the purchased dog and entire litter without compensation and all repossession costs are at the buyer's expense. Additional legal action may be taken.

E) Buyer agrees to inform the breeder if the buyer intends to sale or transfer ownership to a third party. FIRST OPTION to resume full ownership must be given to the breeder at a price and/or with terms mutually agreed upon by both parties. This would take into consideration the costs incurred by the breeder in caring for the dog and locating a new home. The dog will be returned with the registration papers and any medical records. The breeder has ten (10) days to accept or reject this right of first offer. If this dog should, anytime in its lifetime, need to be surrendered at no cost, the buyer will reclaim this dog, and its disposition becomes the choice of the breeder. Under no circumstances is the dog to be placed in a pet shop, animal shelter or similar establishment. Under no circumstance is the dog to be used in dog fighting or similar activities.

F) Should the buyer be unable or unwilling to fulfill any of the above provisions, or if this dog is seized by any local authority as having been neglected or abandoned, the breeder retains the right to reclaim this dog without compensation. The buyer agrees to pay the breeder any and all expenses, including court costs and reasonable attorney fees, in enforcing the terms and provisions of this contract. Canines are livestock and therefore cannot be returned for any reason other than those stipulated in the health agreement or additional terms and provisions sections of this contract. All sales are final.

G) Color, confirmation, and health are not guaranteed unless outlined in this contract.

STATEMENT OF UNDERSTANDING

The undersigned buyer hereby acknowledges having read the terms of the contract and does hereby agree to abide by each of the provisions set forth above. Buyer acknowledges that no canines purchased through Blue Mountain French Bulldogs shall be used for any illegal purposes. All sales are final. If voluntary arrangements are made by the breeder to repossess the puppy due to the buyer's inability to retain possession, all costs for shipping are the sole liability of the buyer.

This agreement between the breeder and the buyer(s), is an enforceable and binding contractual agreement.
