Attention Sea Country Pets!



Thank you for being a part of the Community! We understand how much you enjoy taking walks throughout our beautiful neighborhood – so do we! As a member of the Community, we are asking for your help. Please remember not to use the neighbor's lawn when you have to go, but if you absolutely must, please remind your Human to pick up afterwards. Additionally, Hawaii does have a Leash Law, so remind your Human -"No Leash, No Leave!"

Did You Know?

Sea Country Canines, did you know Sea Country has a Dog Park? The Sea Country Community Dog Park is located on Wehiwehi Street, and is open from sunrise to sunset. The park is a quarter acre of fully gated greenery complete with waste stations, spigots, and even benches for those pesky Humans that insist on accompanying you.

Firewise Community

On June 1, 2018, Firewise Hawaii conducted an area assessment of the Sea Country Community. Firewise is a Community initiative to reduce the risk of wildfires and their effect on our Community.

Living in the Wildland Urban Interface and the Ember Zone

Defensible Space Works – If you live next to a natural area, the Wildland Urban Interface, you should provide firefighters with the defensible space they need to protect your home. The buffer zone you create by removing weeds, bush, and other vegetation helps keep the fire away from your home and reduces the risk from flying embers. Fireswise Communities and other wildland fire preparedness education programs provide valuable guidance on property enhancements.

Consider This – Unmanaged vegetation between and around homes increases the risk of wildland fire spreading through the community, endangering lives, and property. Pre-fire planning, fuels management, and sufficient fuel breaks allow Firefighters the space they need to keep fire from entering the Community during a wildland fire event.

Not Only the Homes on the Wildland Boundary are at Risk – A home within one mile of a natural area is in the Ember Zone. This includes all of Sea Country. Wind-driven embers can attack your home. You and your home must be prepared well before the fire occurs. Ember fire can destroy homes or neighborhoods far from the actual flame front of a wildland fire. These threats are amplified in Hawaii due to the complex system of strong, erratic winds.

It's fire season. Are you concerned about your property, or the property next to yours? Do you need help clearing it out? Do you know a neighbor that needs help? Well that's what this is about. Let's become a Firewise Community.

Voice of America Soil Contamination Removal

On May 17, 2018, District 43 Representative Andria Tupola held a Town Hall Meeting providing updates about the Voice of America soil contamination removal. Beginning June 1, 2018, the Coast Guard, in partnership with Mountain Methods, Element Environmental, and Pacific Commercial Services, began work surveying and removing contaminated soil from what is known as the Voice of America Radio Broadcasting 5-acre area. The contamination is a chemical known as "PCBs," which was used in electrical transformers up until 1977. According to the Coast Guard's current schedule, removal should have begun June 11, 2018, and will finish August 2, 2018. Complete demobilization is scheduled for August 25, 2018.

Pool & Clubhouse Renovation

Pool Renovations are scheduled to begin September 2018 and continues through November 2018. All activity will be suspended at this time.

Gate Monitor

In the near future, you may notice someone sitting outside the entrance to the pool. This is our new Gate Monitor. The responsibility of the Gate Monitor is to ensure legal entry in to the pool area by Sea Country residents and their approved guests, as well as observe and report inappropriate activity to the General Manager. The Gate Monitor is NOT a lifeguard.

Night Patrol

Effective July 27, 2018, Sea Country will temporarily discontinue Night Patrol services. As a reminder, Night Patrol was not intended to function as a form of security for the Community, but rather as an after-hours enforcement of the House Rules. As such, please continue to call 911 directly to report any suspicious or illegal activity.

Anaha Street Parking

You may have already seen (or heard about) the Department of Transportation making preparations to restrict parking on Anaha Street. A letter was submitted to Councilwoman Kymberly Pine's office from the Board, with the assistance of Anaha Street Homeowners, requesting the restriction due to multiple safety issues, such as the extremely limited visibility at the corner of Anaha and Pakeke, which has been the cause of many nearly missed head-on collisions. For those curious as to why the HOA could not "handle the situation in-house," Anaha Street is a public street, therefore the HOA has no jurisdiction over it – fines could not be enforced and towing would be illegal.

Voting 101



Every year, Homeowners are mailed a "packet" of information intended to prepare them for the Annual Meeting. Included in this packet is a Proxy Form. **Proxy Voting** is a form of voting in which a Homeowner delegates their voting power to a representative, thereby enabling that person to vote on their behalf. There are different ways a Homeowner can delegate Proxy Voting authority in Sea Country. Listed on the Proxy Form are four different options. We will be discussing each option in upcoming issues, beginning with delegation of Proxy **Authority for Quorum Purposes Only.**

If Holomoana and Wailana are part of Sea Country, why aren't issues about those areas addressed at the Master Meetings?
