Homeowners wishing to obtain a confirmed Party Reservation Date must fill out and return to the Sea Country Association Office a Club-house Usage Contract and pay all usage fees and deposits by <u>check</u> in the amounts of:

\$150 for reservation of the Clubhouse from 9am - 8pm, \$100 security deposit, and \$25 for the use of the BBQ grill if desired.

Please make separate checks payable to: Sea Country Community Association.

Party Reservation Date(s) will be confirmed only after contract has been received by the Sea Country Association Office and all fees have been paid.

CLUBHOUSE PARTY RULES

Use of the *Sea Country Club* clubhouse and barbecue area is open to all homeowners wishing to hold private functions that are non-commercial and non-business related in nature. Reservations must be made no more than 90 days in advance with the Sea Country Association Office. Reservations shall be approved on a first come, first served basis. **A \$100.00 refundable security deposit* and \$150 fee for 9am - 8pm usage** are required before the reservation can be confirmed. If you wish to use the BBQ grill, a \$25.00 fee is required. Security deposit, usage fee, and BBQ grill fee shall be <u>paid by separate checks only</u>. The \$150 Clubhouse usage fee is non-refundable within 30 days of the reservation date (*as long as the clubhouse and pool area are left in the same clean condition it was found).

- 1. **No** furniture, appliances, equipment, or furnishings belonging to the clubhouse may be removed from the clubhouse or recreation area and no pool furniture moved from pool deck.
- 2. <u>All</u> garbage and trash must be wrapped, bagged, and removed from the premises. <u>Any</u> spillage from the removal of garbage and trash must be completely cleaned up.
- 3. Parties are to use the clubhouse trash receptacles <u>only</u>. Usage of the pool deck trash receptacles is <u>prohibited</u>.
- 4. Parties are not to exceed a **maximum** of 50 people.
- 5.If used, the BBQ grill must be cleaned. Use of personal barbecues, hibachis, etc. are prohibited within the recreation area.
- 6.Live music, karaoke, or amplified music will be permitted for three hours only (between the hours of Noon to 7pm) during any reserved party. (For example: Noon to 3pm, 2pm to 5pm, 4pm to 7pm, etc.). **Noise is not to exceed an unreasonable level**, to be determined by the manager.
- 7. <u>All</u> pool rules apply to party attendees and must be followed at all times. Host is responsible for all actions of their guests.
- 8. The pool and pool deck area are **not reserved** for party usage; they are for **all** residents' enjoyment. No pool furniture may be moved into the pool clubhouse.
- 9. The use of nails or push pins of any sort are prohibited to hang decorations. <u>All</u> tape and debris must be removed from any wall, table, chair, etc.
- 10. No decorations are allowed on the pool deck or pergola. Signage may be placed on outside of fence with prior approval.
- 11. All tables, chairs, counters, sink, refrigerator, and floors must be cleaned.
- 12. NO alcohol allowed.

- 13. No propping or leaving pool gate open. All guests must be let in by the party host. Homeowner is responsible for ensuring none of their guests prop or leave pool gate open. By signing these "Clubhouse Party Rules" ("Rules"), home owner agrees to accept sole personal liability and shall be solely, personally liable, to the fullest extent permitted by law, for any and all personal injuries and damages to any person or persons who suffer injury and/or damage in the pool, clubhouse, recreation and/or BBQ area(s), as a result of said home owner's or their guest's propping or leaving of pool gate open which allows any unauthorized person or persons entrance into any of the afore-described recreation areas.
- 14. **No** pets allowed at pool.
- 15. **No** food or drink on pool deck or pool area. **All** food and drinks must remain in the clubhouse.
- 16. **Any** spills or mess must be cleaned and mopped with the provided mop and cleaner. Hosing of the clubhouse is **prohibited**.
- 17. Failure to comply with <u>ANY</u> of the above Rules may result in the forfeiture of your security deposit and/or subject you to personal liability for any damage proximately caused by your or your guest's violation of any of these Rules.
- 18. Sea Country Community Association, its directors, officers, employees and agents disclaim any and all liability, to the fullest extent permitted by law, for any and all personal injuries and/or damages to any person caused by the violation of any of these Rules, even if such personal injuries and/or damages were caused by the negligence of Sea County Community Association, its directors, officers, employees and/or agents.

Clubhouse Usage Contract

A user fee of one hundred and fifty dollars (\$150.00) for all day, 9am - 8pm and a refundable security deposit of one hundred dollars (\$100.00) are required when reserving the clubhouse area for a Resident's sole and exclusive use as described in the *Swimming Pool and Clubhouse Rules* and the *Clubhouse Party Rules*, and prohibits any business-related or commercial function (except Community Functions). The user fee is used for the maintenance and upkeep of the physical building, furniture, appliances, and any other equipment available in the Clubhouse for use by the resident host and his or her guests. The resident host is responsible for leaving the Clubhouse in the same condition it was found. The \$150 Clubhouse usage fee is non-refundable within 30 days of the reservation date. Additionally, a non-refundable user fee of twenty-five dollars (\$25.00) is required for use of the BBQ grill.
