CATS & DOGS*

Start

with 1/4 drop (0.01 mL) per 20 lbs.
twice a day.

Increase

to 1/2 drop — 1 full drop (0.02 mL
— 0.05 mL) per 20 lbs. twice a day.

*Place inside the upper lip under the split
between upper lips and nose.*

*** Always start low initially.** If you don't see any results after dosing your animal, gradually increase the dosage until the maximum dosage is met. Do not exceed the dosing requirements. Always consult your veterinary provider prior to use.



HORSES*

500 lbs. or less

2 drops (0.1 mL) — 4 drops (0.2 mL)
1 - 2 times per day.

500 lbs. — 1,000 lbs.

2.5 drops (0.125 mL) — 5 drops
(0.25 mL) 1 - 2 times per day.

1,000 lbs. — 1,500 lbs.

3 drops (0.15 mL) — 6 drops (0.3 mL)
1 - 2 times per day.

*Place in the "gutter cup" of the lower lip or at
the corner of mouth where lips meet.*

Hyper-agitation	Restlessness; pacing; body tension; jumpiness; growling; cowering; flicking tail quickly.	Lower dosage.
Hyper-sedation	Drowsiness; loss of coordination; dry-mouth; lowering head; leaning on something; lack of balance; loss of appetite.	Lower dosage.
Hives / Rash	Itching; scratching; bumps; welts.	Stop usage. Seek emergency veterinary care.
Respiratory / Breathing Issues	Gasping; wheezing; swollen lips/tongue/mouth.	Stop usage. Seek emergency veterinary care.
