

- We can secure \$25,000 \$50,000 or more in business credit cards AND build business credit through Dun & Bradstreet and Experian Business. The credit cards will have no personal guarantee! You will not be personally responsible for the debt on these credit cards.
- First, we establish your business credit profiles and make sure your business is in compliance. The first round of cards (within the first couple of months) will be vendor credit "Net 30" cards. These cards are essential to the process because they build a foundation, which then allows us to gain access to "revolving" credit cards.
- The second round of cards will be "revolving" cards to additional vendors, including gas cards for all of your fuel expenses. You can now pay monthly for fuel expenses; improving cash flow and building your business credit while doing so. You will also receive additional vendor credit (examples of vendors below). Once we reach Round 3 of funding, you can receive Amex, Visa and Mastercards which can be used anywhere.
- After securing the credit cards, your business will now have the ability to potentially purchase equipment and vehicles using the newly established business credit. Giving you access to products & programs you've never had before.
- It's time to finally separate Business from Personal. No more maxing out personal credit cards for business debt. Protect yourself and keep your business expenses
