- 2. Submit \$50.00 check for park usage
- 3. Please clean and remove all garbage from the park.
- 4. Park hours shall be from Dawn to Dark. Swimming, picnicking and general use is permitted during these hours only.
- 5. No Lifeguard is on duty. Swimming is at your own risk.

  Parents are responsible for the safety and discipline of their children at all times during the use of the common properties and facilities.
- Limit usage of park tables and grills to two (2).Additional tables if needed may be brought by you or your guest.
- 7. Only current members may bring their watercraft.
- 8. Maximum number of individuals (members and guest) attending the family activity is limited to 50 or less.

Note: This procedure only applies if your party exceeds the number of guests granted by your membership. Each member (card carrier may have two guests each per day)
