Summary: Under the general direction and supervision of the Director of County Emergency Medical Services and Assistant Director, the Paramedic is to support the emergency medical operations of the EMS. This position will work closely with other EMS staff, the Consolidated City/County Fire & Rescue Department, Law Enforcement Officers, 911 Dispatchers, and citizens of Jeff Davis County. This position reports directly to the EMS Director.

Supervisory Duties: Supervision of EMT's during medical transport.

- Pass a background check
- Valid driver's license
