Terms and Conditions

Angelinas Dream Foundation a 501(c)(3) non-profit, is providing scholarships to Cheeks Beauty Academy Cheyenne School, in memory of Angelina Marie Harrison, by setting aside certain amounts for scholarship opportunities for cosmetology and barbering school students, both new students and those currently enrolled.

Eligibility: The Scholarship is open to individuals: (a) who are at least high school seniors, (b) who are legal residents of the 50 United States (including D.C), (c) are, at the time of application through award distribution, enrolled in a cosmetology or barbering program at Cheeks Beauty Academy or will be enrolling within 6 months of receipt of award, (d) who meet all qualifications outlined in these Terms and Conditions, and (e) meet all of the admission requirements for Cheeks Beauty Academy Cheyenne school. Individuals under 18 will need written consent from a parent or legal guardian to accept any award. Angelinas Dream Foundation board members and their immediate family members are not eligible to participate in the Scholarship. Federal, state, provincial and local laws and regulations. Angelinas Dream Foundation may change, suspend, or terminate the Scholarship at any time (subject to applicable law) and will provide notification of any changes on the scholarship tab of their website at angelinasdreamfoundation.org ("Site"). Void where prohibited.

Scholarship Application Process: There will be two Application Periods (as defined below) during each calendar year – a First Application Period and a Second Application Period. To register, you must complete the Scholarship application form (available online, via email request, or at Cheeks Beauty Academy Cheyenne School), and answer the following essay questions listed on the application:

- What would this scholarship mean to you?
- What are your plans/goals once completing the Cheeks Beauty Academy Program?

To be eligible for consideration, your Scholarship application and essay (collectively, the "Application") must be submitted and received by the following dates and times (each, the "Application Period"):

First Application Period is from January 1, 2024, to May 31, 2024.

Second Application Period is from July 1, 2024, to November 30, 2024.

The Application must be received by Angelinas Dream Foundation by on by 11:59 p.m. Mountain Time on the last date of the respective Application Period. Angelinas Dream Foundation computer is the official timekeeper. Winners will be notified by June 30, 2024, for the First Application Period and by December 31, 2024, for the Second Application Period. Applications submitted, but not selected during a particular Application Period will be deemed void and will not be eligible for any other Application Periods. Eligible applicants who are not selected during an Application Period may reapply by resubmitting an application within the next Application Period; provided all eligibility requirements are still met at the time the Scholarship is awarded. By completing an application, you (or your parent or legal guardian on your behalf) represent that the information you are providing to Angelinas Dream Foundation is truthful and accurate. Any applicant who is not at least a high school senior or not enrolled in Cheeks Beauty Academy Cheyenne School during the Application Period will not be considered. Incomplete applications will be null and void and Angelinas Dream Foundation retains the right to reject applications for failure to comply with these Terms and Conditions or otherwise meet eligibility requirements. Applicants selected as a winner will receive a tuition reimbursement award in the maximum amount noted below. To receive the award, the recipient must be currently enrolled in Cheeks Beauty Academy (enrollment will be subject to verification by Angelinas Dream Foundation) or be enrolling within six months of winning the award, and sign Angelinas Dream Foundation Affidavit of Eligibility and Publicity Release. Funds will be paid directly to Cheeks Beauty Academy Cheyenne School on behalf of the winner. The recipient will need to be enrolled in the program for a period of at least thirty days before funds are distributed. If at any time the recipient drops out of the program or is terminated from the program, the funds will be returned to Angelinas Dream Foundation and will be put back into the scholarship program. Angelinas Dream Foundation reserves the right to verify/inquire about the recipients' grades and/or attendance at any time.

Terms and Conditions for the Essay Response: All essay responses must be original to the applicant and must be suitable for display and publication in all forms of media, including but not limited to the internet, print, radio, and network, cable, or satellite television broadcast. Accordingly, submissions must be dignified, modest and in good taste, may not be obscene or indecent, including but not limited to nudity, pornography or profanity, must not contain any offensive or defamatory statements including but not limited to words or symbols that might be considered offensive to individuals of any race, ethnicity, religion, sexual orientation or socioeconomic group, must not feature, advocate, suggest, condone, or include threats to any person, place, business, group or world peace, it must not invade privacy or other rights of any person, firm or entity, must not include any third party trademarks or copyrighted materials, including brand names, logos, text or other similar materials, it must not portray Angelinas Dream Foundation, or its respective brands or products in any way that might tend to subject any of them to public contempt, scandal, disrepute or ridicule, and it must not in any other way violate any applicable laws, rules or regulations or network standards. Angelinas Dream Foundation reserves the right to make determinations of suitability in its sole and absolute discretion, and to disqualify any essay submissions it determines to be inappropriate for any of the reasons listed above, or for any other reason. Essay submissions must not contain material that violates or infringes another's rights, including but not limited to privacy, publicity, or intellectual property rights, or that constitutes copyright infringement.

Scholarship Selection and Award: At the close of each applicable Application Period, eligible Applications will be evaluated by a qualified panel of judges designated by Angelinas Dream Foundation. Applications will be judged based on the quality of the applicant's essay; including, but not limited to, the authenticity, originality, and impact of the essay. To the extent possible, and during each applicable Application Period, one winner will be selected. In the event Angelinas Dream Foundation receives no eligible Applications for a particular Application Period, they reserve the right to open the application period again or move the funds to the next application period. Angelinas Dream Foundation reserves the right to modify or change the scholarships at any time and will post changes to the website, angelinasdreamfoundation.org. The amount of each Scholarship award will be the lesser of: (i) \$2,500 or (ii) the winner's current tuition balance. The scholarship award is made payable to Cheeks Beauty Academy Cheyenne School on the winner's behalf 30 days after being enrolled.

Award Notification: A representative from Angelinas Dream Foundation will announce the Scholarship winners no later than June 30<sup>th</sup> of each year for the First Application Period and December 31<sup>st</sup> of each year for the Second Application Period. Winners will be notified via email or phone communication as determined solely by Angelinas Dream Foundation. In the event the potential award recipient does not respond to notification within 5 days or does not return the Affidavit of Eligibility and Publicity Release, Angelinas Dream Foundation may grant the Scholarship to another applicant. Potential award recipients are subject to verification (including verification of enrollment from Cheeks Beauty Academy Cheyenne School) and compliance with these Terms and Conditions. Angelinas Dream Foundation reserves the right to modify all Scholarship awards and these Terms and Conditions. All awards are non-transferable, non-assignable and may not be exchanged or returned. Odds of winning a Scholarship depend on the number of eligible Applications received. Upon receipt of any Scholarship, the winner is required to comply with any and all applicable federal, state, provincial, territorial and local laws, rules and regulations. All federal, state, provincial, territorial, and local taxes are solely the winner's responsibility.

Publicity Release: By submitting an application, you agree to allow Angelinas Dream Foundation and their officers, directors, franchisees, affiliates, subsidiaries, agents and licensees to use your name, likeness, city, state, photo, statements and other information in connection with the Scholarship, including all or portions of your essay response, for promotional, advertising, trade and/or other purposes, in perpetuity, worldwide, in any and all media, without further compensation or notification, unless prohibited by law. Angelinas Dream Foundation shall not incur any liability whatsoever to the extent Angelinas Dream Foundation chooses to partake or refrain from any exploitation of its rights hereunder. Award recipients will be required to sign an Affidavit of Eligibility and Publicity Release as a condition of receiving an award as described herein, or the award will be forfeited. Limitation of Liability: By submitting an Application (whether or not an award is issued or received), all applicants hereby waive and release, and agree to hold harmless Angelinas Dream Foundation from and against, any and all rights, claims and causes of action whatsoever that they may have, or which may arise, against any of them for any liability for any matter, cause or thing whatsoever, including but not limited to any injury, loss, damage, whether direct, compensatory, incidental or consequential, to person, including death, and/or property, arising in whole or in part, directly or indirectly, from their participation in the Scholarship or receipt of an award. Angelinas Dream Foundation is not responsible for lost, late, damaged, delayed, incomplete or misdirected applications, or for any technical failure of the Site or any technology related to the application or Scholarship.

Disputes: Each Scholarship applicant and recipient agrees that any disputes or claims related to the Scholarship shall be resolved individually, without resort to a class action and all proceedings shall take place in federal or state court in the state of Wyoming, applying Wyoming law (without regard to conflict of law provisions).

Privacy: By submitting an Application for the Scholarship, you agree to be contacted by Angelinas Dream Foundation and, if applicant is at least the age of majority in his or her state of residence, Angelinas Dream Foundation may add applicant's information to its database, with information collected as described in Angelinas Dream Foundation.
