APPROVE PREVIOUS MEETING'S MINUTES

Motion by Robert Goodwin, 2nd by Audrey Oberlin to approve the January 4, 2024 meeting minutes. Passed Unanimously.

Stephanie Sobotik stated that she was interested in what the district will be doing this spring regarding road maintenance and any plan for the bridge. Discussion followed in the group.

Discussion followed regarding a plan for spring road maintenance. Robert Goodwin delivered two dump trailer loads that are intended for pothole repair on the east side of the bridge and he had already done some roto-mill work on the west side of the bridge at the Hwy 133 entrance.

More discussion regarding identifying problem areas on the district roads and getting bids from excavating companies for completing the work. Wayne Ives and Robert Goodwin will obtain bids from excavators and present to the board for review and approval.
