

History of Civil Society Conferences

- 1945 San Francisco: UN established with representatives of 1200 voluntary organizations:
 - "We the peoples of the United Nations..."
- Article 71 of the UN Charter recognition of civil society and NGOs
 - The Economic and Social Council may make suitable arrangements for consultation with non-governmental organizations which are concerned with matters within its competence. Such arrangements may be made with international organizations and, where appropriate, with national organizations after consultation with the Member of the United Nations concerned.

Inclusivity & respect for dignity & human rights of all

 "sustainable cities and communities must foster opportunities regardless of age; gender; race; nation of origin; sexual orientation; religion; socio-economic status; disability; language; universal, societal, and individual traditions and values; or political opinion."

Issues addressed

- Global & Civil Governance
- Youth Potential & Significance
- Ethical Use & Development of Technology

Stakeholders were urged to take 13 principal actions, especially related to our purposes:

- enhance inclusivity & respect for dignity of all (human rights)
- sustain safe, peaceful, and just societies, free from war, civil strife, human exploitation, hate speech, and other crimes (especially through conflict resolution)
- establish legal and institutional frameworks to enable positive impact by community and business investments on society

Attendees offered eight (8) principal commitments, especially related to our purposes:

- Application of conscious inclusivity and respect for human dignity and rights...in our laws, regulations, policies, and practices in a manner that facilitated the inclusion of marginalized, vulnerable, and deprived members of society
- Formation of civil society collaborations, including public-private partnerships, in order to formulate policies, mechanisms, and regulations that foster peaceful, prosperous, inclusive, and sustainable cities and societies.

Examples of Other Civil Society Conferences



International Campaign to Ban Landmines – one of he most successful civil society campaigns in history



The Coalition for the ICC – had a series of civil society initiatives that led up to the Rome Statute in 1998 (ICC governing law) and beyond



World Health Organization's (WHO) Civil Society Commission's Steering Committee dedicated to fielding advice and recommendations to the WHO's executives



The Conference of the Parties to the Climate Change Treaty has yielded a lot of civil society response, i.e. the Earth Summit.

Inventive Participation in Civil Society Conferences

- ICAN (prohibition and elimination of nuclear weapons) = Participated in Salt Lake City's events with a Peace Boat
- ICBL continues to contribute to the movement at the United Nations as especially during a special Mine Action Week.






