Parent/Student Contract

The undersigned do hereby understand and agree, as a condition of admission to Cornerstone Christian Academy (CCA), to the following statements:

- I/We have, as a family, read, discussed the importance of, and agree to support the Statement of Faith.
- I/We acknowledge that our child will be taught the Christian faith, and I/we agree to support such instruction both in school and at home.
- I/We have read and understand the policies of Cornerstone Christian Academy and agree to adhere to them.
- I/We have read and understand the information in the current edition of the Parent/Student Handbook.
- I/We understand that our child is expected to exhibit respectful behavior towards peers and the staff and faculty of the school in accordance with the school's behavior policies.
- I/We shall strive to ensure that all assigned work is accomplished in a timely and satisfactory manner.
- I/We agree that our child (Grade P3-8) will participate in all normally scheduled school activities (P.E., art, holiday programs, chapel, etc.) except those that have been excused by the Headmaster at the advance request of the parents or guardians.
- I/We have read and understand the financial policies of the school, and agree to make payments on a schedule agreed to by all parties. In the event that I/we withdraw student(s), I/we have read and understand our commitment to continue tuition payments, as is applicable, through the end of the semester as per the school's financial policies.
- I/We agree that our child will abide by the school dress code (Grade P3-8), in spirit as well as in practice.
- I/We understand that our child is not allowed to use electronics including but not limited to cell phones, laptops, gameboys while on the school property unless otherwise authorized by a teacher or staff.
- I/We understand that attendance at Cornerstone Christian Academy is a privilege, and that the privilege can be revoked at any time by the Headmaster for good and sufficient reason after informing the parents of the rationale for such a decision.
- I/We agree to support, to the best of our ability, school, and student fundraising activities.
- I/We will, to the best of our ability, strive to volunteer a minimum of 15 hours annually of our time to assist in Cornerstone Christian Academy school activities.
- I/We authorize Cornerstone Christian Academy to use, without compensation, any photographs of me or my child participating in the classes, activities, and events of the organization for artwork, educational, promotional and/or advertising purposes in school brochures, flyers, newspapers, advertisements, public access or commercial television and/or promotional video or in literature published electronically or traditionally. Please notify the office in writing if you wish to opt out of this participation.
- I/We agree to support the administration of CCA in establishing and enforcing disciplinary rules, creating and maintaining a positive learning environment for all students and establishing behavioral guidelines for all students. We realize that we will not agree with all decisions that are made by the administration. In such events we will express our disagreement directly with the administration in a discreet, appropriate manner that will not compromise the administrator's ability to effectively manage the situation.
- I/We understand and agree that continued enrollment and re-enrollment of my/our children at CCA is dependent on my/our parental support of the school, its staff and its policies.
- I/We understand that, at the conclusion of any appellate action, the decisions of the Headmaster are final.
- It is agreed that this contract remains in effect for the duration of our child(ren)'s enrollment at CCA.
