Ninfirmaw kom li r-registrazzjoni tal-klabb issa hija miftuha. **Id-data tal-ġeluq għar-registrazzjoni hija s-7 ta' Awwissu** u trid tigi pprezentata bi ħlas dovut ta' €250 għat-timijiet registrati fl-istaġġun preċedenti u €250 u depožitu refundabli ta' €75 għal timijiet ġoddha. Dear Members and Clubs of the Malta Darts Association,

We inform you that clubs registrations are now open. **The closing date for submitting the registration is August 7th** and must be presented with a due payment of €250 for teams registered in the previous season and €250 and a €75 refundable deposit for new teams. All forms must be submitted by the closing day to confirm registration at the next Annual General Meeting.

Regarding player registration, each club must present a minimum of 8 player registrations. If the forms presented are less than 8 the club will not be allowed to register such a team, ie the registration will not be accepted. It is IMPORTANT to know that after August 7 no more registrations will be accepted.

The registrations together with the Payments must be given to the Cashier Mr. Steven Galea directly to him or at the MDA office on August 6 or 7 where he will be present to accept registrations and payments until 10 pm, those who wish to contact him can do so on the number 7928-3703.

With this circular, you will find attached the club registration form, the Player registration form, and the nomination form for the Executive Committee. We encourage you to complete and submit these forms according to the instructions so that we can continue to grow our association in a professional and organized way.

A club registration must be filled out properly otherwise it will be rejected. The Delegate and Assistant section as well as the Councilor and Assistant section **cannot be left blank**.

For the Executive Committee, 2 representatives must be elected from each division according to the Statute, if more than 2 people are nominated, an election will be held for that particular division.

We appreciate your cooperation and encourage you to do so in the stipulated time so that we can continue to plan for the coming season efficiently.
