Membership

Trail and Route Status

New Enterprise Forest Trail

As work continues to progress on this trail there was a snag in the budget, and the county found itself \$51,000 short, which equates to just over 2 miles of trail that still needed to be completed. Fortunately the ORV Council which issued the initial grant for the trail was gracious enough to grant additional funding which now will be sufficient to complete the project. In discussing the status with the Forestry Director, John Bilogan, he stated that he was hoping to complete the project by opening of the 2019 season, however, as we all know, it is fully dependent on our Wisconsin weather.

Our thanks go out to both John and Bob Mott, our county supervisor who is on the Forestry Committee, for all their efforts in getting this project both approved as well as nearing completion

North Route to Monico via Dump Road/Old Hwy 26

After working on this for over two years, we have been able to have a confirmation with the Forest Land Group Senior Director of Forest Operations that he would be willing to work with us on allowing use of their property through a formal easement agreement. This was great news and a sign of significant progress but as he mentioned the "devil is in the details" of such agreement, such as final cost of the easement, who will maintain it, who can use it, their access for forest management, etc.

Considerable work will need to be done to come up with a workable agreement, and then we still have the four wetland areas to contend with as well. In discussing this with the DNR we would have to apply for a General Permit to request doing work on the four wetland areas. The application fee for this permit is \$800. We have a request into the DNR as to what types of crossings would we would have to construct and when we receive a reply we can put a budget together to see if it is even economically feasible for us to continue on this.

If any club member has knowledge of DNR Wetland Permitting processes or Easement Agreements please contact me to discuss further.

Hwy 45 thru Pelican Lake

The Town of Schoepke has submitted the letter to the Wisconsin DOT requesting that they work with the town on either changing the speed limit on the north end of town, extending the 35 MPH zone all the way to Hwy Q, or that they work with us on using the old railroad ROW on the east side of the road. The latter would be preferred as it would keep ATV/UTV traffic off Hwy 45, but it is also the more costly option of the two. Hopefully the DOT will have an answer for the town in the next couple of weeks.

In the meantime, DO NOT DRIVE ON HWY 45 in Pelican Lake

9th Annual Fischer's ATV/UTV Rally and Poker Run

We had the annual Fischer's ATV/UTV Rally on Saturday, June 23rd in conjunction with the Parrish Highlanders Club at Fischer's Bar on Hwy 17 and Q and again had a great turnout, as well as a very successful fund raiser for the two clubs. Our thanks go out to all of those who helped out, as well as came and supported the clubs and a great cooperative event with the Highlanders and Jeremy Fisher's Bar.

Trailer Update

The club trailer has been has been received, it is a 16 foot trailer, aluminum sides, two side doors, loading ramp rear door, dual axle. We have the club graphics on the two sides and rear tailgate and it also has an awning on it as well.

For those interested, we are considering offering sponsorship space on the trailer on each side of our banner for our business members. You would be able to put your business name and location on a decal on either side of the club decal. There would be a one-time buy in cost for the cost of the decal and first year, and then an annual renewal fee. While we do not have exact numbers we are thinking the initial decals would be less than \$150.00, and the annual renewal would be reasonable, but we have not established any firm numbers.

Safe and Responsible Riding

Unfortunately there have been four ATV/UTV deaths in Oneida County this year, last year there were none. What this does is bring the naysayers out that believe that these machines have no business on a road, and casts a pall over an otherwise safe and enjoyable sport. We all know that the use of county and town roads is vital to our sport to gain access to the various trail systems we enjoy.

As a result of a few people potentially spoiling it for the majority, we believe as a club we have a responsibility to take a pro-active role in aggressively promoting and teaching safe and responsible riding. To that end, we will be working with the other clubs in the local TV Channel 12 viewing area to work together to run a series of safe ATV/UTV riding TV ads during the 2019 season. We would hope that we would get 100% participation from these clubs, and many have already committed to working with us on this project. If as a business you would also like to participate please let me know. The intent is that at the end of the ad, credits will run showing the sponsoring ATV/UTV Clubs and any participating businesses. If as a business you have an interest in contributing towards this ad campaign please let me know.

In addition to the above, we will also be creating a simplified Rules/Regulations handout that dealers can give to new machine buyers, providing them the immediate education on helmet, age and speed laws. As many of you know, it takes from 2-4 weeks to receive your stickers and DNR Regulation pamphlet, which by that time many do not read. Our hope is to educate people on the basics as soon as they buy the machine.

Lastly, along the same topic many clubs have what is called a Trail Ambassador/Trail Patrol program.

The Trail Patrol Ambassador program is a group of dedicated and trained volunteers who give their time to patrol our ATV trails. While they are not law enforcement officers however most of work directly with law enforcement agencies.

Some of the tasks included:

Educating the riders on the rules and regulations as well as ethical riding practices.

- Teach Wisconsin Department of Natural Resources ATV certification class.
- Patrol the trails while watching for riders in distress or riders who are violating the law.
- Trail clean up.
- Sign posting.
- Have fun!

Route and Trail Signage

Part of enjoying our sport is knowing where we are and how to get to where we want to go. Well, maybe not for all of us, some like the excitement of just seeing "where will this take us now". When riding and if you feel we need to add signage, an arrow, or some informational sign, or you find directional arrows missing please let us know, and we can follow-up on the request.

We are also looking into putting directional signs with mileage to the various towns and locales at the major intersections to help guide people, as well as intersection numbering that would also be shown on our map. Let your board members know your thoughts on this, and assist in giving us some direction.

Adopt-a-Highway Program

Your club feels very strongly about promoting itself thru responsible, community orientated projects, fulfilling a civic responsibility to the community. As many of you know, we do the Senior Rides three times a year, and have contributed to the local fire department, local baseball sponsorship, and currently have a raffle basket circulating for childhood cancer.

We would also like to consider taking on a section of highway under the Adopt-a Highway Program which entails the following responsibility for litter control on approximately a two mile segment of state highway.

The group picks up litter on this segment at least three times per year between April 1 and November 1.

- The Adopt-A-Highway program emphasizes safety. It is important to be very careful when working on the roadsides. For more information, view the Adopt-A-Highway Safety page.
- Groups do not work in dangerous areas like medians, bridges, or steep slopes.
