#### Trail Updates

#### Monico to Forest County Trail

I have been advised by the county that the trail segment connecting Oneida and Forest County is still being worked on, requiring some signage to be either replaced or repaired, and some new signs installed. As of this writing Jeff Herman, Dennis VandenHuevel and Bruce Dantoine are working on this and we hope to have this open in the next week. In addition, the leg from the county lines to Cole Road and Mays bar will also be open. This new segment will allow one to have access into the Town of Monico. Just been informed this will be open for this weekend

#### Hwy 45/McGinnis Road Crossing North of Pelican Lake

We are continuing to work with Kerry Romsa on developing a trail leg thru his property from Hwy Q to Hwy 45, across from McGinnis Road. At this time we are waiting on a contractor to come in and clear approximately a ¼ mile thru the woods for the trail, and are hopeful this is done sometime in July.

Our appreciation goes out to Kerry and Suz for allowing us to cross their property and develop the trail.

#### ATV/UTV Access to East side of Pelican Lake-Conservation Fund/DNR Recreational Easement

As stated in previous newsletters I have been working closely with the Conservation Fund who now owns the approximately 57,000 acres east and north of Pelican Lake.

There has been considerable opposition to this easement but it has not come from the public. In fact, in all the meetings that I have attended the public is in overwhelming support of the project.

Unfortunately our elected leaders, that being town chairmen, and county supervisors have taken it upon themselves to organize the opposition amongst themselves, going against the desires of their constituency. Credit goes to the Conservation Fund who is diligently working on bringing this project to fruition thru all possible efforts to appease the opponents.

I will be continuing to work closely with Clint Miller of the Conservation Fund towards establishing ATV/UTV access to this property, and we will be doing some field work on this on June 12<sup>th</sup>.

#### **Dump Road to Old 26**

The Town of Schoepke has designated this as an un-maintained, un-managed town road so that we can now gate it for solely ATV/UTV and Snowmobile use. This has allowed us to work with the county who has submitted a request for funding from the ORVC to develop it into a navigable trail to be completed by 2024.

We will not know if the request is granted until the Off-Road Vehicle Council meets in September, so let's keep our fingers crossed.
