Executive Summary

<u>Mission Statement</u>: A brief statement of what your business seeks to accomplish

<u>Company Information</u>: Founding date, names/roles of founders, number of employees, number of locations

<u>Company Highlights</u>: Growth highlights of the company (financial or other), along with hard numbers and charts

<u>Product/Service</u>: Short description of what you sell and who you sell to

<u>Financial Information</u>: Financing goals and any current sources of funding

<u>Future Plans</u>: Quick glimpse of where you're headed (expansion, new products)

Company Description

Industry: A quick description of the industry you're in

<u>Target Market</u>: Your primary customer base

<u>Competitive Advantages</u>: Describe any competitive advantages you may have, such expertise or location.

Market Analysis

<u>Industry Information</u>: Size of industry, past growth, projected future growth, current trends

<u>Competitors</u>: Top competitors, strengths and weaknesses, total market share

<u>Target Market</u>: Specific customers you are targeting (current needs and existing solutions, demographic information)

<u>Target Market Size</u>: Amount target market spends, frequency and timing of purchases

<u>Market Share Potential</u>: Amount of market share you believe you can acquire

<u>Barriers To Entry</u>: Things that would make it difficult to succeed, such as strict regulations or high tech costs

Organization and Management

<u>Key Stakeholders</u>: Who are the key stakeholders in the business and how do they relate to one another (include organizational chart)?

<u>Legal Structure</u>: Describe whether your company is an LLC, S-Corp, C-Corp, or other legal entity.

<u>Employee Background</u>: Background information about key stakeholders that demonstrates expertise/value

<u>Key Hires</u>: List any key hires that you will need to make in order to succeed

Products and Services

<u>Description of Product/Service</u>: A clear description of what your product/service is

<u>Benefits</u>: A thorough description of how your product benefits customers and stands apart from the competition

<u>Pricing Structure</u>: Explanation of how you will price your product

<u>Proprietary Information</u>: Any intellectual property, patents, or proprietary information you possess that will contribute to your success

<u>Supply Chain</u>: Suppliers/vendors you rely upon, along with key information like how often you receive supplies and the method by which you receive them

Marketing and Sales

<u>Positioning</u>: How you will position yourself relative to your competitors (lower cost, superior quality, superior service)

<u>Promotional Methods</u>: Specific tactics you'll use to spread the word about your product or service

<u>Success Metrics</u>: How you will evaluate the results of your marketing efforts

<u>Sales Strategy</u>: Method(s) you will use to sell to customers (cold calling, in-person meetings, other strategies)

Sales Team: Description of who will be selling to customers

Budget: Amount of money to be spent on marketing and sales efforts

Financial Projections

<u>Current Financial Status</u>: Income statements, balance sheets, cash flow statements, debt documentation, and other pertinent details

<u>12-Month Financial Projection</u>: Projected sales, cost of goods sold, profit, expenses, net operating income

<u>Cash Flow Projection</u>: Projection of how much cash you'll have on hand at given points over the next 12 months

<u>Projected Balance Sheet</u>: Projected balance sheet in 12 months

<u>Break-even Calculation</u>: Projection of how much sales volume you'll need to cover costs

Funding Request

<u>Request Details</u>: Type of funding you are requesting along with the amount of funding and terms

<u>Use of Funds</u>: How you will be using the funding (inventory, payroll, other)

<u>Future Plans</u>: How and when you will repay the investment, any plans to sell the business

<u>Table Of Contents</u>: Make it easy to connect information in the appendix to specific sections of the business plan.

<u>Supporting Information</u>: Key information that supports previous sections
