## Upcoming Changes to Release Requirements Impacting Carriers and Freight Forwarders

## What is Changing?

- As of April 19, 2025, importers seeking to continue to benefit from electronic release service options – specifically, the IID, PARS and paper RMD will be required to enroll in Release Prior to Payment (RPP) and post final security.
- The majority of importers, and in turn carriers, benefit from electronic release at the border.
   Should importers not enroll, shipments will not be eligible for release using one of the above release service options.
- There are potential impacts to drivers, carriers and freight forwarders at the border should importers not enroll in RPP.

# Impacts to Drivers, Carriers and Freight Forwarders

- If a carrier arrives at the border with cargo (including house bills) destined for release at the first port of arrival (FPOA) and the importer has not enrolled in RPP, there will not be a release on file. The conveyance cannot proceed inland without a release or approved change of destination for both the primary cargo control number and house bills (if applicable).
- Non-bonded carriers and freight forwarders will not be permitted to move inland with their cargo without a single trip bond.

# Know Before You Go: What Carriers can do to Minimize Delays at the Border?

- Verify with your importers (brokers) they have enrolled in RPP. Knowing this before heading to the border avoids uncertainty and unexpected delays post April 19, 2025.
- Become a bonded carrier or freight forwarder:
   Carriers and freight forwarders who are not
   currently bonded should consider this option.
   Non-bonded carriers/freight forwarders with
   cargo that is not released will not be permitted
   to proceed past the first port of arrival without
   applying for a single trip bond. Whereas bonded
   carriers/freight forwarders are permitted to
   move inland with presentation of an A8A(B).

- Signed up to receive eManifest notices and Release Notification System notifications:
   Carriers and freight forwarders can sign up to receive eManifest Completeness Notices, so that they may react accordingly (e.g. change destination to an inland location if bonded) prior to arrival at the port of entry. Absence of a Completeness Notice is a strong indication that the release has not been successfully submitted to the CBSA.
- Carriers and freight forwarders can also refer to their Release Notification System (RNS) notices to look for a "Dec Accepted" message. If there is an accepted release request on file, the carrier may proceed with confidence to the FPOA.
- Alternate inland port of arrival: Ensure drivers know in advance the inland sufferance warehouse (subloc) and port codes they would move goods to if a release is not on file at the border. This information can be found on the <u>Directory of CBSA Offices and Services</u> webpage.



Ensure your drivers have a completed paper A8A(B)
 on hand showing an alternate inland port of arrival
 and sufferance warehouse sub location code.
 Knowing this information in advance will expedite the
 cargo process in the event the release is not on file.

## **Enroll in the CARM Client Portal (CCP)**

- Carriers and freight forwarders who have not already registered in the CCP should do so. The CCP is where carriers and freight forwarders go to apply for a carrier/freight forwarder code and maintain their existing program account information including updates to business address, apply for or amend bonded status, etc. Additional information on carrier enrollment can be found below.
- Enroll in CCP by going to the <u>CCP</u> login page to create your account.
- Once you have created your account, see the <u>Enroll in the Carrier Program</u> user guide from the <u>CARM user guides webpage</u> and follow the steps for registration in the carrier and freight forwarder program.

#### **How to Become a Bonded Carrier**

- Carriers and freight forwarders seeking to post financial security or manage their current bonds can do so in the CCP.
