The following is a copy of the South MS Intergroup Minutes from the Intergroup meeting dated December 11, 1988

Meeting opened at 6:35 p.m.

Purpose tonight is to discuss the Central Office.

Don gave brief summary of what it is for and how we hope it will operate, Annual Budget of \$5000. We need fundraisers to reach this. We can assign groups periods of time to run office, or just put the word out, and ask for volunteers. Details need to be worked out. We want all groups to think about the 60-30-10 plan for contributions.

Questions:

Q: What will be the markup on literature?

A: Any increase will be done by Intergroup. May be less than current 20%.

Q: What about phones?

A: Maintain answering service and have basic phone line.

Report from Hancock County DCM (Mark)

They thought of opening an office but it didn't get off the ground. They want to cooperate with Intergroup and will support it in any way they can. Money may be short.

Randy-Camel Group-will support Central Office, but not as much as 60-30-10. Extended area phone could include all three counties.

The Original Circle Triangle Medallion

Have you ever wondered how the custom of handing out raised center medallions began?

The story of behind the tradition is a story of innovation and strength of the recovery fellowship.

One of the brightest highlights in Wendell's history is our role in support for the millions of people worldwide who have fought and are still fighting the battle of addiction. In early 1973, Bill Westman, a recovering alcoholic wanted to do something to fortify the will of groups and individuals he spoke with. Bill designed and had Wendell's to produce a coin bearing two large A's on one side of the medallion and the Serenity Prayer on the reverse. His advice was to "carry this in your pocket or purse and when temptation is great, reach into your pocket and feel the medallion and remember your struggle to get this far." Thousands of the medallions were given to individuals and attendees of his Founders Group. Always thinking of his fellow members, Bill decided he wanted a design that would have individual meaning for each person who carried one. He knew the medallion as originally designed would feel much like other coins in the purse or pocket so he changed the design by adding a raised center with the actual time the person had been sober.

This is from the current By Laws for the Intergroup. Since the positions of the board are going to be voted on in October, I was asked once again to place the positions and duties in this month's newsletter. The minimum requirement of Sobriety for these positions is three years.

1. IG Board Duties and Responsibilities:

a. Chairperson:

- 1. The Chairperson shall conduct meetings and preserve order in accordance with these bylaws, Roberts Rules of Order, and other such rules and procedures as may be adopted by the Intergroup.
- 2. The Chairperson shall have the authority to appoint Special, Standing, and Temporary, and Standing Committees or positions, and shall be ex-officio member) member of all committees.
- 3. The Chairperson shall assist the Central Office Manager

b. Secretary:

- 1. The Secretary shall provide the previous meeting minutes at each IG Committee and Board Meeting.
- 2. The Secretary shall record the proceedings of all IG Committee and Board Meetings.
- 3. The Secretary shall provide minutes of the IG Committee meetings for publication in the Newsletter.
- 4. The Secretary shall notify the appropriate person of all IG Board, Committee, Standing, and Special Meetings.
- 5. The Secretary shall assist the IG Board and Committee members as needed.

c. Treasurer:

- 1. The Treasurer shall insure adequate bookkeeping records are maintained, all account payables and receivables are processed in a timely manner.
- 2. The Treasurer shall give a financial report at each regular IG Committee meeting and submit records to any audit agency as may be utilized by the IG Committee.
- 3. Two Signatures will be required on all checks one board member and the Central Office Manager or two Board Members.
- 4. The Treasurer shall act as Chairperson in the absence of both the Chairperson and Associate Board Member/Co-Chair.
