



HER WORLD MARKET is a retail consignment store where new brands can showcase and sell their original art, design and products. For a monthly fee, hermarketxo.com will host the selected vendor storefront.

BENEFITS TO HER WORLD MARKET BRANDS

HER World Market will provide vendors with:

- A world-wide, non-exclusive, license to use HER World Market in connection with the sale of HER World Market vendor's original product.
- Instant access to HER WORLD Enterprises. Community - a network of over 6k women.
- First dibs on vendor opportunities at local HER Events.

HER WORLD MARKET ADMINISTRATION SERVICES

In order for vendors to efficiently sell through HER World Market , HER World Market will be responsible for:

- Running and operating the functionality of HER World Market , including all related technical maintenance.
- Ordering and payment processing for products sold on HER World Market.
 - Upon each sale, electronically forwarding an invoice/receipt of such purchase to the customer and the vendor whose product is purchased. The vendor will then be responsible for shipping the product in accordance with the HER World Market's established shipping policy.
- On a monthly basis, sending the vendor a check equal to 100% of the sales of the products, sold through HER World Market (see HER World Market monthly commission information below).

HER WORLD MARKET MONTHLY COMMISSION

On a monthly basis, vendors will receive a monthly commission payment as follows:

- Payments will be issued to the vendor electronically on the 25th day of each month via cash.
- Vendor payments lessen the 2.75% of the overall sales of the products sold through HER World Market.

HER WORD MARKET VENDOR RESPONSIBILITIES

HER WORLD Enterprises expects all brands to run their business in a professional manner. The responsibilities of vendors on HER World Market are:

- The vendor will be responsible for providing the HER World Market administrative team with product information and updates/changes on a regular basis for accuracy.
- The vendor will be responsible for the following policies/processes: shipping, returns and/or exchanges and customer service (**except for questions related to technical processes, HER World Enterprises./HER World Market will not be responsible for customer service for HER World Market**).
- Keep up the good work with your dope products!



COMPENSATION TO HER WORLD Enterprises.

In exchange for the right to showcase and sell their product on HER World Market, vendors will pay HER WORLD Enterprises the following fees:

- A monthly consignment fee of \$249 by the 3rd day of each month.

SETTING UP YOUR BRAND

The vendor will provide HER WORLD Enterprises with the following items:

- The vendor will send one physical product to HER Headquarters for official product shots.
- Product shots are required before the vendor can go “live” on hermarketxo.com.
- Item /product descriptions, names and other relevant information.
- Information related to the vendor’s shipping and return policies (which will be determined by the vendor in conjunction with HER World Market and the vendor’s direct contact information (for customers to be able to contact the vendor about his/her products).
- Any other information the vendor wants to post on HER World Market, except that the vendor will not be allowed to post any language or products that are deemed by HER World Market, in its sole discretion, to be racist, sexist, homophobic or otherwise offensive and insulting (HER World Market will have the right to remove any language or products that it deems, in its sole discretion, to be racist; sexist, homophobic or otherwise offensive and insulting at any time).
- Once HER World Market reviews and consents (in its sole discretion) to the above information, HER World Market and the vendor will enter into a License Agreement and will set up shop!

DURATION OF STOREFRONT FEATURE

The first term of the agreement between HER World Market and the vendor will last for 3 months or 6 months and will be renewed automatically for additional periods, unless either party ends the agreement according to procedures set out in the Retail Agreement.
