**Brief Scope**

The KINGDOM OF GOD - Holy Church of Jesus Christ seeks qualified contractors to produce, personalize, and deliver the initial production run (pilot + first operational batch) of a new ICAO-compliant biometric electronic Machine Readable Travel Document (eMRTD) passport. This first version shall fully conform to ICAO Doc 9303 (Parts 1-4, 9, latest consolidated editions and amendments effective 2026), incorporating contactless eChip with facial biometrics (mandatory) and optional fingerprints/iris, in compliance with the ISO/IEC 39794 transition timeline.

**Key Requirements** (detailed in full RFP upon request)

- ❖ Complete ICAO Doc 9303 conformity (MRZ, eChip LDS1, PKI, Basic Access Control)
- ❖ High-security production facility (ISO 14298 / ISO 27001, Facility Security Clearance equivalent)
- ❖ Chain-of-custody, secure logistics, and full audit rights by the State
- ❖ Pilot production (144,000 booklets) + personalization testing + full initial rollout
- ❖ Duration: 7-year framework contract with options
- ❖ Evaluation Approach: Best-value tradeoff (Technical/managerial 65%, Price 35%)

- ❖ ICAO Doc 9303 (Machine Readable Travel Documents) and Best Practices for MRTD Acquisition
