STRUCTURE

I am certified and licensed by the National Christian Counselor's Association (NCCA) in the area of Temperament Counseling. This strategy focuses on the way that God created us and the implications of how our lives look in light of that. To determine temperament characteristics, a profile questionnaire called the APS will be filled out by the client. This will be explained in greater detail during the first session and prior to initiating the process. Those responses will be analyzed, and I will receive those results within 24-48 hours. This profile costs an additional \$30, but it is a one time fee that will be charged prior to initiating the process. This \$30 is in addition to the standard session fee (outlined on the next page.) Once this payment is made, the client will receive an email from WebServer@ncca.org to complete the responses.

We will spend subsequent time after this breaking down those results and looking at them through the lens of the current issues that are being faced by the client. To do this properly will require a minimum of 4 sessions. I have used this counseling theory and process with over 50 clients to great success. I believe that unlike personality assessments, this one dives into the core of who we are and looks at that as the foundation of our lives. This reveals much about our interpersonal relationships, and more importantly, our relationship with God.

SCHEDULING

Completing this process will create a Zoom link and an invite that will be sent to your email. I usually keep my availability updated 6-8 weeks out. Depending on availability, I am able to do in-person sessions at Union Road Church in Gastonia, NC. I do work a regular job, so most of my availability is in the evenings, but I'm able to use my lunch break to do sessions during select times during the day.

The fee for individual counseling sessions is \$100.00 per hour, with a one-hour minimum billable time. Any time over one hour is billed to the nearest quarter hour.
