Per the October 20, 2022, Order of the Board of Public Health and Environment, the following is the Weekly Report for BPHE Docket Number 22-29:

a) the list of Residential Neighborhood Organizations (RNOs) receiving notifications;

Drilling has not started. Required notifications were previously sent to: Kendra Black, Denver Councilwoman District 4: John Inzina of Strong Denver, and Loretta Koehler of Inter-Neighborhood Cooperation. Copies of the December 30, 2022, letters were attached to the previous weekly report.

Onsite work during the week of the Jan 2 through Jan 8 included the installation of the sound wall and two monitoring stations, bringing the rig and equipment to the site, and installation of the surface conductor. All work was done during daytime hours. The upcoming week (Jan 9 through Jan 15) includes setup of the rig and equipment, and start-up and conditioning of the drilling mud system. The 24-hour drilling operations are scheduled to begin this Wednesday, January 11th and should end by February 1st.
