Mr. Riedesel,

Per the October 20, 2022, Order of the Board of Public Health and Environment, the following is the Weekly Report for BPHE Docket Number 22-29:

a) the list of Residential Neighborhood Organizations (RNOs) receiving notifications;

Drilling started January 12<sup>th</sup>. Required notifications were sent previously. Copies of the December 30, 2022, letters were attached to a previous weekly report.

b) a copy of the notification sent to the RNOs;

See Item a). The 24-hr drilling phase started January 12<sup>th</sup>. The drilling continued through the week Jan 16 through Jan 22. The upcoming week (Jan 23 through Jan 29) includes drilling to final depth of the borehole, geophysical downhole logging, welding and placing casing and screens, installing gravel filter pack, and installing grout seal. The 24-hour drilling phase should end by February 1<sup>st</sup>. Copies of the December 30, 2022, RNO letters were attached to a previous weekly report.

c) a list of the households eligible for hotel vouchers;

None for the period of Jan 16 through Jan 22. Soundwall installation was completed by Jan 9<sup>th</sup>. The 24-hr drilling phase started January 12<sup>th</sup>
