Discussion on adding verbiage to the Rule Book regarding the cross training of sent detection canines.

Motion made by Mark Green to add the following lines to the Rule Book under each detection area:

Narcotics: A Narcotics K9 cannot be trained or certified on any EOD or Gun Odors.

EOD: Must not have any other scent training or certifications other than Gun.

Wildlife: A Wildlife K9 cannot be trained or certified on any EOD or Gun Odors.

Aircraft: An Aircraft K9 must be EOD or Narcotics. It cannot be both.

Contraband: A Contraband K9 cannot be trained or certified on any EOD or Gun Odors.

Currency: A Currency K9 cannot be trained or certified on any EOD or Gun Odors.

Gun: No change needed. 2<sup>nd</sup> by Daryl Gaunt. Motion passed.

#### **New Business:**

A recommendation to make Alaska its own region was discussed.

Motion to adjourn the meeting was made by Joe Caponetto, Daryl Gaunt  $2^{nd}$ . Motion passed and meeting adjourned at 1914 hours.
