2024 TAB ARMA Conference Scholarship Promotion - Terms and Conditions

1. Promotion Overview:

1.1 This promotion, organized by Tabcorp (TAB) and the Australian Racecourse Managers Association (ARMA), aims to provide an opportunity for a club representative of a thoroughbred racing club from each state in Australia to attend the 2024 TAB ARMA Conference. Tabcorp, as the naming rights sponsor, will cover the expenses related to conference registration, flights, and accommodation for the selected winners.

2. Eligibility:

- 2.1 The promotion is open to all racing clubs associated with thoroughbred racing in Australia.
- 2.2 Clubs must complete the online form via www.racecoursemanagers.com.au to submit their nomination.
- 2.3 Clubs must provide the details of the staff member they are nominating and a reason for the nomination.
- 2.4 The eligible roles within a racing club include:
- 2.4.1 Racecourse Manager
- 2.4.2 Track Staff
- 2.4.3 Club Manager
- 2.4.4 Racing Manager
- 2.4.5 Or equivalent
- 2.5 Employees, directors, and agents of Tabcorp, ARMA, and their immediate family members are not eligible to participate.

3. Promotion Period:

3.1 Nominations will open on the date of the promotion announcement and close on Friday, 5 July 2024, at 4:00 PM (local time).

4. Scholarship Benefits:

- 4.1 One racecourse manager from each state will be selected as a winner.
- 4.2 If a nomination is not received from a state, the promoters reserve the right to award scholarships to multiple recipients from other states or withdraw the scholarship offer for that state.
- 4.3 Each winner will receive a scholarship to attend the 2024 TAB ARMA Conference.
- 4.4 The scholarship covers conference registration, round-trip flights, and accommodation expenses for the duration of the conference.

5. Nomination Process:

- 5.1 Clubs must complete the online nomination form during the nomination period.
- 5.2 The nomination form must be filled out accurately and completely, providing all requested information.
- 5.3 Clubs must provide a reason for the nomination, as well as at least one on-course racing-related idea or promotion they would like Tabcorp to offer throughout the 2024-25 thoroughbred racing season.
- 5.4 Incomplete or late nominations will not be considered.

6. Winner Selection and Notification:

- ${\bf 6.1\ \ Winners\ will\ be\ selected\ by\ Tabcorp\ and\ ARMA\ based\ on\ the\ nominations\ received.}$
- 6.2 The selection process will take place after the nomination period has ended.
- 6.3 Winners will be notified week commencing Monday 17 July 2024, via the contact information provided during the nomination process.
- 6.4 If a winner fails to respond to the notification within seven days or declines the scholarship, an alternate winner may be selected.
- 6.5 If a winner is no longer employed by the racing club that nominated them at the time of the 2024 TAB ARMA Conference, they are ineligible to attend, and their scholarship will be ceased. Clubs can seek approval to transfer the scholarship to another eligible staff member with ARMA, but TAB and ARMA reserve the right to void the scholarship at their discretion.

7. Travel Arrangements:

- 7.1 Tabcorp will make all necessary travel arrangements for the winners, including conference registration, flights, and accommodation. Transfers to and from the airport are not included.
- 7.2 Winners must provide Tabcorp with the required personal information to facilitate the booking process.
- 7.3 Winners are responsible for obtaining any necessary travel documents and insurance and ensuring compliance with all travel requirements.

8. Publicity and Personal Data:

- 8.1 By participating in the promotion, winners agree to participate in any promotional activities related to the promotion, including but not limited to interviews, photography, and social media promotions.
- 8.2 Clubs' nominations and any personal data collected during the promotion will be used in accordance with Tabcorp's privacy policy and applicable data protection laws.

9. General Conditions:

- 9.1 Tabcorp and ARMA reserve the right to modify or cancel the promotion at any time, subject to applicable laws.
- 9.2 Tabcorp and ARMA reserve the right to disqualify any participant or club who violates these terms and conditions or engages in fraudulent or improper conduct.
- 9.3 Participants and clubs agree to release and hold harmless Tabcorp, ARMA, and their affiliates from any liability arising from or related to the promotion.
- 9.4 These terms and conditions shall be governed by and construed in accordance with the laws of Australia.
