### **IMPORTANT NOTICE!!! PAYMENT FOR SERVICE**

**Due to rising operating costs, there will be a \$25 price increase on all tax returns, regardless of tax year.** Your total tax preparation fee depends on which forms are required to be e-filed with the IRS and State(s). Payment is due upon completion of the tax returns by cash, check, credit card, or Zelle (JNS TAX SERVICES 562-417-9005) I'm sorry, but we cannot file your return without receiving payment first. NO EXCEPTIONS!

### For your convenience, we offer the following type of tax appointments:

- Mail-In (USPS, FedEx, UPS)
- Email (PDF format Only)
- Secure Portal Upload (Contact our office for access)

## This year's tax deadline is as follows:

- March 15th Partnerships & S-Corporations
- April 15th Individual, Sole-Proprietors, LLC's & C-Corps

Failure to file by the deadlines will result in late penalties and interest from both Federal and State

### **Extensions & Late filing penalties:**

If you need to file an extension, please contact us before the above deadlines, so we may file an extension on your behalf before that deadline. Please note that filing an extension is an extension of time to FILE your tax return; it is not an extension of time to PAY your taxes due. If you owe money and file AFTER the tax deadlines, the IRS will charge a penalty which is 0.5% of the tax due plus 6% interest. This is calculated on a monthly basis. You can only avoid the penalty if you pay your tax IN FULL by the due date. State penalties and interest vary in each State.

### **Regarding Health Insurance**

If you received assistance through the Healthcare Marketplace or Covered California, you WILL have to show proof! I cannot stress this enough! What this means in short is that you must have the **1095-A** before filing. Only if you were insured through the marketplace. Failure to provide this information or providing incorrect information will delay your income tax refund.

### **Full Time Students**

Please make sure you have form 1095-T from your college institution before your scheduled appointment. You should be able to retrieve it via your student portal or financial aid office at the school. Failure to provide this information will delay filing your return.
