### **2012 Events**

The following events occur "rain or shine." Contact a board member if you need more information.

- **Peninsula Garage Sale: Saturday, June 9, 9 AM to 4:30 PM.** DLPSA provides newspaper ads (on June 8-9), an announcement sign at the culvert crossing, and direction signs from the main roads. Participation is by your choice on your own property.

### **Items from the 2012 Spring Meeting**

#### **Attendees**

#### **Liability Insurance for DLPSA Members**

Officers of the DLPSA have known for many years that they can be found liable for any action construed as contributing to damages incurred to persons or property on the Peninsula. Accordingly, we have carried an insurance policy, but our Treasurer discovered this year that this insurance did not cover officer's liability. A motion was made and approved that the Board take immediate action to insure itself against such liability for the next year, during which

time the Board will make a decision about what additional coverage is needed.

Some have said that all members of the DLPSA (that is, all property owners on the Peninsula) are potentially liable for any damages incurred in a common area (such as, for example, a juvenile who breaks his neck falling off the pavilion roof). The Board must verify whether this is true, and if so, decide whether and how to cover this risk. It is possible that expenses for this coverage can be minimized by limiting it to active members, according to a list that the DLPSA provides annually to the insurance carrier. In that case, members who don't pay their dues would not be included in this coverage.

#### **Identifying Paid-up DLPSA Members**

Several participants expressed their long-standing frustration that the cost to carry property owners who refuse to pay their dues comes directly out of their pockets. Alternatives for improving participation were discussed. A motion was made and approved to publish the names of those who are current in their dues in this Newsletter.

#### **DLPSA Finances**

The budget for the coming FY 2012/13 was also approved as follows:

Projected Income:	\$12,350
Projected Expenses:	\$15,960

The Board acknowledged that this budget would need revision during the year. Expenses now include a figure for officers' liability coverage, a topic about which all residents will hear more information. It may be possible to lower expenses by insuring only dues-paying residents. Lack of payment by non-dues-paying residents has now reached the point where it may now may require a cutback on necessary maintenance.

### **Update to DLPSA By-Laws**

A DLPSA committee, headed up by Paul Grunberger, has undertaken to review the DLPSA by-laws and recommend amendments to be voted on in the next Annual Meeting in 2112. The committee, which includes Oral Carper and Sue Carlson, met over the winter to discuss possible changes, but Sue, who headed the effort to produce the latest revision in 2004, made a good case that the current by-laws are still good. They lack some of the formality and boilerplate that can be seen in other communities, but that can be regarded as an advantage in an organization that operates on a severely limited budget.

### **DLPSA Projects**

Most of this work is being done by volunteers at little or no cost to the DLPSA. Contact any Board member if you wish to lead or participate in a project.

#### **Completed Projects – Thanks to All:**

1. The inside Park Pavillion walls and ceiling were cleaned.
2. The north edge of the Pavilion roof was tarred in an effort to identify the juveniles who dwell on the roof.
3. Two big dips in the access road to the William P. Happ Boat Ramp were filled and re-paved under a contract managed by Duane Lueck.
4. John Hubbard repaired a damaged swing seat and installed a new tether ball in the Park.

#### **Active Projects**

1. Renovation of the shuffleboard court (new surface, scoreboard and equipment) has begun. This project is being sponsored and chaired by John Stuart, and completion will depend upon demonstration of interest by active DLPSA members.
2. Duane Lueck and Wayne Lanckton are building a DLPSA equipment closet (4 x 12 feet) into the northwest corner of the Pavilion for use by all active members with a Peninsula key (formerly called the Boat Ramp key). This will provide storage for sports equipment and any other items

that members wish to store while they are at the Park.

3. We have begun to replace deteriorating signs at various locations around the Peninsula.

Regarding item 3, we are starting with the restoration of William Happ's name at the Boat Launch, in honor of the work he did (see the Guest Column in the Fall 2011 Newsletter), and will then continue with the other lake accesses as funds become available. We will also make a final decision about the name of our Park, identified on the current sign as *Schworm Park*.

If you would like to help decide the content of the signs, please view the photos of the current signs at the Boat Ramp Bulletin Board, and make a recommendation to any Board member. Judging from the general lack of response in the past, your suggestion will probably have a considerable influence on the words you will see for the next 30 years!

### **Planned Projects**

We are sticking with plans to install new fencing at (a) Park horseshoe pits, (b) Road-end parks, and (c) corner of Peninsular Shores Drive with East Shore Drive.

### **Policy for Projects**

The Board has received very little support from residents for proposed improvements to the Park. Therefore, it has decided that proposed projects will require an active DLPSA member to demonstrate a community interest and chair an improvement committee.

### **Annual Picnic Notes**

We are not quite sure yet how long this has been going on, although a 4<sup>th</sup> of July Picnic was held in 1972, and subsequent picnics were held under the names *Summer Picnic*, *Annual DLPSA Picnic*, and (for the latest 5 years) *Pig Roast*. Another picnic is scheduled for this year, but since we have already set the precedent of roasting selected cuts instead of whole pigs, we have changed the name of this traditional event to the Annual Picnic.

This event has always been a great way to meet your neighbors! Let us know if you want to participate, or if you have new ideas for the arrangements.

### **Preferred Trash Collection Provider**

In 2010, the membership endorsed *American Waste* (AW) as the preferred provider of trash pickup for the Peninsula. Our contact (and yours) at AW is the Account Manager, Mr. Patrick (Pat) Cline, whom you may call at 231-624-1550 (cell phone direct), or 231-943-8088 (office).

AW, a locally owned and environmentally friendly company, has been providing superior service to more than 100 residences. Thursday pickups are only \$12/month, and details of other terms are listed on the DLPSA website.

(If you are a happy AW client who knows of a neighbor using another provider, you might want to help her (or him) decide to switch over by sharing your AW experience.)

## **Dues Issues**

### **Reminder about Dues Payment Policy**

Your Board has, by tradition, sent out dues notices with the Spring Newsletter, which is usually around June 1. That coincides with the beginning of the Fiscal Year for which you are paying those dues. Accordingly, the dues are considered payable when you receive the bill. Your prompt payment is valuable to the Board in its effort to establish an accurate budget for the year.

If you want to know more about our dues policy, there were detailed presentations in last year's Newsletters.

### **Dues Prospects**

In the last year, DLPSA has incurred additional unplanned expenses for winter storm cleanup, and recovery from acts of vandalism. Additionally, the establishment of Directors' liability insurance is being planned. As things stand, unless dues compliance can be improved above the current 50-60% level, it will be necessary to increase the regular dues amount. We urge you to talk to your neighbors about this, and to attend the Annual Meeting in September, where a decision on 2013-14 dues will be made.

We continue hear reports of drivers running the stop sign at the north end of East Shore Drive. This a truly blessed corner in that, according to Lowell Spence, there has not been an accident there. But, please don't tempt fate any further.

## **Focus on Vandals**

Just a few days ago, on the morning of Monday, May 22, 2012, someone cut the chain that controls access to the William P. Happ Boat Ramp. Access to this private boat ramp has been managed by the DLPSA for the benefit of dues-paying members since 1970. No individual Peninsula resident, or any member of the public, has the right to cut this chain for any reason. A Peninsula key to open the chain is available at no cost to each dues-paying member, and a replacement key (with no questions asked) is available for \$30.

Furthermore, there have been several recent incidents around the Park Pavillion. There are numerous shingle fragments on the ground there, indicating that juveniles (of whatever age) are continuing to climb up on the roof. Inside was an empty fifth of vodka. And, the garbage can lid has walked away! Should we be surprised? We guess not, because it was the only thing not chained down.

All of this activity is creating additional expense to you. Accordingly, we are taking measures to identify vandals and make sure they are stopped. If they think they have the right to engage in this behavior, they may have to explain that to a judge.

Meanwhile, be watchful. If you happen to see (or know of) anyone who is doing something to make our work harder, please contact any Board member with the information, so that one of us can have a conversation with an interested parent.

## **Winter Storm**

On the evening of Friday, March 2, those of us who braved the Winter here experienced an amazing, sudden storm that dumped 15 inches of heavy wet snow on us in a few hours, culminating in an electric power outage for the entire Peninsula that was to last 40 hours. Large branches, laden with snow, cracked and fell everywhere.

Saturday did not provide much relief, with blizzard conditions and an additional 9 inches. There was no sign of municipal road plowing all weekend, but many folks on the Peninsula were out helping each other.

Your DLPSA authorized about \$2,250 of unplanned expenditures to clean up tree damage in the common areas (lake accesses and parks)

## **Thanks to Landscape Management**

Our hats go off to Tom Fabatz and his team. While the municipal crews were apparently busy elsewhere, Landscape Management crews were out early the next week, loading and chipping debris that residents piled up in front yards all over the Peninsula for six solid days. There was no practical way to contact each resident on a timely basis for arrangements. On April 3, Tom mailed a letter to the 110 residents that had large amounts of debris, explaining the work that was done, and requesting a \$20 donation to defray the more than \$5000 in expenses that were incurred. We are happy to report that Landscape Management got responses from 28 residents, some of whom contributed more than the \$20 requested. ## **Trees over Power Lines**

Utility lines were severed in no fewer than five places. Two were from the sheer weight of the snow that coated lines to a 6-inch diameter, but three more were pulled down by falling branches. Our information is that because of previous complaints by homeowners, Cherryland Electric is reluctant to take the initiative to trim trees over lines. However, they would be happy to trim such trees at your request, if you would simply call them toll-free at 1-800-442-8616

We have also noticed that many trees on private lots are overgrown with massive vines (mostly grapevines) that cover the tree crowns and tend to catch more snow. You can easily correct this by severing them at the trunk near the ground. The vines will wither and come down on their own in a year or two, leaving you with a simple cleanup.
