

September 20th Meeting

Board Officers present: Pres. Duane Lueck, V.P. Rod Ross, Sec. Sara Cockrell, Treas. Scott Hackney, Directors. Jan Bachman, and Scott Hocking. Dir. Camille Brand was absent.

Secretary's minutes of Aug. 6th Annual Meeting and Aug 9th Organizational Meeting were approved as is.

Treasurer's report (see below) was given and approved.

Treasurer's Report:

Public participation: Dan Bodary attended the meeting to discuss the boats which dock at Access #4. Discussion was that the DLPSA's purpose is the beautification and upkeep of neighborhood amenities, and that the matter should be turned over to the appropriate government entity.

Garbage collection by one company was discussed. No resident would have to use this particular service, but this service would come with a reduced rate for assorted services (bags, carts, etc.)

January 2nd Meeting

Board Officers present: Pres. Duane Lueck, V.P. Rod Ross, Sec. Sara Cockrell, Treas. Scott Hackney, and Directors Camille Brand, Jan Bachman and Scott Hocking.

Secretary's minutes of November meeting were read and approved with corrections.

No public participation was requested. The Maintenance Committee is seeking bids for tree removal at the south end of the tennis courts in the park. Also, the inside of the pavilion should be

painted, and playground structures will be discussed with Kelly Steinbach.

Old Business discussed: A "Lock after use" sign has been ordered for the boat launch, as well as a sign to replace the Access #4 "No docking" sign.

New Business discussed: It was discussed that a another meeting be held in addition to the annual meeting in an effort to keep communication open between the board and the residents we represent.

March 6th Meeting

The board discussed the Green Lake-Betsie River Association. This is a separate body from the DLPSA, our homeowners group of peninsula residents, which is mainly concerned with maintenance of the accesses and park. The Duck Lake Association represents all residents on or near Duck Lake and is mainly focused on lake quality and environmental issues. As Green Lake, Duck Lake, and the Betsie River are all part of the same watershed, and because there is strength in numbers, the various associations have agreed to work together to help in tracking and solving environmental concerns. 
Now, enough of that "soap box," let's all get out there and enjoy the great outdoors!
