US-31 REBUILDING PROJECT

The Michigan Department of Transportation (MDOT) plans to rebuild a 7.8-mile section of US-31 from Reynolds Road to Sullivan Road in 2025-2026. The proposed rebuilding project includes widening to improve pavement condition and safety with the addition of center left-turn lanes, rumble strips and access management where possible. Interlochen corners, the South Long Lake Road/J. Maddy Parkway intersection will be rebuilt as a two-lane roundabout.

We also understand there will be a focus to make the intersection where East Duck Lake Road meets US-31 much safer. The addition of a dedicated right-turn lane

on northbound US-31, realigned East Duck Road to reduce the curve there and grading/flattening improvements are planned.

FALL CLEAN-UP

The leaves and pine needles are falling. For all our new residents and others, there are several options available to you. You can contact independent landscape services to help with your specific needs. They can do a complete clean-up or simply pick-up your leaves, pine needles and small yard waste you collect and deposit near the street. Another option is taking your leaves or grass clippings (only) to the Green Lake Township Compost Facility, which is located on Youker Road just 2.7 miles from County Road 633. If you have questions on using this facility you can call (231) 276-9329. Previously you had to acquire a key from Green Lake Township to open the gate but lately the gate has been open. PLEASE, do not blow or deposit leaves or yard waste into the lake, on neighbor's property, on our various easements/parks or vacant lots on the Peninsula. Your attention to this matter is greatly appreciated by all community members, especially your immediate neighbors.

SHORT-TERM RENTALS

Short-term rentals continue to be a concern for our community members. It should be noted that such activity is in violation of both Section A & C of our Protective Covenants. Section A states "lots shall be used exclusively for residential purposes." Section C states "no commercial enterprise or business of any nature shall be be carried on upon any lot nor shall anything be done thereon which may be or become an annoyance or nuisance to the neighborhood."

CHICKENS & ROOSTERS PROHIBITED

There is a Green Lake Township Zoning Ordinance that prohibits raising or keeping Chickens and especially Roosters, on the Peninsula. All property on the Peninsula is considered Lake Residential District (LK). Article 4 – General Provisions, 4.29. If you have issues with a neighboring property that is housing or raising chickens please contact Green Lake Township Zoning Supervisor, Jason Hamilton, (231) 276-9329.

MANAGING PETS ON THE PENINSULA

We continue to receive complaints regarding dogs not on leashes and freely roaming Peninsula properties. The State of Michigan has a Leash Law that requires all dogs to be on a leash, which means the dog owner is required to enforce this law by keeping their animal securely on a leash and under control in public areas. Additionally, dog owners should be reasonably responsible to clean up after their pets, especially on Peninsula easements/parks and other community members properties. There are dog clean-up bags available at all the Parks. These bags should be used and deposited in the owners trash, NOT LEFT ON PUBLIC PROPERTY ON THE PENINSULA! We continue to have issues with someone or multiple owners leaving bags containing waste at the boat launch.

PLEASE dog owners, this should not be an issue we continue to address or deal with! It should not be the responsibility of others to clean-up after your pets!



OBITUARY FOR JOHN TREZISE

John B. Trezise, 102, of Grawn, died on September 14th, 2025 at home. Mr. Trezise, who was a descendant of some of the earliest settlers in northern Michigan's Keweenaw Peninsula, was born in Calumet, Michigan on November 28, 1922 to Norman and Emma Anderson Trezise.

He graduated from Calumet High School in 1940, and was then employed on the editorial staff of the Calumet daily newspaper until he entered the U.S. Army in early 1943, where he served until 1946 during World War II. After the war he enrolled at the University of

Michigan where he earned a bachelor's and master's degree in 1949 and 1950. After completing his college education, he was employed for 29 years by the Ford Motor Company where he held management positions in the sales and systems departments.


In 1950 he was married to Patricia Jane Wright, of Fort Thomas, Kentucky, who was at the time a nurse at University Hospital in Ann Arbor. They had three sons, Peter, John, and Timothy. The family lived in Ann Arbor for the next thirty years, where he was active in the Democratic party and participated in successful bond/millage campaigns conducted by the Ann Arbor board of education. Upon his retirement from Ford, he and his wife moved to the Traverse City area where they resided on the Duck Lake Peninsula. Patricia Trezise died in June, 2010.

After moving to the Traverse City area, Mr. Trezise became active in library affairs. He was one of the founders of the Interlochen Public Library in 1982-83, and served on the Board of Trustees of the Traverse Area District Library from its establishment in 1983 until 1991. In 1992 he was elected to the board of the Interlochen Library where he served until 2001, including four years as board president. He remained active in the Library's affairs until his final illness.

Mr. Trezise is survived by his sons: Peter, John, and Timothy (Regina). He is also survived by granddaughters: Sarah VandeBurgh, Carole Blue, Christina Alexander, and Brooke Morici; grandson John Carolyn; and great-granddaughter Adeline VandeBurgh.

Besides his parents, he was preceded in death by his wife, Patricia, two sisters, Norma Baril, of Lansing and Winifred Dietzel, of Flint, and brothers, Philip Trezise, of Washington, D.C., and Carl Trezise of Temple Hills, MD.

John lived at 3763 East Shore Drive. A Memorial Service is scheduled for Sunday, November 9, 2025, at 2 pm, at the Interlochen Public Library.



OBITUARY FOR EDMUND MARTIN BARBOUR, MD

Edmund Martin Barbour (Marty), from Dearborn MI age 85, passed away on September 28th, 2025 peacefully surrounded by his family. Born on March 4th, 1940, in Detroit, Michigan, Marty graduated from Austin Catholic Preparatory School in Detroit in 1958. Marty went on to study at Marquette University in Milwaukee WI receiving a BA in 1962 and a MD in 1966 where he also met the love of his life, Judy Binell whom he married on July 31, 1965. Marty served as a Lieutenant Commander in the US public Health service and Coast Guard assigned

to the Public Health Service Division of Indian Health at Indian Hospital in Phoenix, AZ. Following his honorable discharge for time served, Marty, Judy, and baby Nicole moved back to Dearborn for an Internal Medicine Residency at Harper Hospital. Shortly thereafter Michael became a welcome addition to the family.

Marty started a private practice in Dearborn, MI in 1971. In 1976 he became an Assistant Clinical Professor of Medicine at Wayne State University and from 1987 on was an Associate Professor of Medicine, Wayne State University. Marty retired from the practice of medicine in 2006.

Marty was an avid sportsman - hunting and fishing at Durkee Lakes Hunting and Fishing Club and "the Binell cottage" in northern MI at 3860 Peninsullar Shores Drive. He also enjoyed baseball, softball, bowling, and especially golf - his favorite pastime and what kept him moving.

GRAND TRAVERSE REGIONAL LAND CONSERVANCY

Since 1991, the Grand Traverse Regional Land Conservancy (GTRLC) has protected and cared for the region's natural, scenic, farm and forest lands thanks to the support of generous donors and volunteers, and strong partnerships with local, state and federal agencies. We use a targeted selection of land protection tools that guarantee the permanent safeguarding of significant land and other natural resources. Our work reflects the needs of local communities and is made possible by the participation of willing landowners. We protect land by:

- Working with landowners to permanently protect private land through voluntary conservation easements
- Acquiring high-quality natural lands by purchase or donation to create Conservancy-owned nature preserves and nature sanctuaries
- Assisting local government units in creating or expanding public parks and natural areas
- Providing technical assistance to local government units to administer farmland protection programs

We protect the places that matter most: crucial wildlife habitat and corridors, critical watersheds, high-quality farmlands, valuable forests and ecologically significant dunes along Lake Michigan's beautiful and endangered shore.

As of 2025, GTRLC has protected more than 48,400 acres of irreplaceable northwest Michigan land and nearly 157 miles of shoreline along our rivers, lakes and streams—but protecting land is just the beginning. As long-term land stewards, we are responsible for caring for the lands we preserve. Our stewardship team works year-round to ensure the health of natural ecosystems, maintain trails and infrastructure and provide safe, sustainable access to nature where appropriate.

Together, we can do even more! Please join us in the effort to keep northwest Michigan a spectacular place to live, work, and play. Our work is possible with the support of people like you!
