MEMORIAL PLAQUES

As noted in our Spring Newsletter, our new park benches provide an opportunity for Memorial Plaques to be incorporated. The cost for each plaque is \$400 and will go towards the purchase of additional new benches as deemed necessary. To date, we have received requests for three such plaques. The first was from long-time residents John and Paul Schroeder in honor of their parents and reads "Thank you Reba & Ernest Schroeder Loon Lookout." This plaque will be placed on one of the benches at South Beach Park at the end of East Shore Drive. Reba and Ernest were one of the first families on the Peninsula. After camping at Interlochen State Park for many years and rowing their boat over to explore the Peninsula one Summer in 1951 they found a for sale sign and early development with sand roads. They bought a lot for \$700 and built the basic half-log cabin in 1952 without any

electricity, electricity had not come down Central Park Road yet, by two Swedish Carpenters by hand and sweat. The cabin still stands today. If you walk the Peninsula, you've likely seen the sign "Loon Lookout" at the road in front. You might recall Phyllis and Paul Schroeder were the Grand Marshall's of our 2021 4th of July Parade around the Peninsula.

The second plaque to be placed at North Beach Park reads "In loving memory of our dear Granddaughter, Meghan Elizabeth Speiles, March 3, 1996 - January 31, 2003.



Meghan Speiles

Meghan Speiles was born on March 22, 1996, to her proud parents Mark and Kim Speiles of Ann Arbor, Michigan. Her sister is Makenna Anne and her brother is Jacob Speiles. Meghan was an intelligent, happy, and energetic first grader at King Elementary School in Ann Arbor, Michigan. The week before she became ill, she was the "Star of the Week" in her class at school. She was a Brownie Girl Scout and received a new badge the same week. Meghan loved coming up to Duck Lake in the summer time to visit with Grandma Anne and Grandpa Tom. Meghan was an outgoing little girl who enjoyed colorful flowers, arts and crafts, and dancing around. Meghan enjoyed trying to catch butterflies in her little net. She had fun playing in the water and looked forward to many boat rides and fishing. She was our bundle of joy.

On January 31, 2003, after a brief illness, Meghan suddenly passed away due to Influenza A and Bacterial Pneumonia. We miss her dearly. Tom and Anne Speiles, Meghan's Grandparents purchased their property on Duck Lake in 1979. In 1984, they moved into their new cottage with their three sons. Today Tom and I are very blessed to live in this beautiful area of the Northland on Duck Lake. We are especially thankful for the nice and caring neighbors who surround us.





Bud and Doneva Johnson

Bud and Doneva Johnson were able to live out their dream of living on Duck Lake Peninsula and raise their family on the lake. Bud and Doneva built their first home on the peninsula at 4094 Peninsular Shores Drive. This was the 6th home to be built on the peninsula and at the time it was at the end of the road. Bud was a contractor by trade, and he built this home entirely by hand without any power tools. Seven years later they sold that home and built a home at 4076 Peninsular Shores where they lived for the next 65 years raising 2 sons a daughter and sharing their beloved Duck Lake with 9 grandchildren and many great grandchildren.

Bud was an avid hunter and fisherman and he could be found on the lake winter and summer fishing and enjoying the outdoors. Doneva was an amazing cook

and loved to fry up his catch of the day. Bud and Doneva believed in giving back and were always available to help out a neighbor start their furnace, prime their pump, mow their lawn, shovel their roof and provide the news of the peninsula for its residents. Bud also built and/or remodeled 27 houses on the peninsula. Not many people get to live their dream but Bud and Doneva did. Bud brought Doneva to where their first home would later be built when they were dating. He promised Doneva that someday they would live there. After serving in the Navy during WWII Bud returned from the war to marry Doneva and move to his dream spot-Duck Lake Peninsula.

SHORT-TERM RENTALS

Short-Term rentals continue to be a concern and potential nuisance for many of our community members. It should be noted that such activity is in violation of both Section A & C of our Protective Covenants. Section A of the Protective Covenants says "lots shall be used exclusively for residential purposes." Section C states "no commercial enterprise or business of any nature shall —be carried on upon any lot nor shall anything be done thereon which may be or become an annoyance or nuisance to the neighborhood."

CHICKENS & ROOSTERS PROHIBITED

The Green Lake Township Zoning Ordinance prohibits raising or keeping of Chickens and especially Roosters on the Peninsula. All property on the Peninsula is considered Lake Residential District (LK). Article 4 - General Provisions, 4.29 The Keeping of Livestock Other Than Horses, C. Regulations and Standards for Keeping of Mature Fowl.


TENNIS AND PICKLE BALL COURT

The Tennis & Pickle Ball Court in Schworm Park is one of our premier assets on the Peninsula and needs to be treated as such. It is for the explicit use for Tennis and Pickle Ball only. There have been times when residents have seen children playing on the courts on bicycles, skateboards or other wheeled toys, which must be prohibited. Everyone's assistance to assure wheeled vehicles are not used on the court is greatly appreciated.

KNOW THE BASICS PEDESTRIAN SAFETY

9 Walking Safety Tips

- 1. Be predictable. Follow the rules of the road and obey signs and signals.
- 2. Walk on sidewalks whenever they are available
- 3. If there is no sidewalk, walk facing traffic and as far from traffic as possible.
- 4. Keep alert at all times; don't be distracted by electronic devices that take your eyes (and ears) off the road.
- 5. Whenever possible, cross streets at crosswalks or intersections, where drivers expect pedestrians. Look for cars in all directions, including those turning left or right.
- 6. Never assume a driver sees you. Make eye contact with drivers as they approach to make sure you are seen.
- 7. Be visible at all times. Wear bright clothing during the day, and wear reflective materials or use a flashlight at night.
- Watch for cars entering or exiting driveways, or backing up in parking lots.
- 9. Avoid alcohol and drugs when walking; they impair your abilities and your judgment.



DOGGIE BAG DISPENSERS

Here are the bag dispensers for use at all Peninsula access areas and throughout the neighborhood. These PVC ones are water tight and bug resistant. They accept 3 rolls of bags, one being dispensed and two in
