## DATA SECURITY

Protecting your data is our top priority. We use advanced security measures to ensure that your information is always safe and secure.

- The document storage area is well protected.
- Access to our server is restricted to the only Manager, requiring authentication through an Administrator Password.
- All computers are password-protected.
- Various backup operations are scheduled to prevent data loss.
- We take extra precautions to protect our document storage area.
- Every workstation has anti-virus software installed, which checks for updates daily, performs quick scans daily, and has boot and full scans scheduled weekly and monthly, respectively.
- Anti-malware software performs quick scans twice a week on all computers. Circuit cameras cover our premises for monitoring purposes.
- The server and workstations are configured to lock after 2 minutes of unattended time, requiring re-authentication to unlock.
- Various backup operations are scheduled to prevent the loss of data.
- Users are not allowed to use personal email accounts, and access to various internet sites is restricted and controlled.
- Staff members are prohibited from using USB devices and mobile phones.
