Thank you for choosing TGMC (Temple Guard MC). In order to be a Member of TGMC, you must be a Master Mason in good standing with a Blue Lodge that is recognized by the Grand Lodges of Louisiana and Mississippi and own a legally registered motorcycle of not less than 800cc.

For liability issues, we do require that you submit a copy of the following documentation with your application packet:

- Your current Blue Lodge dues card
- A valid state driver's license with your photo and motorcycle endorsement
- A valid registration for the motorcycle you currently ride
- A current insurance certificate for your motorcycle

Please follow these instructions:

- Read and understand the TGMC By-Laws.
- Complete and sign all documents in the Application Form
- Email all completed and signed papers (4), along with copies of the documents mentioned above, to:
 - president@templeguardmc.com

The copies of your personal documents are not retained by Temple Guard MC. They are only used as verification and then are properly discarded.

Once your application is received and reviewed, you will be contacted by a Temple Guard Officer with further instructions.

There is a \$ 185.00 donation for your patches that will be due once you are accepted into the Club. This cost includes your first year's \$ 30.00 donation as a member. An annual donation of \$30.00 will be due by February 1 of every year you are a Temple Guard MC member. All donations are payable in U.S. dollars and checks are to be made out to "cash". **However, the preferred method of payment is thru PayPal transferring money via "Friends and Family".**

IRREVOCABLE CONSENT AGREEMENT

Temple Guard Motorcycle Club Release and Waiver of Liability

As consideration for being permitted by the Temple Guard MC to participate in these activities, I forever release the TGMC and its respective Founders, Officers, Members, and Chapters (collectively "Releasees") from any and all actions, claims, or demands that I, my assignees, heirs, distributes, guardians, next of kin, spouse and legal representatives may now or shall have in the future, for injury, death, or property damage, related to (i) my participation in these activities, (ii) the negligence or other acts, whether directly connected to these activities or not, and however caused, by any Releasee, or (iii) the condition of the premises where these activities occur, whether or not I am then participating in the activities. I also agree that I, my assignees, heirs, distributes, guardians, next of kin, spouse and legal representatives will not make a claim against, sue, or attach the property of any Releasee in connection with any of the matters covered in the foregoing release.
