Sheriff's Office Road Patrol Proposal

- For the sole purpose of providing Isabella County Sheriff's Office Road Patrol operations, equipment, communications and notifications, shall the constitutional limitation on general ad valorem taxes which may be assessed in any one year upon all property within Isabella County, Michigan, be increased by up to 1.45 mills (\$1.45 per \$1,000.00 of taxable value) for a period of six (6) years, from 2024 through 2029, inclusive.
- ▶ If approved and levied in full, this millage will raise an estimated \$3,737,196.00 for the Isabella County Sheriff's Office Road Patrol operations, equipment, communications and notifications in the first calendar year of the levy. In accordance with State law, a small portionof the millage may also be disbursed to the Downtown Development Authorities of the city of Mt. Pleasant and Union Township; the Tax Increment Finance Authority of the City of Mt. Pleasant; and the Brownfield Redevelopment Authority of the City of Mt. Pleasant.
