BALLOT PROPOSALS

There are four Washtenaw County-wide ballot proposals on the November ballot. In addition, there are several other ballot proposals that are specific to a city, a township, or school district. For more information on all these ballot proposals, please visit <u>washtenaw.org/DocumentCenter/View/35429/November-5-2024-Official-List-of-Proposals</u>

Ballot proposals often propose tax increases earmarked for a specific purpose, although these taxes are not necessarily the only way that purpose might be funded. For any ballot proposal, a 1.000 millage rate is equivalent to a \$1.00 tax per one-thousand (\$1,000.00) dollars of property taxable value; e.g. \$350 for a \$350,000 property.

Proposal 1: Emergency Communications Systems Tax. This tax is to support the County's Enhanced Emergency Communications system. It renews a 0.096 millage rate and adds an additional 0.200 millage rate for 10 years (2026 to 2035).

Proposal 2: Veterans Tax. This tax is to support the County's Department of Veterans Affairs. It renews a 0.100 millage rate and adds an additional 0.100 millage rate for 8 years (2024 to 2031).

Proposal 3: Older Persons Service Tax. This tax would provide funding for activities and services for older persons (age 60 and older) in Washtenaw County. This is a new tax millage of 0.500 for a period of 8 years (2024 to 2031).

Proposal 4: Community Mental Health and Public Safety Tax. This tax is to provide funds for the County Community Mental Health Department, the County Sheriff's office, and local government police force with funding to improve treatment of mental health needs. It renews a 1.000 millage rate and adds an additional 1.000 millage rate for 8 years (2026 to 2033).

CANDIDATE PROFILE: RYAN BAUMGART

Candidate for Washtenaw County Board of Commissioners, District 3

(Bridgewater, Freedom, Lodi, Manchester, Saline, Sharon, and York Townships; Cities of Milan and Saline; Village of Manchester)

Ryan Baumgart is the Founder & CEO of a small business in Saline with a degree in Intercultural Studies and a Juris Master's degree in International Legal Studies.

As an active member of the community, Ryan is running to address the severe problems on the Washtenaw County Commission: lack of transparency, misuse of funds, overreach of elected officials, and a lack of reporting

accountability. Each of these problems can be identified as extensions of a sole-party system within the Washtenaw County government. Ryan's top priority will be to call for transparency in reports, such as those of government funding and the availability of line items that directly impact the livelihood of Washtenaw County residents.

For example, on October 18, 2023, Ryan's opponent, Commissioner Beeman, sought to use USDA-allocated funds available for district residents to "remedy" the issue of homelessness in out-of-district communities, calling it "money on the table." Beeman

thought nothing of violating the strict conditions on the funds' usage to misappropriate the money outside of her own district.

In another example, the Board of Commissioners heard months of public outcry against a proposed set of seven tax millages, most allocated to community mental health. The Board blatantly whitewashed the concerns, actively refused to change terms on these county-wide tax hikes, and meanwhile offered "blank check" conditions on the use of drawn funds. The tax millages were written with unclear responsibility for the oversight of these resources.

As Commissioner, Ryan Baumgart will blow the whistle on the misuse of funds for private and partisan endeavors. Using his background, Ryan will put these practices into plain language for presentation to the public. His goal is to renew trust in elected officials, and to uphold the high standards of office that voters expect.


