The All American Girl pageant is a youth development program open to girls ages 0-26 that are unmarried without children.. it offers three levels of competition: Preliminary, State, and National.

All American Girl is dedicated to promoting positive pageantry by celebrating today's girls and tomorrow's leaders in a fun, family friendly, and natural program! The focus in All American Girl is on natural beauty, poise, public speaking, and personality. This format allows ALL participants the opportunity to compete equally within our program.



The age division in which you are eligible to compete is determined by your age as of September 1st (2023). Baby Miss - 0-2 years Tiny Miss - 3-4 years Mini Miss - 5-6 years Little Miss - 7-8 years Young Miss - 9-11 years Jr Teen Miss - 12-14 years Teen Miss - 15-18 years Miss - 0-26 years

INTERVIEW OR PLAYTIME - 40%

Playtime will be for the Baby Miss and Tiny Miss division with all others interviewing with the judges one on one, round robin style. You will have 2 minutes with each of our 3 judges.

PERSONAL INTRODUCTION - 15%

During the casualwear competition, you will have no more than 30 seconds to introduce yourself to the judges. Mandatory components of the introduction include name, age, and hometown. You are free to add additional elements to your speech so the judges have an opportunity to get to know you better.

CASUALWEAR - 15%

Using the All American Girl modeling pattern, you will model an outfit of your choosing such as a pantsuit, dress, etc. that is age appropriate. No jeans are allowed.

PARTY/FORMALWEAR - 20%

Using the All American Girl modeling pattern, you will model a party dress or formal gown of your choosing that is age appropriate.

PARTICIPATION SCORE - 10%

Points are awarded based on observations made during down time, parties, while backstage, etc. Always remember to be kind to one another!



OVERALL

Highest scoring contestant in her division. The overall package.

BEAUTY

Highest combined score of casualwear and party/formalwear

PERSONALITY

Highest combined score of interview and personal introduction.

IDEAL MISS

Chosen by the current State Royalty and Director. Goes to the contestant who is a true All American Girl

COVER GIRL

Given to the contestant who promotes our program and brings in the most ads. In case of a tie highest score between the two will be awarded Cover Girl

PHOTOGENIC

As chosen by the judges from the submitted contestant headshots.





Guidefines By Division





PLAY TIME

Judges will be looking for those girls who are friendly with others and willing to share. The attire should be age appropriate sunday best dress, cute romper or jumper. Judges will take into consideration the overall length, modesty, and appearance of each girl No makeup, no heeled shoes. Chaparone will accompany contestant during playtime. You may bring in a favorite toy to play with.

CASUALWEAR / INTRODUCTION Dressier playtime outfit that is age appropriate. Cute dress, romper, or jumper. Light makeup age appropriate for stage. No heeled shoes. No denim. Chaperone must be touching/holding contestant AT ALL TIMES. Introduction will be given by the Chaperone at the 2nd X. Queen will hold the mic, the contestant or the chaperone should NOT touch/hold the mic.





PARTYWEAR

Party Dress should be a dress that would actually be worn to a party / wedding. Cupcake /pageant dresses are not appropriate. Hem needs to be within 1" above or below the knee. Dress MUST have at least 1" straps. Light makeup age appropriate for stage. No heeled shoes. Turned down ankle socks (ruffle ok). Chaperone must be touching/holding contestant AT ALL TIMES.





PLAY TIME

Judges will be looking for those girls who are friendly, playful, and respectful to others. They will interact with other contestants and the judges. No chaperon will accompany them. The attire should be age appropriate Sunday best dress, cute romper or jumper. Judges will take into consideration the overall length, modesty, and appearance of each girl No makeup, no heeled shoes.

CASUALWEAR / INTRODUCTION Dressier playtime outfit that is age appropriate. Cute dress, romper, or jumper. Light makeup age appropriate for stage. No heeled shoes. No denim. Chaperone must be touching contestant AT ALL TIMES. Introduction will be given by the Chaperone or Contestant at the 2nd X. Queen will hold the mic, the contestant or the chaperone should NOT touch/hold the mic.





PARTYWEAR

Party Dress should be a dress that would actually be worn to a party / wedding. Cupcake /pageant dresses are not appropriate. Hem needs to be within 1" above or below the knee. Dress MUST have at least 1" straps. Light makeup age appropriate for stage. No heeled shoes. Turned down ankle socks (ruffle ok). Chaperone must be touching contestant AT ALL TIMES.

Small wedge type heels are okay. No denim. Introduction will be given by the Contestant at the 2nd X. Queen will hold the mic, the contestant should NOT touch/hold the mic.





PARTYWEAR

Party Dress should be a dress that would actually be worn to a party / wedding. Cupcake /pageant dresses are not appropriate. Hem needs to be within 1" above or below the knee. Dress MUST have at least 1" straps A conservative amount of makeup age appropriate for stage. Small wedge style shoes ok.





Judges will be looking for girls who are well mannered, friendly, genuine, and real in their responses. The attire should be age appropriate Sunday best type of dress, tailored interview style dress, or jumper. No mini skirt styles. Judges will take into consideration the overall length, modesty, and appearance of each girl. Makeup and heels are ok.

CASUALWEAR / INTRODUCTION Dressier Casualwear outfit that is age appropriate. Cute dress, romper, jumper or two piece set. Makeup and heels are okay. No denim. Introduction will be given by the Contestant at the 2nd X. Queen will hold the mic, the contestant should NOT touch/hold the mic.





FORMAL WEAR

Full length formal wear dress. Hem should brush the ground when walking. A train is allowed but must be able to turn in it without grabbing the dress. Must have any size straps or sleeves on dress. 2 Piece dress is allowed with no more than a 2" Midriff showing. Makeup and heels are okay. No false eyelashes or hair extensions.

CASUALWEAR / INTRODUCTION Dressier Casualwear outfit that is age appropriate. Cute dress, romper, jumper or two piece set. Makeup and heels are okay. No denim. Introduction will be given by the Contestant at the 2nd X. Queen will hold the mic, the contestant should NOT touch/hold the mic.

Platform should be included in Introduction. False Eyelashes and Hair Extensions, if they are professionally placed into the hair are allowed.

Judges will be looking for girls who are well mannered, friendly, genuine, and real in their

responses. The attire should be an age appropriate tailored interview style dress, or jumper. No mini skirt styles. Judges will take into consideration the overall length, modesty, and appearance of each girl. Makeup and heels are ok. No False Lashes. Hair Extensions, if they are professionally placed into the hair are allowed. TEEN and MISS ONLY



FORMAL WEAR

Full length formal wear dress. Hem should brush the ground when walking. A train is allowed but must be able to turn in it without grabbing the dress, can be strapless but MUST be age appropriate.) 2 Piece dress is allowed with no more than a 2" Midriff showing. Makeup and heels are okay. False Eyelashes and Hair Extensions, if they are professionally placed into the hair are allowed. TEEN and MISS ONLY





Interview will include a resume that is turned in at registration. Judges will be looking for girls who are well mannered, friendly, genuine, and real in their responses. The attire should be an age appropriate tailored interview style dress, or jumper. No mini skirt styles. Judges will take into consideration the overall length, modesty, and appearance of each girl. Makeup and heels are ok. No False Lashes. Hair Extensions, if they are professionally placed into the hair are allowed. TEEN and MISS ONLY

CASUALWEAR / INTRODUCTION Dressier Casualwear outfit that is age appropriate. Cute dress, romper, jumper or two piece set. Makeup and heels are okay. No denim. Introduction will be given by the Contestant at the 2nd X. Queen will hold the mic, the contestant should NOT touch/hold the mic.

Platform should be included in Introduction. False Eyelashes and Hair Extensions, if they are professionally placed into the hair are allowed.

TEEN and MISS ONLY





FORMAL WEAR

Full length formal wear dress. Hem should brush the ground when walking. A train is allowed but must be able to turn in it without grabbing the dress, can be strapless, 2 Piece dress is allowed with no more than a 2" Midriff showing. Makeup and heels are okay. False Eyelashes and Hair Extensions, if they are professionally placed into the hair are allowed. TEEN and MISS ONLY



Examples of Introductions – Must include NAME, AGE, WHERE YOU ARE FROM everything else is extra. CAN NOT exceed the 30 second time limit.

- Representing the beautiful city of Seattle, Washington I am an honor student who enjoys rock climbing and reading comics. In the future, I'd like to be a Veterinarian. As active volunteer for the Red Cross and future lawyer, I enjoy singing, soccer and movie nights with my family. I am 8-year-old Grace Smith
- A 22-year-old graduate of the University of Oregon, I am currently pursuing a career in dance. I enjoy baking and sewing. Coming to a stage near you, in Salt Lake City, Utah I am Amy Seal
 - Good morning ladies and gentlemen. As a future translator for the United Nations, I enjoy baton twirling, shopping and of course learning new languages! An honor student from Lake Topps, Washington, I am 13-year-old Jessica Grace.
- From Casper, Wyoming this 2-year-old enjoys playing dolls all day long. Not sure on what she wants to be when she grows up but that is okay, she has time. This is Katie Peterson
- Paging doctor Doe, Paging Doctor Doe. That is what you will hear when this 3-year-old grows up. From Pinedale, Wyoming she likes dancing, singing, and anything that sparkles. Jane Doe is a name you will not want to forget.

The optional competitions are NOT required for the All American Girl Overall Titles

The optional talent competition was designed for those girls who have a desire for the performance arts. Maximum time limit is 2:30 and all music must be emailed prior to the date of the pageant. Any props, etc. must be able to be placed or removed from the stage in under 90 seconds unless approved with the director. Use of the runway is not allowed during talent. A piano will NOT be provided at the venue.

Fur Fashion

The optional Fun Fashion competition is for those girls who love fashion modeling and working the runway. Props, skirts, hand gestures, and fashion type modeling is allowed in this competition.

You will model while walking the AAG pattern but may add turns and poses of your choice. You better work!






Kunway Duo

The optional Runway Duo competition was designed for those who want family/friends to be involved in their pageant experience. In Runway Duo 2-4 particapants are to dress in fashion of choice (casual, formal or themed) and create a walk show casing their personalities. Use of the whole stage is permitted.

If the contestant participates in ALL optionals they will be entered, automatically, for the star award - given to the contestant with the highest combined scores of all optionals.

At ALL official All American Girl events, the emphasis is placed on participants AND adults to display good manners, grooming, listening to and acknowledging instructions, adjusting to various conditions, maintaining discipline and dependability, and above all, displaying excellent sportsmanship AT ALL TIMES.

All American Girl is a youth development program and a safe place for all. Because the All American Girl Pageant is a youth development program and a "family affair", the following rules and regulations will be enforced at every event. NO ALCHOHOLIC BEVERAGES will be allowed in or around the staging areas or events. This rule is enforced at every level of the pageant system and includes participants, parents, staff and guests viewing the event. Any violation of this rule will mean immediate disqualification from the All American Girl Program.

All participants, chaperones and guests MUST observe housing rules and curfews imposed by the pageant and host hotel. Contestants, Young Miss and below are not to walk the hotel or be unsupervised (by an adult) while in the hotel. Jr. Teen and Teen must have a buddy with them. Miss is encouraged to have a buddy. This is for the safety of all our contestants.

Smoking, vaping, and cannabis use by participants is strictly prohibited throughout the pageant week and at all events.

The NO SMOKING rule will apply to all attending events and be enforced in and around the staging area for the health and well being of the participants and those who do not smoke. Smoking will be permitted only in designated areas.

Pregnancy by participants is prohibited. AAG Is a Youth Development Program,

Participation is open to girl's ages 0-26 who are single, unmarried and without children. Participants, chaperones and guests who cannot observe the rules of the pageant are asked not to attend.

Any parent, teacher, guest, or participant who conducts themselves in an unsportsmanlike manner before, during, or after an All American Girl event, will be subject to immediate dismissal from the All American Girl program. This includes but is not limited to ALL forms of electronic media (Facebook, Instagram, SnapChat, TikTok, etc.). Such conduct will mean automatic forfeiture of ALL awards and titles.



Interviews will be done round robin style with each girl rotating to have a one on one interview with each of the three judges.

All American Girl is looking for those girls who are genuine and real in their responses and not just giving you the answers, they think you want to hear (rehearsed). They are polished but not "fake". Look for the girl who is passionate, shows vulnerability and confidence, can express their true feelings. Someone who you genuinely enjoy speaking with.

The attire chosen by each girl should be age appropriate. Take into consideration the overall length, modesty, and appearance of each girl. Here are some additional guidelines for each division:

Baby Miss through Little Miss (o-8) – No makeup, no heeled shoes, and no platform.

Young Miss (9-11) – Heels or chunky/wedge style 1" max and no platform. May wear a light, ageappropriate makeup.

Jr Teen Miss through Teen Miss (12-18) – May wear makeup but it must be age and interview appropriate. Heels are allowed but take into consideration if they can walk comfortably and with ease in them. These divisions do have platforms.

Miss (19-26) - May wear makeup but it must be age and interview appropriate. Heels are allowed but take into consideration if they can walk comfortably and with ease in them. This division will have platforms AND a resume that they will provide.



PERSONAL INTRODUCTION IN CASUALWEAR

This is judged during the casualwear presentation. The three mandatory components are the following: - Name - Age - Hometown

The personal introduction needs to be 30 seconds or less. Besides the three mandatory components, each girl can provide more information in her speech that will allow you to get to know them better. Take into consideration their confidence while speaking, clarity, speed in which they talk, and the content of their speech. Contestants are allowed to use hand gestures, but they are NOT allowed to touch the microphone.

Additional guidelines as follows:

Baby Miss (0-2) – Chaperone will say the introduction.

Tiny Miss (3-4) – The chaperone is suggested to say the introduction unless the contestant is comfortable enough to say it on their own.

Mini Miss – Miss (5-26) – Contestant says introduction themselves on the second x. Jr. Teen – Miss all should have a platform and are encouraged to add it into their introduction.

CASUALWEAR

For this competition, you will be looking for confidence, stage presence, personality, adherence to the walking pattern, personal appearance, and outfit choice. The outfit should ENHANCE the girl. There will be no use of props, lunges, high fashion turns, blowing kisses, etc. Contestants are to stick to a simple modeling presentation while following the All American Girl modeling pattern. All makeup should be age appropriate for the stage. Skirt and dress hems should be within 1" above/below the knee. If a romper or shorts, length should be school appropriate (about fingertip length). NO denim, this includes ALL parts of outfit. A "Miss America" turn is ok on the final X

ONLY.

Additional guidelines are as follows:

Baby Miss (0–2) – No heeled shoes. The chaperone must ALWAYS be touching the contestant. They can either be carried or a hand held. Chaperone will say their introduction.

Tiny Miss (3-4) – No heeled shoes. The chaperone must be on stage with the contestant. They are free to stay on stage in the back or they can walk with their child and assist them. Chaperone is suggested to say their introduction unless the contestant is comfortable saying it on their own.

Mini Miss through Little Miss (5-8) – No heeled shoes.

Young Miss (9-11) – Heels or chunky/wedge style 1" max.

Jr Teen Miss through Miss (12-26) – Heels are allowed but take into consideration if they can walk comfortably and with ease in them.



PARTY/FORMALWEAR

Again, for this competition, you will be looking for confidence, stage presence, personality, adherence to the walking pattern, personal appearance, and dress/gown choice. The dress or gown should ENHANCE the girl. There will be no use of props, lunges, high fashion turns, blowing kisses, etc. Contestants are to stick to a simple modeling presentation while following the All American Girl modeling pattern. All makeup should be age appropriate for the stage. It is important that the contestants look their age. A "Miss America" turn is ok on the final X ONLY.

Additional guidelines are as follows:

Baby Miss (0-2) - No heeled shoes. Dress length should be within 1" above or below the knee. The chaperone must ALWAYS be touching the contestant. They can either be carried or a hand held.

Tiny Miss (3-4) – No heeled shoes. Dress length should be within 1" above or below the knee. The chaperone must be on stage with the contestant. They are free to stay on stage in the back or they can walk with their child and assist them.

Mini Miss (5-6) & Little Miss (7-8) – No heeled shoes. Dress length should be within 1" above or below the knee. Dresses must have at least a 1" strap. No heeled shoes. We do not want these girls looking like a "young teenager".

Young Miss (9-11) – Dress length should be within 1" above or below the knee. Dresses must have at least a 1" strap. Heels or chunky/wedge style 1" max. We do not want these girls looking like a "young teenager or young adult".

Jr Teen Miss (12–14) – Dress length should be long and skimming the floor. The contestant should not have highly visible shoes, nor should the contestant be tripping on a long hem. Dresses must have some kind of strap. 2 Piece dress is allowed with no more than a 2" Midriff showing. Heels are allowed but take into consideration if they can walk comfortably and with ease in them.

Teen Miss and Miss (15–26) – Dress length should be long and skimming the floor. The contestant should not have highly visible shoes, nor should the contestant be tripping on a long hem. Strapless dresses are ok in these two divisions. 2 Piece dress is allowed with no more than a 2" midriff showing. Heels are allowed but take into consideration if they can walk comfortably and with ease in them.



ADDITIONAL GUIDELINES

- No false teeth allowed.

- Fake lashes or lash extensions are allowed for TEEN MISS and MISS ONLY.

Hair extensions are allowed for TEEN MISS and MISS ONLY. Extensions must be sewn in and not removeable. If a younger contestant has extensions/false hair, they must have a doctor's note that was turned in during registration. This information will NOT be disclosed unless an issue arises.
Teen Miss and Miss contestants cannot be married (or ever have been), be pregnant, or have ever had children.

- Again, ALL makeup and hair must be age appropriate. Makeup and hair should enhance a contestant's beauty and be complementary.

- All contestants, and their families, must show good sportsmanship AT ALL TIMES.

Deductions will be made for the following Clothing Violation Shoe Violations Action Violations (waving, blowing kisses, ect.) Walk/Pattern Violation (Not Crossing 2nd x, turns) Makeup Violation Time Violation (30 seconds) on introduction Missing Mandatory Component on introduction Late check-in Inappropriate behavior

The judge's decisions are always FINAL

State and National Directors are not permitted to sway the judging for any contestant in any way, at any time.

Judges are not permitted to speak with contestants, parents, etc. before, during, or after the competition. They are not permitted to offer any comments or personal critiques, without approval of director after the Pageant has concluded.

Judges are invited to all events. They may also be throughout the hotel so please be on your best behavior.

QUALITIES AND ATTRIBUTES OF A TITLEHOLDER

A titleholder in the All American Girl system is charming, poised, and a genuine individual. She should exude confidence, a strong self-esteem yet be approachable, kind, and compassionate towards others. She is a girl that knows how to make a good first impression, has the selfconfidence and speaking ability to give a good interview or speak confidently at a public appearance, and have the positive attitude to adapt and step up when needed. She should be at ease in a crowd or with her peers. She is graceful but not affected in a manner that is unbecoming of a young lady/woman. Her attributes include being poised, personable, well-groomed, self-confident; and above all have the character, humility, and inner beauty that sets her apart as a leader.

In All American Girl, we are searching for a natural, authentic young lady/woman to represent our program and be an example to those in her age division. She has manners, and her dress and behavior are always age appropriate. An All American Girl is the perfect balance of inner and outer beauty.

For our titleholders, they need to be role models in every way, even in their personal lives and what they post on their social media platforms. They need to set an example for the younger girls who are looking up to them and be held to a higher standard.

Our new titleholders will spend a significant amount of time together over the next year, so it is important that each new queen demonstrate a true love for being a role model, making a positive difference in the lives of other, and showing love and grace to all ages of our All American Girl family.

All titleholders in the All American Girl program are to conduct themselves with the dignity of the important title they hold. Failure to represent the title in a "Queenly" manner could result in the forfeit of the title and any rights thereof.

As a titleholder you are expected to go to 80% of the state events, Nationals is a big portion of this. If you fail to go to events you forfeit the right to any gifts received and possible end of rein scholarship.

As a state titleholder, you will also be expected to complete 20 hours of community service during your year of service.

One of the most important parts of the All American Girl Pageant is our commitment to community service. All American Girl is committed to teaching our youth to give back to their communities by volunteering their time and talents to charitable organizations.
