## BUILDING PERMIT GUIDELINES

As of January 1, 2026

### Requirements

A building permit shall be required for the following:

1. New Construction.
2. Additions to an existing structure and/or property. This includes, but is not limited to building extensions, sheds, garages, fences, permanent swimming pools.

*A minimum side clearance of **5 feet** shall be required from the boundary line or other structure, or it shall maintain the existing profile of current structures.*

3. Renovations or general repair to an existing structure (*A permit for renovations or general repair shall be required only when the value of the material is over \$2,000*).

### Permit Conditions

- A building **permit fee of \$25.00** shall be charged.
- Any deviation from the original permit shall require an amended permit.
- Application for a building permit should be received by the town at least 30 days prior to the expected start date of construction.
- Under no circumstances will a permit be issued or construction permitted to commence until all approvals have been received from applicable government agencies.
- A building permit shall only be valid for a period of 12 months.

Any person and/or business found constructing without a valid permit may be subject to fines and/or legal action.

The permit does not include or authorize any electrical work. A separate permit, from a licensed electrician, is required and is recommended.
