#### PHOENIX PD APP

The Phoenix Police Department has a mobile APP, bringing a variety of resources and information to one place. Users can use the app to access online reporting, crime statistics, precinct locations, phone numbers, career opportunities, virtual block watch, victims' rights information, and more. Users can also turn on notifications from the precinct they live in to receive news updates and information on events in their area.

The APP is now available both in the Apple Store for iOS and in the Google Play Store for Android.

Report graffiti on the Phoenix PD app! Graffiti can now be reported on the Police Department APP released in January 2021. Studies show that if graffiti is removed within 24 hours, there is a 90% likelihood that the graffiti will not use the app to have it removed! #GraffitiFreePHX

#### WHEN YOU CALL 911 - KNOW THE 10 W'S

- What is your location? GIVE EXACT LOCATION
- What happened? WHAT TYPE OF CRIME?
- When did this happen?

These questions will determine if it is a priority call. Give as much of this necessary information as you can.

- Was anyone hurt?
- **Weapons -** are there weapons involved?
- What manner did they leave or arrive foot, vehicle, bicycle...?
- Who did it? -Suspect description
- Where did the suspect go? What direction
- What did the suspect obtain? type and amount
- Who is calling? Give your name location and phone number (You can remain anonymous. If you do give your name, the info is redacted from the public record access.)

**TEXT 9-1-1** "Call if you can. Text if you can't." After months of collaboration between numerous public agencies and advocates for the disability community (or advocates for the disabled) if you are in imminent danger and are unable to talk to a 911 operator, you now have for the first time in Phoenix the ability to text to 9-1-1.

#### **UPDATE ON e-BIKES**

There have been ongoing concerns about the use of ebikes and the safety risks associated with them. These concerns are not limited to the Black Mountain Precinct but are shared across many precincts and cities throughout the valley. In response, supervisors and officers in the Black Mountain Precinct have launched several crime suppression initiatives aimed at addressing illegal activities related to e-bikes. This effort has included numerous educational contacts as well as some enforcement actions involving e-bike operators.

To enhance public awareness, the Department is working on updating a brochure to educate both e-bike operators and parents about the dangers, legal requirements, and potential consequences of improper use. Additionally, the Department is developing guidelines for supervisors and officers detailing the traffic statutes that apply to e-bike operators, outlining when citations may be issued during traffic stops. These guidelines will also address illegal modifications to e-bikes, ensuring that unlawfully altered devices are removed from the streets. The Department's Legal Unit, Public Affairs Bureau, Traffic Bureau, Mountain View Precinct, and Black Mountain Precinct are all working collaboratively on this project.

Once these measures are finalized, the Department's Public Affairs Bureau will launch public service announcements, media, and social media campaigns to further educate the community on e-bike safety. The goal is to promote the responsible use of e-bikes in legal areas while discouraging unsafe practices that pose risks to the public. Updates on these efforts will be shared as they progress. In the meantime, the Department remains committed to addressing e-bike-related concerns as they arise.

Please continue being an active member of the community in Black Mountain Precinct, and do not hesitate to reach out to any of us with your concerns.



Maricopa County is the 4th largest county in the U.S. It is funded by property taxes and has no debt. The County performs city-like services unincorporated areas, PUBLIC SAFETY Sheriff Department Search and Rescue, CRIMINAL JUSTICE Courts, Jails, and Diversion,

QUALITY Clean Air Act Compliance, PUBLIC HEALTH OUTBREAK PREVENTION Healthy Citizens and Communities, COMMUNITY DEVELOPMENT Planning, Zoning, and Environmental Hazards, TRANSPORTATION PUBLIC WORKS Operations and Planning, DOMESTIC ANIMALS & ANIMAL CARE Mitigation and Control, COUNTY RECORDING & ELECTIONS County Recorders and Elections Directors. 

#### **BLIGHT AND ZONING LAWS**

STRUCTURES: The maintenance of a home is the responsibility of the property owner. Any wood, siding, shingles, roof covering, railings, fences, walls, ceilings, porches, doors, windows, screens, and other exterior parts of any structure on the property must be maintained in weather tight, sound condition and in good repair. The property owner is responsible for making sure there are no doors or windows left open and not secure to the outside. FOR HELP call the Preservation Division of the Neighborhood Services Dept. at 602-495-0700 to see if you qualify for a free Grant!

**OUTDOOR STORAGE:** All outside storage that can be seen from the street should be inside sheds or cabinets. Items should not be set in car ports in view of the street. Please use enclosed areas or backyards.

**JUNK, TRASH & DEBRIS:** Junk, trash and debris cannot be left in the yard or car port and must be properly disposed of. This includes junk auto parts, appliances, furniture, building and/or landscaping material, trash such as discarded papers, cardboard, plastics, etc. including tree trimmings and fallen limbs or any other items that appear to have been discarded. The only exception is during the Bulk Trash Collection weeks four times a year

**PARKING:** Parking is only permitted for passenger cars and motorcycles on residential streets, on driveways or in garages. A driveway or parking area must be constructed with an approved dust free parking surface. The stone must be1/4 -3/4 in size with a permanent border holding it in. ¼ minus size stone is not allowed for parking. There are limits to the amount of front yard area that can be used for parking. Only 35% of the front yard may be converted to driveway or dust free parking.

**GRASS AND WEEDS:** Grass and weeds must not be allowed to grow over 6 inches high due to fire hazard, allowing the weeds to go to seed and spreading throughout the neighborhood and insect infestation.

**ELIMINATE GRAFFITI:** Keeping the neighborhood graffiti free is something we can all do. If there is graffiti on your property, please remove it as soon as possible. The Graffiti Busters Program provides paint, supplies and training to assist groups with eliminating graffiti. The City will also remove the graffiti from private property with written permission from the property owner. Call 602-495-7014.

## CRIME TIPS:

## THAT'S NOT THE SOCIAL SECURITY ADMINISTRATION CALLING

One of the most popular ways for criminals to steal money and sensitive information is by impersonating a trusted source—often a government agency. According to the <u>Federal Trade Commission</u>, victims of government impostor scams reported over \$577 million stolen from them in 2024 and, due to underreporting, that's likely a vast undercount.

The Social Security Administration (SSA) is a frequently impersonated agency. Here's what you need to know to help spot and stop a <u>Social Security impostor scam</u>.

#### **HOW IT WORKS**

You get an unexpected call, text or email from someone claiming to be from SSA who needs you to respond urgently.

You may learn that your Social Security account has been suspended.

They could explain that you need to fill out a form to get your annual cost-of-living increase.

Or they may warn that your Social Security number has been used to gain access to your bank account and now your assets are at risk of being drained.

#### WHAT YOU SHOULD KNOW

SSA almost never contacts people unexpectedly, so assume a contact from the agency is a fraud attempt.

SSA will never threaten you or demand immediate action.

In the event you owe money to the agency, SSA does not require payment with gift cards or cryptocurrency.

#### WHAT YOU SHOULD DO

Don't engage with anyone who unexpectedly contacts you and claims to be from SSA; if you are concerned there is a problem with your account, contact the agency at 800-772-1213 (while hold times can be long, it's worth the wait).

You can set up a "My SSA Account" and receive encrypted communications from SSA through it. With this access, you can go online to find out if SSA is trying to reach you. You can also check the status of an application, get a replacement card and more. Get started at ssa.gov/myaccount.

If you shared your Social Security number and feel it was part of a scam, file a police report for a record, and go to <a href="Light-left.gov">LdentityTheft.gov</a> for specific guidance on protecting against its use in identity fraud.

#### **BEWARE OF FAKE QR CODE SCAMS**

QR codes, those black-and-white squares you can scan with your phone, seem to be everywhere these days. While scanning them is convenient and makes reaching a website hassle-free, it can also be risky. Here's what you need to know about QR code scams.

#### **HOW IT WORKS**

You might encounter a QR code to pay for parking, browse a menu or learn more from a flyer.

You may receive a text or email with a QR code to address an issue with an account.

You may also receive a letter in the mail that offers a QR code to access discounts, offer loan forgiveness or request payment.

#### WHAT YOU SHOULD KNOW

While QR codes from trusted sources, like a business's official website or reputable magazine articles, are generally safe, not all QR codes are.

Criminals can easily create fake QR codes and place them in public areas, leading you to spoofed sites where you are

prompted to share personal information, including login credentials and forms of payment.

Since QR codes displayed on your phone serve as admission to live events, criminals may also sell you fake sports or concert tickets.

#### WHAT YOU SHOULD DO

Before scanning a QR code in public, make sure it doesn't appear tampered with—whether a sticker has been placed on top of the original code or you can detect other sorts of manipulation.

Before clicking on the web address the QR code is associated with, preview and carefully inspect it, looking for any misspellings, a switched letter or a shortened version of the web address.

Avoid scanning QR codes from unexpected messages, especially if they pressure you to act quickly.

Be especially wary of QR codes that come via email or text, since the point of a QR code is to link you to a website when you're not otherwise online.

If you're unsure if something is legitimate, contact the company directly using a verified phone number or website.

Protect your phone and accounts by keeping your device's operating system up to date and using strong passwords and multifactor authentication when available.

#### WARDRIVING: WHAT IT IS AND HOW TO HELP PROTECT YOUR NETWORK

Wardriving could enable hackers to gain access to devices connected to your home network. Find out how to help stop them. You probably already know the risks tied to browsing the web on unsecure wireless networks like the <u>public Wi-Fi</u> in your local coffee shop or at the airport. Wardriving brings some of those same risks to your home.

Wardriving occurs when a hacker drives around and uses technology to identify unsecure wireless networks — potentially in your home. The hacker may be able to access that network, gather sensitive data, and commit identity theft or engage in other malicious activities.

Are you at risk? It depends in part on the security of your home network. It's smart to take steps to protect your network, devices, and data against wardrivers. Here's what you need to know.

#### **HOW DOES WARDRIVING WORK?**

Peter Shipley, a computer security consultant, developed software that interacts with a portable global positioning system (GPS) and coined the term wardriving.

How does it work? Wardriving occurs when someone uses software and hardware to locate unsecure wireless networks and

potentially gain access to them. Software applications are needed to figure out passwords and decrypt networks. Hardware includes a mobile device such as a wireless laptop, a GPS system, and a wireless network.

Wardrivers travel around looking for Wi-Fi signals, plotting the Wi-Fi access points on a map — also called access point mapping — and gathering data on those networks. Wardrivers stay on the move, usually in vehicles, to find those Wi-Fi networks along their route. Variations of wardriving include warbiking, warcycling, warwalking, warjogging, warrailing, wartraining, and warkitting.

#### **HOW WARDRIVING CAN AFFECT YOU**

Wardriving could enable hackers to gain access to any device connected to your home network. Hackers that access your network through wardriving may be able to engage in malicious activities like installing malware on your home computer and other connected devices. They may commit online frauds like identity theft, using the sensitive data they obtain from the computer and other devices connected to your network.

#### IS WARDRIVING LEGAL?

The legality of wardriving can be confusing. Laws don't specifically prohibit or permit wardriving, but the act may have legal implications under certain jurisdictions and circumstances. For instance, in the United States, it isn't illegal to gather data on wireless networks. Wardriving can have benign purposes like data collection and computer-generated mapping.

But exploiting wardriving could be problematic if a wardriver accesses a private network. Hacking into networks that aren't yours — especially when accessing another person's data and with malintent — could be considered a network attack and deemed criminal activity.

Wardriving can be dangerous on a larger scale when the hack involves corporate networks.

## 5 WAYS TO HELP PROTECT YOUR NETWORK AGAINST WARDRIVING

You can take steps to help make sure your <a href="https://home.network.is.more.secure">home network is more secure</a> and not vulnerable to outsiders engaging in activities like wardriving. Here are five tips for preventing outsiders from gaining access to your network.

- Turn off your wireless router when away from home or not using it. This will ensure it is not discoverable to outsiders like hackers.
- Change the default administrative login username and password on your router. Otherwise, hackers may be able to discover the default administrative passwords on the web.
- Use the highest level of encryption possible. This
  means using a router with up-to-date, secure
  encryption like Wi-Fi Protected Access 2 (WPA2) or
  WPA3, and permitting router access by passwords
  only.
- Conduct a review of your network settings. This review includes making sure your network settings are updated with the latest security patches. Patches fix security flaws that could leave your network vulnerable.
- Configure a <u>smart firewall</u> as an extra layer of protection. A <u>firewall</u> can monitor communications and help block unauthorized users from accessing your network.

Wardrivers may be less likely to access your personal information if you take these steps to protect your network and devices against intrusion. Best result? Wardrivers will continue on their way.

## ACCESSIBILITY COMPLIANCE ENFORCEMENT PROGRAM

The Accessibility Compliance Enforcement aide is a volunteer who has committed to serve a minimum of four hours each week to assist the community and the Phoenix Police Department. Volunteers patrol the city of Phoenix, writing disabled parking citations. The mission of the ACE Program is to provide safe and accessible parking spaces for the disabled community through enforcement and education. Directed patrol is accomplished by responding to locations identified through the disabled parking violation hotline, **602-534-SPACE**.

The City of Phoenix has created the Save Our Space Campaign to educate the public about the importance of saving disabled parking spaces for those people who really need them. Recently, the City of Phoenix has more than doubled the fine for illegal use of designated accessible parking spaces. The fine for this violation is \$296/\$565.

The authority granted to Accessibility Compliance Volunteers is limited to non-law- enforcement functions. ACE volunteers will not engage in any activities that would place them in the role of a sworn law enforcement officer, and/or subject them to unreasonable and unnecessary hazards.

#### **MOTORIST ASSIST PROGRAM**

The Motorist Assist aide is a volunteer who has committed to serve a minimum of four hours each week to assist members of the community and the Phoenix Police Department. Serving as a uniformed civilian, the volunteer assists motorists who have encountered vehicular problems while using city streets. Assistance provided may include, but is not limited to, pushing vehicles; starting vehicles; opening vehicle doors; providing fuel, air, or water; assisting with changing a tire/s; arranging transportation; or other assistance reasonably required to aid the temporarily stranded motorist.

Volunteers also work closely with sworn police personnel and may be called upon to assist at vehicular accident scenes for traffic control or other duties. In addition, the volunteer may be requested to assist at special events. The philosophy of the Motorist Assist Program is service as opposed to enforcement. The authority granted to Motorist Assist aides is limited to non-law-enforcement functions. Motorist assist aides will not engage in any activities that would place them in the role of a sworn law enforcement officer, and/or subject them to unreasonable hazards.

#### STRENGTHENING ANIMAL CRUELTY LAWS

At a recent press conference, County Attorney Rachel Mitchell announced her support of two bills that will give law enforcement and prosecutors the tools they need to hold animal abusers accountable.



Senate Bill 1234 outlines what qualifies as appropriate food, water, and shelter for pets.

- Food that is appropriate for the species, consumption and given daily
- Water that is suitable for drinking
- Shelter that is accessible, structurally sound, sized to allow the dog to stand, turn, lie down, and maintain normal body temperature

Senate Bill 1412 includes animal cruelty to the list of offenses that may qualify as domestic violence.

Why it matters: Animal abuse is often an indicator that other violent criminal activity may be taking place in a household such as assault, domestic violence, and child abuse.

What's Next: County Attorney Mitchell recently spoke in support of these bills at a legislative committee. The proposed bills are now moving through the legislative process.



## **Board Approves Funding for Independent Review of Elections**

Wednesday, Feb. 26, 2025 (Phoenix, AZ) -Today, the Maricopa County Board of Supervisors approved funding for an independent outside review of election administration and technology.





"Maricopa County believes government should be accountable and transparent," said Chairman Thomas Galvin, District 2. "In my Chairman's speech, I promised an independent review of Maricopa County election processes and procedures. That work starts today with Board approval of funding to our Internal Audit Department for a comprehensive review on key aspects of election administration in Maricopa County. We welcome the opportunity to improve!"

"We are united in our belief that Maricopa County administers free and fair elections, said Vice Chair Kate Brophy McGee, District 3. "However, I believe this comprehensive review will give voters more confidence and ultimately strengthen American democracy."

Included in the review is a technology audit, similar to what was done in 2021, to make sure election equipment was not tampered with during the 2024 election cycle and cannot connect to the internet.

The process will be overseen by the Maricopa County Internal Audit Department and will be free of Board and staff influence. Any company that believes it is qualified and can perform the work will have an opportunity to bid for the project.

"Maricopa County deserves best-in-class elections. Today, a united Board took action to invest in a comprehensive, independent review of election processes and procedures because we recognize the value of outside expertise," said Supervisor Mark Stewart, District 1. "I hear it every day from friends and neighbors—they want a government that operates in plain view, that's accountable to the people, and that jumps at the opportunity to get better. That's what this comprehensive review is about, and I'm excited that we are moving forward with it on behalf of voters."

"It's not enough to say 'trust us.' Good government demands transparency and thoroughness in making sure taxpayers are getting what they paid for: in this case, fair and efficient elections," said Supervisor Debbie Lesko, District 4. "I have been calling for an independent audit of elections since taking office, and I'm pleased that we are taking this important step to improve processes and enhance voter trust."

"The last in-depth review of our tabulation equipment was completed in 2021 and the County has replaced and upgraded many components of our tabulation equipment. Since we have an off cycle with only smaller jurisdictional audits, now is the right time to perform another in-depth review," said Supervisor Steve Gallardo, District 5.

It is expected that the technology audit will be finished in summer 2025 and parts of the comprehensive review will be completed in fall 2025. The County Board of Supervisors will release those findings in a public setting, without edits, revisions or changes. The auditors' work will be theirs and theirs alone.

#### **COMMUNITY CATS**

#### Helpful Information and Tips for the Community

A Community Cat is a catch-all term often used to describe any outdoor cat that may appear to not have an owner. Feral cats, which are under- or not socialized, fall under this umbrella, as do free-roaming, friendly cats.

In Maricopa County, cats are not subject to the same licensing and leash laws as dogs. Because of this, Maricopa County Animal Care and Control (MCACC) cannot pick up stray or feral cats or take action against those feeding cats in their neighborhoods.

Many times, members of the community act as colony managers to ensure that a feral cat colony is a managed colony. Cats in these communities are usually fed, watered, vaccinated, spayed, or neutered, and monitored for overall health. Other times, the cats are self-reliant and can survive in the neighborhood on their own, without any direct assistance.

TNR (Trap-Neuter-Return) is a long-proven and effective method for humanely addressing community cat populations across the world.

**Trap**: The cats are humanely trapped and brought to a clinic.

**Neuter**: The cats are fixed, vaccinated, and their left ear is "tipped" to indicate they have been fixed.

Return: The fixed cats are safely returned to their colony.

#### Benefits of TNR

- Cats become better neighbors as it reduces or eliminates unwanted mating behaviors (e.g., yowling, fighting, spraying).
- Cats will be healthier when treated with this humane solution and typically are less likely to wander from their food source.
- Halts the breeding cycle which allows community cat populations to stabilize and eventually decline.
- · Protects and respects cats' lives

#### HOW TO HELP KEEP COMMUNITY CATS AWAY FROM YOUR PROPERTY

- Remove or secure all potential food and water sources from your property, including dog food.
- Spray concentrated orange juice or hang orange or lemon peels in areas where cats are spraying cats do not like the citrus scent.
- Keep all trash and recycle bins tightly closed as cats are considered opportunistic feeders/hunters.
- Use a motion-detecting device that turns on a sprinkler or bright light in response to motion on your property, such as ScareCrow™.
- Remove or secure potential shelter areas secure access under houses, sheds, decks, porches, and buildings with wire fencing.
- Use plastic carpet runners spike-side up and covered lightly in soil to prevent cats from digging in your garden.
- Keep landscaping trimmed to avoid creating hiding/nesting spots.
- Spread dried wild animal manure in the areas you notice feral cats in your yard; wild animal urine also may work to deter the cats.
- There are also many commercial cat repellants (chemical and non-chemical options) available in garden stores, pet shops, and online.

## CONTACTING ADOT FRAUD HOTLINE SOLVES CUSTOMER'S TITLE PROBLEM

## ADOT detectives trained to investigate vehicle and driver license fraud

Contacting ADOT's Fraud Hotline helped a customer register a recently purchased vehicle and drive it legally in Arizona after several months of working with the dealership to receive the title.

ADOT received the complaint on Oct. 29, about the purchase of a vehicle in February 2024 through a used car dealership in the Valley. The complaint alleged the dealership was unable to provide a title, and the only option provided by the dealer was for the customer to obtain a bonded title for the vehicle

After the constituent contacted the <u>ADOT Fraud Hotline</u>, detectives with ADOT's Office of Inspector General looked into the complaint and found the dealership unlawfully advertised and sold the vehicle without having possession of the title according to state law. Dealers who violate state law and MVD licensing guidelines are subject to enforcement actions which may include the issuance of cease and desist orders, criminal citations and the cancellation of dealer licenses.

Detectives were then able to get a special lien release affidavit completed for the vehicle after verifying previous transaction information indicating the vehicle was traded to the dealer with an out-of-state title and a documented lienholder attached for a company that was no longer in business. On Dec. 9, detectives provided MVD with findings of their investigation, and an Arizona title was issued for the vehicle. They also issued a cease and desist warning to the dealership and required them to take corrective action so they do not violate state law again.

"It is a wonderful feeling to not only address the violation and potentially prevent similar infractions, but to also help a constituent resolve their title issue and get them safely back on the road," said Lieutenant Jason Henderson with ADOT's Office of Inspector General. "We encourage anyone who suspects fraudulent activity against their driver license or ID card, vehicle registration or title to report it immediately."

ADOT's 24-hour Fraud Hotline is available to those who suspect fraud or criminal activity involving driver licenses, title and registration. Please call 877.712.2370, email <u>fraud@azdot.gov</u> or file a report at <u>azdot.gov/incident-report</u>.

Detectives with ADOT's Office of Inspector General, which is part of the Enforcement and Compliance Division, also investigate fraud involving driver licenses, VIN inspections, as well as licensed and unlicensed vehicle dealerships. They also support investigations by state, local and federal law enforcement

## NUMBER OF ARIZONA TRAVEL IDS NOW EXCEEDS 2.5 MILLION

## May deadline is nearing if you wish to use state credential for travel

With less than two months remaining before the federal deadline for domestic airline travelers to have a federally compliant ID, the Arizona Department of Transportation Motor Vehicle Division has issued more than 2.5 million Arizona Travel ID cards.

May 7 will be here quickly. So join the 2,509,977 – and counting – Arizonans who have already upgraded to the Arizona Travel ID.

As of the federal deadline, you will need a compliant credential like a valid U.S. passport or the Arizona Travel ID to get past Transportation Security Administration checkpoints at U.S. airports. Without the Arizona Travel ID or other form of compliant identification, fliers risk missing an airline flight because the standard driver license may not be accepted.

This federally compliant credential is distinguished by a star in the upper right corner and is available to Arizona residents as a driver license or identification card.

To get an Arizona Travel ID, federal standards require the following:

- Proof of identity: a birth certificate or U.S. passport
- Social Security number: just the number, not the card
- Two documents proving Arizona residency, such as rental or bank statements, credit card or cellphone bills in your name with your current Arizona address

You can walk into an office for this service, but we suggest scheduling an appointment at azmvdnow.gov. Even if you haven't activated your AZ MVD NOW account, you can still schedule an appointment. You can also go to

any <u>authorized third party location</u>, which may be open later and on Saturdays.

# PENDING FEDERAL CHANGE AFFECTS ALTERNATIVE FUEL VEHICLES IN HOV LANES

## AFVs with one occupant would no longer have access effective Sept. 30

PHOENIX – The Federal Highway Administration has informed Arizona that, barring a federal change, electric vehicles and other currently eligible alternative fuel vehicles with only a single occupant will no longer have access to high-occupancy vehicle lanes during restricted times as of Sept. 30, 2025.

Based on this notice, ADOT has established a website at <u>azdot.gov/HOVRule</u> to help alternative fuel vehicle owners and others

prepare for the change. It explains what's scheduled to happen upon expiration of a provision of federal code that allows the access.

HOV lanes are available on freeways in the Phoenix metropolitan area. A provision of federal code (23 USC 166b) currently allows Arizona to exempt alternative fuel vehicles from HOV lane restrictions that otherwise require two or more occupants except in the case of motorcycles. In addition to electric vehicles, currently eligible alternative fuel vehicles include those operating solely on natural gas, propane, hydrogen, coal-derived liquid fuels, fuels derived from biological materials, methanol, or denatured alcohol or other alcohols.

The decision on whether to allow this provision in federal code to lapse lies with Congress. Even though this is a federal matter, ADOT is sharing early word because the outcome affects travelers in the Phoenix area, owners and prospective buyers of alternative fuel vehicles, and businesses selling and servicing alternative fuel vehicles. ADOT's Motor Vehicle Division also is sharing this information with auto dealers so they are aware and can pass the information on to customers, and with drivers who own a vehicle with an Alternative Fuel or Energy Efficient license plate and will no longer qualify to use the HOV lane with only the driver. ADOT offers a resource at <a href="mailto:azdot.gov/HOV">azdot.gov/HOV</a> explaining what HOV lanes are for, who can use them and other topics. It also answers many common questions about HOV lanes.

People experiencing a mental health crisis have a new way to reach out for help in the U.S. They can simply call or text the numbers 9-8-

Modeled after 911, the new three-digit 988 Suicide & Crisis Lifeline is designed to be a memorable and quick number that connects people who are suicidal or in any other mental health crisis to a trained mental health professional.

"If you are willing to turn to someone in your moment of crisis, 988 will be there," said Xavier Becerra, the secretary of the federal Department of Health and Human Services, at a recent press briefing. "988 won't be a busy signal, and 988 won't put you on hold. You will get help."

The primary goal of the new number is to make it easier for people to call for help. Lawmakers and mental health advocates also see this launch as an opportunity to transform the mental health care system and make care easily accessible everywhere in the United States. The Biden administration has invested more than \$400 million in beefing up crisis centers and other mental health services to support the 988 system.

These signs may mean someone is at risk for suicide. Risk is greater if a behavior is new or has increased and if it seems related to a painful event, loss, or change.
