### WELCOME NEW BLACK MOUNTAIN POLICE PRECINCT COMMANDER CHRISTINE CALDERON TANGUMA!

Hello everyone,  
My name is Christine Calderon Tanguma, and I am excited to be part of the Black Mountain precinct community. I was born and raised in Glendale, Arizona, and I am a proud mother of four adult children,

happily married to my husband, Michael Tanguma. In my free time, I cherish moments spent with family and friends, and my husband and I enjoy traveling and playing golf together.

My professional journey in law enforcement began in 1998 when I joined the South Mountain Precinct as an officer. Over the years, I have had the privilege of serving in various roles, including patrol, school resource officer, and field training officer. I transitioned to the Violent Crimes Bureau, where I worked as an Assaults Detective and later as a Homicide Detective. During my time there, I was honored to receive several awards, including a Medal of Lifesaving, a Medal of Merit, and the Police Chief's Unit Award.



I look forward to connecting with all of you and working together to foster a safe and vibrant community.





## PHOENIX PD APP

The Phoenix Police Department has a mobile APP, bringing a variety of resources and information to one place. Users can use the app to access online reporting, crime statistics, precinct locations, phone numbers, career opportunities, virtual block watch, victims' rights information, and more. Users can also turn on notifications from the precinct they live in to receive news updates and information on events in their area.

The APP is now available both in the Apple Store for iOS and in the Google Play Store for Android.

**Report graffiti on the Phoenix PD app!** Graffiti can now be reported on the Police Department APP released in January 2021. Studies show that if graffiti is removed within 24 hours, there is a 90% likelihood that the graffiti will not use the app to have it removed! #GraffitiFreePHX

## WHEN YOU CALL 911 - KNOW THE 10 W'S

- **What** - is your location? GIVE EXACT LOCATION
- **What** - happened? WHAT TYPE OF CRIME?
- **When** - did this happen?

*These questions will determine if it is a priority call. Give as much of this necessary information as you can.*

- **Was** - anyone hurt?
- **Weapons** - are there weapons involved?
- **What** - manner did they leave or arrive – foot, vehicle, bicycle...?
- **Who** - did it? –Suspect description
- **Where** - did the suspect go? – What direction
- **What** - did the suspect obtain? – type and amount
- **Who** - is calling? – Give your name location and phone number (You can remain anonymous. If you do give your name, the info is redacted from the public record access.)

**TEXT 9-1-1** "Call if you can. Text if you can't." After months of collaboration between numerous public agencies and advocates for the disability community (or advocates for the disabled) if you are in imminent danger and are unable to talk to a 911 operator, you now have for the first time in Phoenix the ability to text to 9-1-1.



Hello, Phoenix!

June was off to an exciting start. We just wrapped up another incredible **602 Day**, and this weekend we're celebrating the launch of the South-Central Extension/Downtown Hub light rail line— a major milestone for public transit in our city.

As temperatures rise, our heat relief network is up and running, with resources in place across Phoenix to help residents stay safe.

In this newsletter, you'll find a look back at 602 Day, highlights from this week's City Council meeting, details on the upcoming light rail opening, and the latest on how we're helping the community stay cool this summer.



Phoenix came out strong for 602 Day— a citywide celebration named for our original area code, which still proudly represents the heart of Phoenix. I was grateful to celebrate it with so many of you. This year, I kicked things off at the Phoenix Zoo where thousands of families came together for early morning fun and \$6.02 admission. Welcoming visitors at 6:02 a.m. was a reminder of just how much this day means to our community— more than 18,000 people came out to celebrate!

Throughout the day, I had the chance to connect with residents and small business owners across the city. I stopped by AZ Pops for a strawberry balsamic popsicle and spoke with the owner about how City of Phoenix programs helped her weather the challenges of COVID. Stories like hers show the strength and resilience behind so many of our local businesses.

I also celebrated youth athletes at the PHX Arena with the Phoenix Suns/ Mercury Foundation and capped off the evening with Phoenix-themed trivia at McKenzie's Midtown Tavern.



## District 1 Community Breakfast/Dinner with Vice Mayor Ann O'Brien

### Message from Vice Mayor Ann O'Brien

We made history in District 1 at Deer Valley Park on June 21<sup>st</sup>. For the first time, the City of Phoenix featured a drone light show, replacing traditional fireworks with a high-tech, eco-friendly display of synchronized lights choreographed to music. For years, I've championed the use of drone technology to support public safety in our parks, as well as in our police and fire departments, and I worked with the Parks Department to bring the same innovation to our annual celebration. Unlike fireworks, drone shows produce no smoke, no debris, and no ear-splitting booms—making them a welcome option for families with young children, veterans, pets, and wildlife. They're also highly customizable and our historic show will feature Phoenix-themed images and logos. The drone light show begins at 8:45 pm, but the fun starts earlier at 6 pm, with live entertainment, food trucks, and inflatables for the kids. I hope you'll join me and celebrate the spirit of Independence Day with community!

I was honored to speak at a Juneteenth celebration organized by the Central Arizona Chapter of the National Forum for Black Public Administrators. June 19 marks the day that union troops arrived in Texas in 1865 to enforce the Emancipation Proclamation, marking the end of slavery, which had been ordered more than two years earlier. At City Hall, we reflected on the historical significance, celebrated achievements, and enjoyed food trucks and local small business owners displaying their products. I couldn't choose between sweet or spicy and ended up getting strawberry shortcake, chocolate cake, and a hot spice mix! As Vice Mayor, it's my privilege to support Juneteenth events, along with other events organized by our nine employee groups which also include, City of Phoenix Employees for Christ; Disabled Employees, Allies, and Leaders; Native American Network; Toastmasters Club; Phoenix Asian League; Phoenix Hispanic Network; Phoenix LGBTQ Employee Alliance; Women in Leadership. I'm proud of Phoenix's diversity!

I hope you were able to watch or listen to the public forum with our three finalists for Police Chief. In alphabetical order, the finalists are Malik Aziz, Matthew Giordano and Mirtha V. Ramos. You can find the public forum [via this link](#) from the city's YouTube channel. After the public forum, I had the opportunity to hear from the candidates, along with my council colleagues. City Manager Jeff Barton will take all feedback into consideration before making his final decision, which is expected in July.

Our last community meeting before summer break will be a special one because we're joining forces with Councilwoman Debra Stark. She represents District 3, which borders District 1 in some areas. By holding a joint community meeting, we hope to reach even more people. We'll hear from the Fire Department who will talk lockboxes and heat safety! The meeting will take place at the Doubletree Hilton North Phoenix from 7:30 – 9 a.m. on Friday, June 27.



**Do you know what your child is doing online?**

While you're in the dark about your child's online activity, cyber predators are watching closely.

Cyber predators are master manipulators who target children on gaming and social media platforms. Here's what you need to know:

- They start conversations with multiple children, trying to find and target the ones who are most vulnerable.
- They use tactics to groom and quickly convince kids to share inappropriate photos or videos.

Then, they blackmail children into sending money or more content. As parents, you are the first line of defense, but you are not alone in this fight. [County Attorney Rachel Mitchell recently launched a new educational awareness effort called Cyber Predators, Real Risks](#) to help parents protect their children online.

This new tool offers vital information and videos, including:

- Tactics predators use to target children
- The 'red flags' of online grooming
- How you can be your child's most trusted adult
- The top 3 steps you MUST take to report online abuse

The bottom line: If your kids are online - whether they're on the phone or on a computer - predators are watching and trying to make them their next victim. Take 5 minutes today to learn about this issue and talk about it with your children.

Small conversations can make a BIG difference.

**Permissible & Prohibited Fireworks Use and Sales**

**Know the Law: Fireworks Use & Sales**

This serves only as a reference guide to aid in understanding items that may or may not be permissible under Arizona state law at the time of publishing. Fireworks sales and use are only allowed during the dates specified by state law and are strictly prohibited at all other times under the Phoenix Fire Code. For updates on sales and use dates, as well as allowed and prohibited items, please refer to the State Law.

**Legal Sale Dates**

- ★ April 25 - May 6
- ★ May 20 - July 6
- ★ December 10 - January 3
- ★ Two days before the start of Diwali through the third day of Diwali each year.

**Permissible Use**

- ★ Sparklers (Ground and Wire Stick)
- ★ Smoke Devices
- ★ Spinners & Fountains (Includes Ground Spinners & Sparkling Wheels)

**Legal Use Dates**

- ★ May 4 - May 6
- ★ June 24 - July 6
- ★ December 26 - January 4
- ★ Second and third days of Diwali each year.

**Prohibited Use**

- ★ Rockets & Aerial Fireworks (Sky Rockets, Bottle rockets, aerial shells)
- ★ Explosive devices
- ★ Anything that rises into the air and explodes is prohibited.





### SILENT WITNESS

with Sgt. Jason Bloom



Great presentation by Sgt. Bloom on Silent Witness. He talked about this 501 C3 entity that works with the Police Department. Every Saturday morning there is a live Fox 10 Silent Witness show that talks about ongoing crimes that need the public's help to solve. You can call in to 480-WITNESS, go online or use the phone app. This program is totally anonymous. The call goes to a center in Texas, not to the police department, so there is no way to know what number called the tip in. It gives someone the ability to give information without any retribution. There is a monetary award for felonies that are not homicides or fatal accidents that lead to an

arrest. There are some people on the street who are informants and live off this money. This program has been around since 1979, and it has paid out \$3,000,000.00. It is completely funded by donors. Some have benefited by the program or have an ongoing investigation and contribute to the award to help solve the case. There have been over 10,000 arrests and \$31,000,000.00 worth of guns and drugs confiscated. The informant has a number and is notified that they have been awarded money with Silent Witness Tip #ABC, and they can pick up the award at Bank of America. They do have to endorse a check, but it is not available to anyone. There have been laws passed that protect the informants and the information cannot be accessed by warrants of any kind.

### BLIGHT AND ZONING LAWS

**STRUCTURES:** The maintenance of a home is the responsibility of the property owner. Any wood, siding, shingles, roof covering, railings, fences, walls, ceilings, porches, doors, windows, screens, and other exterior parts of any structure on the property must be maintained in weather tight, sound condition and in good repair. The property owner is responsible for making sure there are no doors or windows left open and not secure to the outside. **FOR HELP** call the Preservation Division of the Neighborhood Services Dept. at 602-495-0700 to see if you qualify for a free Grant!

**OUTDOOR STORAGE:** All outside storage that can be seen from the street should be inside sheds or cabinets. Items should not be set in car ports in view of the street. Please use enclosed areas or backyards.

**JUNK, TRASH & DEBRIS:** Junk, trash and debris cannot be left in the yard or car port and must be properly disposed of. This includes junk auto parts, appliances, furniture, building and/or landscaping material, trash such as discarded papers, cardboard, plastics, etc. including tree trimmings and fallen limbs or any other items that appear to have been discarded. The only exception is during the dates you can request four times a year for Bulk Trash pickup.

**PARKING:** Parking is only permitted for passenger cars and motorcycles on residential streets, on driveways or in garages. A driveway or parking area must be constructed with an approved dust free parking surface. The stone must be 1/4 - 3/4 in size with a permanent border holding it in. 1/4 minus size stone is not allowed for parking. There are limits to the amount of front yard area that can be used for parking. Only 50% of the front yard may be converted to driveway or dust free parking.

**GRASS AND WEEDS:** Grass and weeds must not be allowed to grow over 6 inches high due to fire hazard, allowing the weeds to go to seed and spreading throughout the neighborhood and insect infestation.

**ELIMINATE GRAFFITI:** Keeping the neighborhood graffiti free is something we can all do. If there is graffiti on your property, please remove it as soon as possible. The Graffiti Busters Program provides paint, supplies and training to assist groups with eliminating graffiti. The City will also remove the graffiti from private property with written permission from the property owner. Call 602-495-7014.

# CRIME TIPS:

## HELP PREVENT ELDER FINANCIAL EXPLOITATION

The impact of elder financial abuse is profound. While it can come from known perpetrators like caregivers or family members, scams carried out by strangers are also a major threat. In fact, the [Federal Trade Commission](#) (FTC) estimated that fraud criminals stole as much as \$61.5 billion from adults age 60 and over in 2023 alone.

World Elder Abuse Awareness Day was June 15—a timely reminder that we can take steps to help [prevent the financial exploitation of older adults](#). Here's how.

### Protect Financial Accounts

While it may seem counterintuitive, it's actually safer to bank online. Not only does it give the account holder 24/7 access to review activity, but it also allows for real-time transaction alerts to monitor for suspicious activity. The other benefit is that a criminal can't use illicitly acquired sensitive information to set up online access to the accounts.

Add a trusted contact to financial accounts. This person has no access to accounts or information about them; they are the point of contact if the account holder cannot be reached.

### Monitor and Freeze Credit

Everyone, including older adults, should regularly check their credit reports for unauthorized activity. You can request [free credit reports](#) from each of the three credit reporting agencies—Equifax, Experian and TransUnion—at [annualcreditreport.com](#). You should also consider placing a [credit freeze](#) with each of the reporting agencies; this stops someone from using stolen credentials to open financial accounts.

### Block Unwanted Calls and Text Messages

Check with your phone carrier or a trusted third party for free or low-cost call and text blocking services to keep the illegal robocalls and texts at bay.

Add all your numbers to the FTC's Do Not Call Registry ([donotcall.gov](#)). It won't stop scammers, but it will cut down on legitimate telemarketing calls and texts.

## A NEW WAY TO STAY SAFE FROM SCAMS: PAUSE. REFLECT. PROTECT.

Keeping up with all of the latest scams and the thousands of red flags associated with them is exhausting. While there will always be a need to understand the specific scams and their red flags, the Fraud Watch Network has done extensive research with people from a range of disciplines around the world to produce a [higher-level message](#) that's a lot easier to remember.

### The Trigger

First, we need to define a "trigger" to signal when fraud comes knocking. Think of learning in grade school to "stop, drop and roll" in the event of a fire. It's the same idea, but fire is a mighty strong trigger. We've defined three elements common to most scams. Once we understand them as a "trigger" for the desired response, we can educate about that desired response. We call it the "Active Pause."

### The Active Pause

This is no ordinary pause. Rather, it is an intentional act to step back and reflect on what you might know about the situation confronting you. For example, is your grandson calling you late at night (1. *unexpected contact*), saying he's in jail across the country and needs your help (2. *surge of emotion: I must help him!*)? Does he say he needs you to send money right away

(3. *urgency*)? These are the three triggers to elicit an "Active Pause."

In this scenario, you might consider whether it makes sense that your grandson is calling you and not his parents, or that he's in jail 2,000 miles away when you just had dinner with him yesterday. This intentional step back allows your brain to move out of emotion and engage with logic. You use the Active Pause to end communication and call your grandson directly. He was at home and asleep. You protect yourself and your money from a fraud attempt.

The Active Pause is taught across high-pressure fields like aviation, emergency medicine and military operations. Now we can apply it to the high-pressure situation of a fraud attempt.

### The Safe Response: Pause. Reflect. Protect.

Taking the pause when triggered can help us regain control of the situation. It gives us time to reflect on what we may know about the scenario and to determine if it makes sense. When it doesn't make sense, you protect yourself by ending communication.

All the red flags are important to understand, but when narrowed to just three, we think it can stop many scams in their tracks. Know the triggers, know the safe response: Pause. Reflect. Protect.

Knowledge gives you power over scams. ## BEWARE OF NEW TEXT SCAM: ADOT ISN'T AFTER YOU FOR UNPAID TICKETS

### Fraudsters are trying to get your personal information and money

PHOENIX — That isn't the Arizona Department of Transportation pinging your phone to demand payment for "an outstanding traffic ticket."

Some Arizonans are understandably contacting ADOT about a scam text that begins "Arizona Department of Transportation Final Enforcement Notice." It promises all manner of bad things should you fail to act quickly. The threats include suspending your vehicle registration and driving privileges, harming your credit and possibly hitting you with prosecution.

It's yet another spam scam trying to get your personal information and money. Make sure not to click on any links in this or any other suspect text, as the goal is stealing your personal information and money. You should delete the text and rest easy.

For the record: ADOT is not involved in collecting for unpaid traffic tickets. We will not text you seeking payment for anything. One obvious tell in this text is its use of "DMV" when ADOT in fact has an "MVD," short for Motor Vehicle Division.

As was the case in recent months with [scam texts alleging unpaid tolls](#), this is another version of what the Federal Bureau of Investigation refers to as "smishing." That's a social engineering attack in which cybercriminals try to trick people into sending money by stoking fear and demanding urgent action. Look closely and you'll notice that this text, like so many other scam texts, comes from another country.

Arizona Department of Transportation Final Notice: Enforcement Begins June 13th. Our records show that as of today, you still have an outstanding traffic ticket. Per Arizona Administrative Code 560-10-22, if you do not pay by June 12, 2025, we will take the following actions:

## ACCESSIBILITY COMPLIANCE ENFORCEMENT PROGRAM

The Accessibility Compliance Enforcement aide is a volunteer who has committed to serve a minimum of four hours each week to assist the community and the Phoenix Police Department. Volunteers patrol the city of Phoenix, writing disabled parking citations. The mission of the ACE Program is to provide safe and accessible parking spaces for the disabled community through enforcement and education. Directed patrol is accomplished by responding to locations identified through the disabled parking violation hotline, **602-534-SPACE**.

The City of Phoenix has created the Save Our Space Campaign to educate the public about the importance of saving disabled parking spaces for those people who really need them. Recently, the City of Phoenix has more than doubled the fine for illegal use of designated accessible parking spaces. The fine for this violation is \$296/\$565.

The authority granted to the Accessibility Compliance Volunteers is limited to non-law-enforcement functions. ACE volunteers will not engage in any activities that would place them in the role of a sworn law enforcement officer, and/or subject them to unreasonable and unnecessary hazards.

## MOTORIST ASSIST PROGRAM

The Motorist Assist aide is a volunteer who has committed to serve a minimum of four hours each week to assist members of the community and the Phoenix Police Department. Serving as a uniformed civilian, the volunteer assists motorists who have encountered vehicular problems while using city streets. Assistance provided may include, but is not limited to, pushing vehicles; starting vehicles; opening vehicle doors; providing fuel, air, or water; assisting with changing a tire/s; arranging transportation; or other assistance reasonably required to aid the temporarily stranded motorist.

Volunteers also work closely with sworn police personnel and may be called upon to assist at vehicular accident scenes for traffic control or other duties. In addition, the volunteer may be requested to assist at special events. The philosophy of the Motorist Assist Program is service as opposed to enforcement. The authority granted to Motorist Assist aides is limited to non-law-enforcement functions. Motorist assist aides will not engage in any activities that would place them in the role of a sworn law enforcement officer, and/or subject them to unreasonable hazards.

## SWIMMING POOL SAFETY TIPS

Pool season is here, so take these steps to keep your park visitors safe this summer:

1. Remove toys and floats from the pool immediately after use; they can attract children.
2. Always assign a designated watcher for children in and around the pool.
3. Make sure there is a self-closing gate around your pool, and always keep it maintained.
4. Gates and fences around the pool area should be at least 4 feet high.
5. All pools should have regulation drain covers; discuss local regulations with your pool maintenance provider.
6. Keep a fully stocked first aid kit and rescue equipment near your pool area.
7. Never swim alone.
8. Learn to perform CPR on both adults and children.
9. Post pool signs in prominent locations and make sure they are easily seen and read.
10. Inspect pool areas for slipping hazards and install safety tape as a precaution.

## THE CITY OF PHOENIX CITYWIDE LOCKBOX PROGRAM



This program allows firefighters to gain entry to your home in case of emergency without causing any damage to your residence. This is done by utilizing a key that you provide in a secure lockbox attached to your entryway. This program not only provides free lockboxes to those vulnerable Phoenix residents; it also allows those who already have their own

lockbox in place to register their lockbox code with the fire department.

Free lockboxes are donated by the Phoenix Area Association of Realtors and are distributed on a first come, first served basis to vulnerable Phoenix residents who are 55+, have special needs or mobility issues.

Your information and the code to the lockbox is provided only to firefighters in the event there is an emergency call to your home. You will need to provide the appropriate key or keys to put in the lockbox at the time of the delivery.

## FENTANYL AWARENESS & OVERDOSE PREVENTION

**Fentanyl is a national public health crisis, and Maricopa County is at the frontline.**

- In 2023, DEA (Drug Enforcement Agency) seized more than 79.5 million fentanyl-laced fake pills and nearly 12,000 pounds of fentanyl powder. The 2023 seizures are equivalent to more than 376.7 million lethal doses of fentanyl. So far this year, fentanyl seizures represent of 93.7 million deadly doses.
- Our office has seen fentanyl cases submitted for prosecution jump 700% from 2020 to 2021.
- Since 2015, Maricopa County has experienced a 5,000% increase in fentanyl-related deaths.
- Among teens, overdose deaths linked to fentanyl have doubled since 2019.

**It's time to face the problem head on.**

1. Start by listening, ask your children what they know
2. Answer their questions truthfully
3. Let them know you are there to help



## ADOT DETECTIVES ASSIST IN SOLVING STOLEN IDENTITY CASE

### Passport and driver license fraud results in arrest and additional charges

Arizona Department of Transportation detectives' assistance resulted in several additional charges against a man accused of using the identity of a deceased child.

ADOT's Office of Inspector General (OIG) was contacted by the Social Security Administration in June of last year for help on a case involving Enrique Diaz-Vazquez, who assumed the stolen identity in 1986 and used it to obtain a Social Security number and Arizona driver license.

OIG detectives located an Arizona driver license under the assumed name and went to the listed address on file. Detectives made contact with a subject at the residence and were able to identify him as Diaz-Vazquez using current Motor Vehicle Division and passport photos along with facial-recognition technology.

On March 7, OIG detectives, along with the Social Security Administration personnel, arrested Diaz-Vazquez in Tucson while he was picking up a newly requested passport.

Subsequent to his arrest, Diaz-Vazquez admitted to obtaining the identity after wandering through a cemetery and finding the grave of a baby that would have been his age. Diaz-Vazquez said he then used the identity to obtain a Social Security card and an Arizona driver license.

Diaz-Vazquez was transported to a federal holding facility in Florence and will be facing several charges including passport fraud, fraudulent statements on an application and misconduct involving weapons for being prohibited possessor. Additional state charges include identity theft and forgery.

"ADOT is very pleased to have assisted the SSA in successfully bringing this suspect to justice," said Lt. Jason Henderson with ADOT's Office of Inspector General. "We encourage anyone who suspects fraudulent activity against their driver license or ID card, vehicle registration or title to report it through the ADOT Fraud Hotline immediately."

ADOT's 24-hour Fraud Hotline is available to those who suspect fraud or criminal activity involving driver licenses, title and registration. Please call 877.712.2370, email [fraud@azdot.gov](mailto:fraud@azdot.gov) or file a report at [azdot.gov/incident-report](http://azdot.gov/incident-report).

Detectives with ADOT's Office of Inspector General, which is part of the Enforcement and Compliance Division, investigate fraud involving licensed and unlicensed vehicle dealerships, titles, odometers, driver licenses, VIN inspections, as well as VIN inspections. Additionally, they also support investigations by state, local and federal law enforcement agencies.



## ADOT MARKS NATIONAL SECURE YOUR LOAD DAY – JUNE 6<sup>th</sup>

### ADOT calls on drivers to tie down, cover loads

PHOENIX – A tipped-over couch left behind in the right lane. A mangled mattress with twisted metal springs and shredded cloth blocking the middle lanes. A smashed ladder splintered across the highway.

These hazardous scenarios are just a fraction of what Arizona Department of Transportation crews and motorists see every day. And they're all caused by unsecured loads.

So, on National Secure Your Load Day, June 6, ADOT wants to remind drivers to take proper steps and secure their loads to prevent dangerous debris from ending up on Arizona's highways.

Items such as couches, landscaping trimmings, ladders, furniture and appliances that fall off or out of vehicles traffic are a danger to drivers that can damage vehicles and, more importantly, cause crashes. Not only that, it puts ADOT crews and Arizona Department of Public Safety troopers, who have to go out into traffic on busy freeways to remove the debris, at risk.

ADOT's Incident Response Unit, sponsored by GEICO, responded to over 4,400 calls for debris in the metro Phoenix area in the past 12 months, with most of the calls being mattresses and tire debris.

"Each time a member of ADOT's Incident Response Unit stops traffic and goes out onto the highway to remove a washing machine or tire shreds, they're putting their lives on the line," IRU Program Manager Abraham Asmerly said. "We encourage all drivers to take a few extra minutes to properly secure their loads, helping to ensure their own safety and the safety of others on our highways."

Before you start your travel, do the following things to make sure your load is secured and stays in your vehicle or attached trailer.


- **Tie down your load:** Use ropes, bungee cords, netting or other straps when hauling items.
- **Cover your load:** Use a tarp to prevent items from flying out from a truck bed or trailer.
- **Ask yourself:** Would I feel safe if I were driving behind my vehicle? Would my load stay secure if I had to suddenly brake or if I hit a bump on the road?

On National Secure Your Load Day, ADOT will display a message on its overhead message signs encouraging drivers to secure their loads to help prevent crashes and litter on the highways. If you come across debris on the highway, treat it as the emergency that it is and call 911. That helps ensure that the debris is quickly and safely removed. Drivers should not attempt to stop and remove debris from travel lanes.

## FAQs

### Frequently Asked Questions

**Q: How long will it take for a Park Ranger to respond?**

A: Calls will be assessed by a Park Ranger who will prioritize them based on other calls and needs for all 167 City of Phoenix parks.

**Q: Will the public be able to talk to a Park Ranger?**

A: Park Rangers are typically occupied serving the parks. The 24/7 Code of Conduct Answering Service is the most efficient method to relay concerns to Park Rangers.

**Q: Will I receive a callback?**

A: A callback will not be made unless additional information is needed from the caller. We will record the caller's name and email address in case we have any follow-up questions.

**Q: What rules can Park Rangers enforce?**

A: Park Rangers have the authority to enforce the Parks Code of Conduct and any violations of Phoenix City Code they have observed, their jurisdiction is only within park boundaries.

**Q: What is the Parks Code of Conduct and what are the trespassing policies?**

People experiencing a mental health crisis have a new way to reach out for help in the U.S. They can simply call or text the numbers 9-8-8.

Modeled after 911, the new three-digit [988 Suicide & Crisis Lifeline](#) is designed to be a memorable and quick number that connects people who are suicidal or in any other mental health crisis to a trained mental health professional.

"If you are willing to turn to someone in your moment of crisis, 988 will be there," said Xavier Becerra, the secretary of the federal Department of Health and Human Services, at a recent press briefing. "988 won't be a busy signal, and 988 won't put you on hold. You will get help."

The primary goal of the new number is to make it easier for people to call for help. Lawmakers and mental health advocates also see this launch as an opportunity to transform the mental health care system and make care easily accessible everywhere in the United States. The Biden administration has invested more than \$400 million in beefing up crisis centers and other mental health services to support the 988 system.

**Suicide Warning Signs**

These signs may mean someone is at risk for suicide. Risk is greater if a behavior is new or has increased and if it seems related to a painful event, loss, or change.

♦ Talking about wanting to die or to kill oneself.	♦ Increasing the use of alcohol or drugs.
♦ Looking for a way to kill oneself, such as searching online or buying a gun.	♦ Acting anxious or agitated; behaving recklessly.
♦ Talking about feeling hopeless or having no reason to live.	♦ Sleeping too little or too much.
♦ Talking about feeling trapped or in unbearable pain.	♦ Withdrawing or feeling isolated.
♦ Talking about being a burden to others.	♦ Showing rage or talking about seeking revenge.
	♦ Displaying extreme mood swings.




