## RETIREMENT PLANS FROM CHIEF JERI WILLIAMS

MAY 3, 2022 9:30 AM



In October of 2016, I accepted the opportunity to become the Phoenix Police Chief. I was honored, humbled, and blessed when I was selected from a large field of worthy and qualified candidates. I still feel that way today. In some ways, I still feel like I'm just a kid from west Phoenix who was blessed to grow up and play in the major leagues in my own backyard.

Now, a few months away from completing my 6th year as Chief, it is time to look to the future. After much prayer and consideration and in consultation with my family and city leadership, I have decided to make a change. There is never a perfect time to transition but the time feels right for me now to step aside. Just like when I felt called to do this job, I also feel called right now to go in a new direction, allowing me the rare opportunity to prioritize family and explore future endeavors.

When I was hired, I shared with the community that one of my mantras was "To whom much is given, much is required." It means we must be responsible for all that we have. And that includes our beginnings and our endings and living not by circumstance but by choice.

As I make this choice to transition professionally, I am proud to have paved the way for this department to move forward in a positive manner while at the same time opening the door for the next Chief to enter. I hope they will enjoy the journey as much as I have while they lead the department through the next chapter in its history.

As I look back over my years as Phoenix Police Officer and Chief of Police, I am tremendously proud of several accomplishments. While that list is long, here are a few that stand out:

- Body Worn Cameras for our officers and the community
- Documenting every time an officer points a weapon at someone
- Implementing less lethal response to encounters which has prevented some officer-involved shootings
- Obtaining a new records management system
- Something as simple as getting cell phones for officers
- Standard processes like updating policies and procedures to mirror the changing expectations and demands of the community
- Being transparent by showing the public Critical Incident Videos in 14-days or less
- Becoming fully compliant with #8CAN'TWAIT
- And relationships: Through all the highs and lows (and there have been many!) I am proud of the relationships we've built and maintained with our community, employees and both legal and law enforcement peers throughout the county, state and country.

I hope you can understand why these accomplishments are special to me. However, when all is said and done, the most rewarding work of all has been the honor and privilege to serve as the leader of the most amazing group of men and women, sworn and non-sworn, in all of law enforcement. So many of them have demonstrated integrity and courage with a job that has changed considerably and a work environment that is filled with challenging personal and political dynamics. So many of these folks, these cops, dispatchers, crime lab employees and many others still find the way to answer the call, do good police work and be transparent, trustworthy and accountable to each other and the community.

I am grateful to our city leaders, including Mayor and Council and City management, who have supported me and our department these last several years. Thank you for trusting me with confidence to keep our city safe. A personal note of gratitude for my three men: Cody, Alan and Big Cody. I am blessed by them and eternally grateful to have their love and support. So what's next? My last day will be sometime this summer. I know there is going to be speculation and questions about where I am going and what I'm going to do next. All of that comes later. For the time being, there is nothing more important to me than working with City management as we develop a transition plan.

Finally, here's what I want you to know: I've been a cop for 33 years. I still feel extremely proud and honored to put a badge and uniform on every day as a symbol of the oath I took in 1989 to serve and protect our community. It has been my extreme honor to serve this city and department as your Phoenix Police Chief.

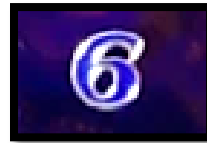

## EMERGENCY RESPONSE (SCHOOLS)

Hello Black Mountain Community Alliance. I was recently asked by members of our community to explain why schools are placed into lockdowns. Lockdowns, shelter in place, lockouts, hold in place and evacuate are emergency response positions that schools are expected to take when there are safety concerns in or near school buildings. Certain police calls that are in close proximity to schools often generate a school lockdown. The decision to place a school into lockdown can be initiated by school administration, school personnel and/or police. These lockdowns are managed by the school district and school which is affected. The decision to release the school from a lockdown is coordinated between the school administrators and police personnel. Each school district conducts their Emergency Response Procedures differently and will generally publish the information on their website.

Per Arizona Department of Education (ADE) Emergency Operations Plan (EOP) Minimum Requirements, ADE Emergency Preparedness Minimum Requirements Arizona Revised Statute 15-341(A)(31) requires each school site to have an emergency operations plan that meets the minimum state requirements. ADE and the Arizona Department of Emergency & Military Affairs (AZDEMA) are responsible for developing the minimum standards for school emergency operations plans in Arizona. Schools practice lockdowns and fire drills through-out the school year and staff members conduct online training about emergency/critical incident response.

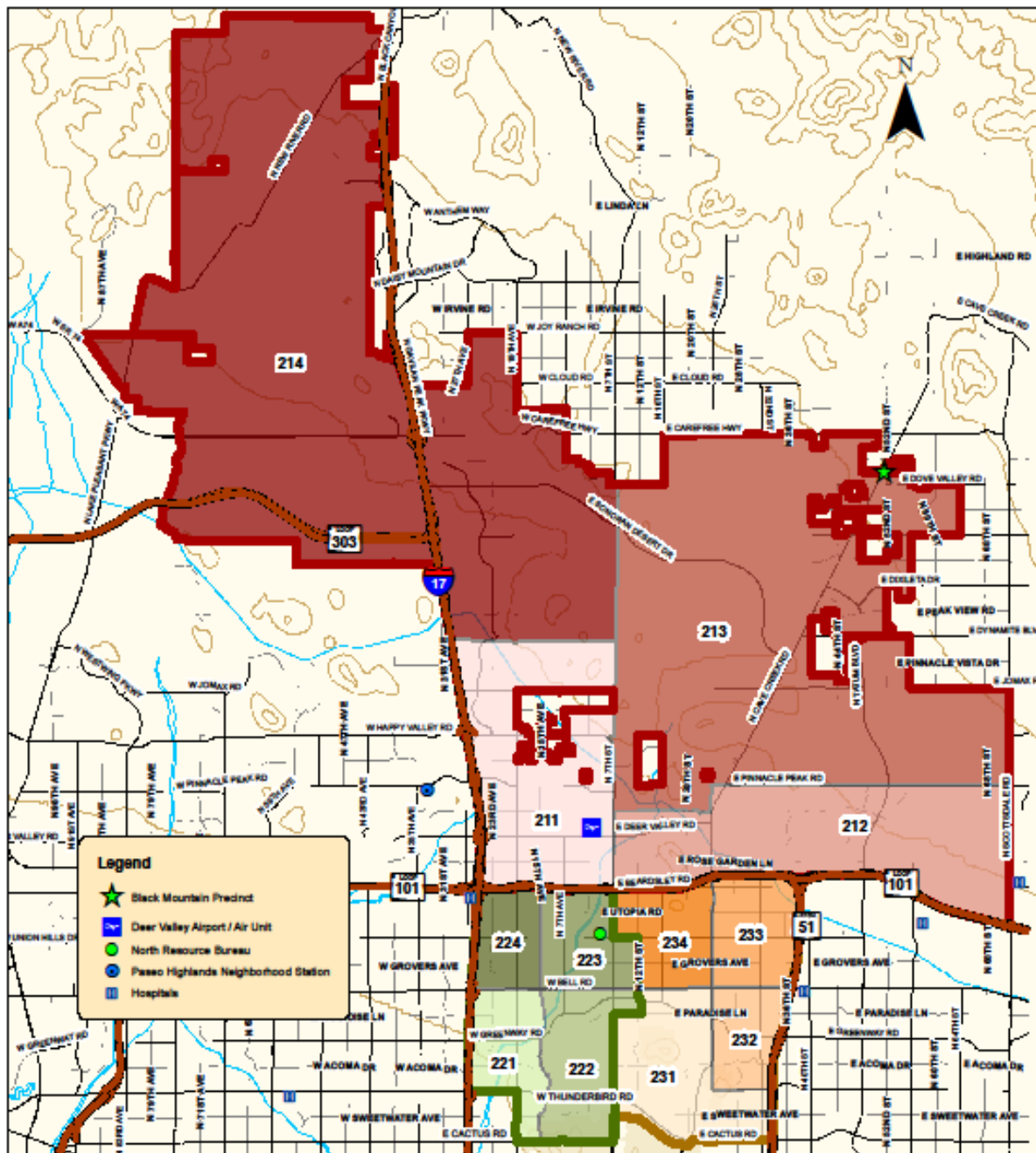

### Mileage Reimbursement Rate Change for 2022

The IRS has announced that the mileage reimbursement rate will change effective January 1, 2022 to 58.5 cents a mile. All PNP patrols prior to January 1, 2022 will still be reimbursed at the IRS rate at the time of the patrol, for all of 2021 it was 56 cents a mile.

Remember the PNP mileage reimbursement is only available to groups that successfully applied for mileage reimbursement funds in a BW grant for their neighborhood and are subject to the NBWGP guidelines and requirements.

### PNP merchandise order forms and cost updates:

As you are writing your grants, you might be budgeting for PNP equipment, like clothing, street signs and/or vehicle signs and are curious about expected prices for 2022. If any of you have bought groceries or filled up your gas tank you know there has been an increase in the cost of just about everything recently. The updated order forms are now online..

### Message from Councilwoman Ann O'Brien

While my week was filled with graduations, it did not stop me and my staff from representing you all in various community groups and our continued meetings with staff and stakeholders to bring forward policy solutions to the problems our communities are experiencing. On Tuesday of last week, I traveled with Councilwoman Stark to our neighboring city, Glendale, to tour their Real Time Crime Center. The technology used in Glendale allows the officers to tap into camera feeds and witness the crime and altercations happening in real time, allowing for dispatch to properly inform the officers responding of potential weapons or who the aggressor is to reduce confusion when arriving on scene. When a call comes in, their center can see if there are any cameras in that area and see if a crime is in progress. This technology helped them identify the criminal responsible for the shooting and killing of a 7-year-old girl last month which otherwise may have gone unsolved. I'm hopeful we can explore this technology as another tool for our Phoenix.

This week, we took a vote on the budget to send it out of Policy and onto the Formal Council Meetings to start the process of a final approval in June. I'm incredibly thankful to staff for all the hours they put into crafting a thoughtful budget. I'm supporting this year's budget because it takes a conservative approach to setting aside much of our surplus for a potential economic downturn, while also funding new positions within our Police Department and ensuring long-term funding for the successful gated alley program. Thank you to everyone who submitted comments and called in during all the budget hearings. It was your support for the gated alley program that convinced staff to make it a permanent fixture in the annual budget.

As you all know, I've been meeting with our stakeholders about how to increase our police recruitment efforts and retain our existing officers. We've had some success, as our recruitment numbers are increasing, and academy classes are being held more frequently. However, when you hear about what we'll be announcing a month from now, our numbers should sky rocket! I had a meeting yesterday with my team and staff from Human Resources to discuss compensation. Can't give you the details just yet, but in June, we'll be making a vote that will rock the City and the Valley. Something tells me we'll start seeing our numbers rise again!

Finally, I want to introduce a new addition to my office. On Monday, Gregory Whitney joined my team as our Policy Advisor. Gregory just graduated as a Marvin Andrews Fellow from ASU with a master's in Public Administration. Gregory comes from Tucson where he received his Bachelors - I won't hold it against him, considering he chose the right university for his Masters! Gregory's work experience includes the Pima County Library System, the Department of Justice, and most recently finishing out a position in the Peoria City Manager's Office.



You all have been asking, and it's finally coming! Soon, the hardest hit intersections in our district will prominently feature the above signs! Three signs have already been installed in the east part of Phoenix and our district will be next. We'll provide you more updates once these get installed!

Remember, donating to charities and wrap around services designed to aid those experiencing homelessness is far more effective than directly giving to the individuals. It's ok to say NO to panhandlers.

Thank you to everyone who advocated strongly for these signs!

**Phone Scam Alert** The Phoenix Police Department has been made aware of an ongoing phone scam. Members of the public have been receiving phone calls from an unknown person identifying themselves as a Phoenix Police Officer. The Caller ID shows the number as originating from different precinct phone numbers, which is not how outgoing phone calls from Phoenix Police precincts appear. The public should be cautious when releasing personal information to a person that is not a confirmed and trusted source. 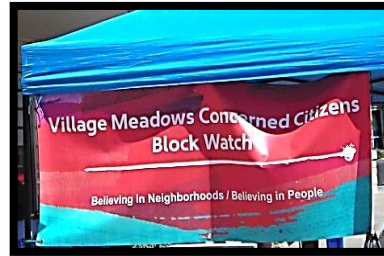

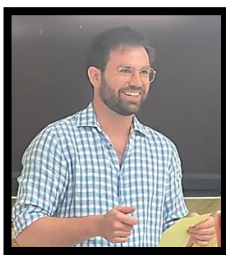

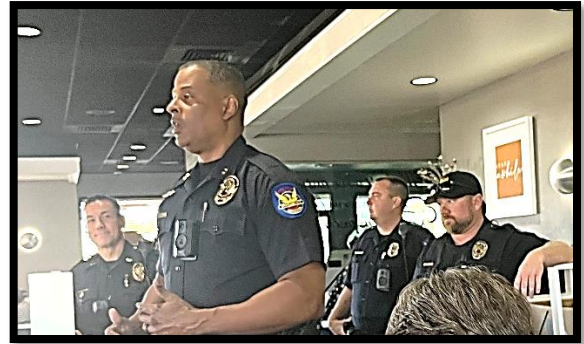

## Talk to Your Kids About Internet Safety

### *May 25th is Missing Children's Day*

One of the first missing children to be pictured on the iconic milk cartons was 6-year-old Etan Patz, who disappeared back in 1979 from a New York City street corner. In memory of the day Etan was kidnapped, President Ronald Reagan declared May 25<sup>th</sup> as National Missing Children's Day. As there were other highly publicized disappearances that garnered national interest in the following years, the mentality of "stranger danger" was fueled.

While this movement created invaluable organizations such as the **National Center for Missing & Exploited Children** (NCMEC) that assists law enforcement agencies bring missing children back home, it is also crucial to acknowledge what the reality of the situation is when it comes to child abductions. Although many people picture kidnapping to be perpetrated by a stranger, it is a far less common form of child abduction both historically and today. According to NCMEC, strangers abduct less than 1% of missing children while the most common form of kidnapping, by far, occurs by a parent, family member or acquaintance, accounting for over 90% of abductions. That being said, it is still important to remind children to avoid these rare scenarios by staying alert and aware at all times, especially if a stranger does approach them.

The discussion that we should be really focusing on talking to our children about is online safety.

As we head into the long and hot summer season, our options for staying entertained become limited and typically involve staying indoors probably accessing the internet in some shape or form. Moreover, the global pandemic has made us more reliant on the internet than ever before. This means that children have become more dependent on their electronic devices for social interactions.

While it may seem impossible to stay up to date with what apps, games and websites are most popular with kids nowadays, it is important to keep an open line of communication when it comes to internet use so that our children feel comfortable coming to us whenever a problem arises. The Department of Justice estimates that one in five children will receive an unwanted sexual solicitation online per year. Oftentimes, children don't come forward to tell a trusted adult because they are either too embarrassed or because they fear that their technology privileges will get taken away.

It is easier to come across inappropriate content than many people might realize, even if a child isn't actively looking for it. This can include pornography, excessive violence, hate speech and risky or illegal behaviors which can easily influence their developing brains. Other problems can include online scams, cyberbullying, sexting, sextortion (blackmail), or grooming from cyber predators.

In addition to these dangers, we also must worry about the toll that internet use, particularly social media, plays on the mental health of our children. Some studies now are suggesting that suicide and suicidal ideations among youth are much more prevalent now than ever before and that the internet seems to be playing a major role in this.

It can be easy to feel overwhelmed by these potential issues, but luckily a lot of this can be avoided by teaching our children to be intuitive while accessing the internet. Be sure to stay diligent by communicating the dangers of talking with strangers online, knowing which accounts your child has, setting up privacy controls, restricting time on devices, being aware of new trends/challenges on social media, and by checking with your service provider for additional information.

## Arizona MVD update: Three options to save time and hassle

### Federal Travel ID deadline is less than a year away

Beginning May 3, 2023, you will need a federally-compliant credential -- like the Arizona Travel ID -- to get past TSA checkpoints at airports for domestic flights. Without the Arizona Travel ID or other form of federally-compliant identification such as a valid U.S. Passport, fliers risk missing an airline flight because the non-travel driver license will not be accepted at TSA checkpoints.

This credential is distinguished by a gold star in the upper right corner and is available to Arizona residents as a driver license or identification card. You can walk-in to an office for this service, but we suggest [scheduling an appointment](#) and that can be done online at [azmvdnow.gov](#). Even if you haven't activated your AZ MVD NOW account, you can still schedule a Travel ID appointment.

Because the Arizona Travel ID is compliant with the federal standards, you will need to provide extra documentation. This includes:

- Proof of identity: a birth certificate or US passport
- Social Security Number: just the number, not the card
- Two documents proving Arizona residency: rental or bank statements, credit card or cell phone bills in your name with your current Arizona address, etc.

### Number of AZ MVD Now accounts now exceeds 3 million

More than 3 million Arizonans have discovered that [AZ MVD Now](#) is the safest, fastest and most convenient way to complete services with the Arizona Department of Transportation Motor Vehicle Division. Since launching in April 2020, more than 3 million Arizonans have activated their free [AZMVDNow.gov](#) account, giving them access to the primary online portal for MVD customers.

Here are some of the things you can do with your [AZ MVD Now](#) account:

- Go online and schedule your own in-office MVD appointments.
- View information related to your vehicle, including title and registration status.
- Complete more than 30 services, like registration renewals, ordering a duplicate license, change of address, registration refunds, title transfers, sold notices and more.

Every Arizonan with a credential -- a driver license or identification card -- or a vehicle registered in Arizona has an [AZ MVD Now](#) account. To activate your account, go to [AZMVDNow.gov](#) and follow the prompts.

### Arizona ID in Apple Wallet

We're excited to be the first state to allow drivers to add their license or state ID card to Apple Wallet. The choice may ease the sometimes arduous nature of getting onto a flight. This puts our residents at the leading edge of convenient, private and secure technology.

Using this feature in Apple Wallet is voluntary. If anyone prefers to use a physical credential at airport security, they may.

Once added to Apple Wallet, Arizona residents can present their driver license or state ID to the Transportation Security Administration at participating airport security checkpoints by simply tapping their device at the identity reader. Phoenix Sky Harbor International Airport is the first airport in America where passengers can use this technology. We're proud that this started here and will spread.

Credentials in Apple Wallet are private and secure. Users are able to choose what information they share. Biometric authentication ensures that only the person who added the ID to the device can view or present their information. If a resident loses their device, they can use the "Find My" app to easily lock, locate, or remotely erase it. Apple Wallet data is encrypted and protected against tampering and theft. Security features allow the MVD to securely verify identity.

## ADOT competing for \$300 million in added federal funding for I-10 expansion between Chandler and Casa Grande

*Money would supplement just-approved \$400 million state dollars*

When it comes to the long-awaited Interstate 10 expansion between Chandler and Casa Grande, more money means more lanes. With that goal, the Arizona Department of Transportation has submitted a proposal to get additional federal dollars to combine with state funds for the project.

ADOT has officially delivered a grant application through the [Federal Infrastructure, Investment and Jobs Act \(IIJA\)](#) for an added \$300 million to supplement the \$400 million state appropriation signed into law by Governor Doug Ducey earlier this month. That commitment of state dollars made ADOT eligible to apply for the federal competitive grant. There is also \$290 million previously budgeted, for a potential project total of \$990 million. Construction is funded in part by Prop. 400, a dedicated half-cent sales tax approved by Maricopa County voters in 2004.

ADOT is collaborating closely with the Gila River Indian Community and Maricopa Association of Governments on the I-10 project, and the ADOT application has also gained the vital support of the Arizona congressional delegation, state legislators, and local and regional elected officials. Additionally, more than 50 letters of support have been received from multiple chambers of commerce, trade associations as well as large and small businesses.

"This project is essential for Arizona to enhance the safety and traffic capacity of I-10 with the added benefit of positively impacting our economy," said ADOT Director John Halikowski. "Interstate 10 is a Key Economic Corridor. Commercial traffic on I-10 carries significant numbers of products and commodities, many of which are manufactured or produced right here in Arizona. These critical items reach every corner of the United States and internationally."

Halikowski added, "ADOT will do everything possible to leverage financial resources to expand and improve these 26 miles of highway and associated infrastructure. Applying for these federal funds speaks loudly to our commitment to the vision of moving Arizona and becoming the safest, most reliable transportation system in the nation."

The grant award announcement is expected sometime this fall. In the interim, an engineering and environmental study for the project is currently being completed in cooperation with the Gila River Indian Community and Maricopa Association of Governments (MAG). Additionally, a public hearing for the project is planned in late summer.

Following completion of required environmental review and clearance, the project is expected to start in 2023, beginning with expanding the bridges that carry traffic over the Gila River. Should the federal money not be awarded to the state, ADOT will have contingencies prepared to maximize the use of available dollars for lane expansion.

Target completion date for the full project is sometime in 2026.

### BLIGHT AND ZONING LAWS

**STRUCTURES:** The maintenance of a home is the responsibility of the property owner. Any wood, siding, shingles, roof covering, railings, fences, walls, ceilings, porches, doors, windows, screens and other exterior parts of any structure on the property must be maintained in weather tight, sound condition and in good repair. The property owner is responsible for making sure there are no doors or windows left open and not secure to the outside. **FOR HELP** call the Preservation Division of the Neighborhood Services Dept. at 602-495-0700 to see if you qualify for a free Grant!

**OUTDOOR STORAGE:** All outside storage that can be seen from the street should be inside sheds or cabinets. Items should not be set in car ports in view of the street. Please use enclosed areas or backyards.

**JUNK, TRASH & DEBRIS:** Junk, trash and debris cannot be left in the yard or car port and must be properly disposed of. This includes junk auto parts, appliances, furniture, building and/or landscaping material, trash such as discarded papers, cardboard, plastics, etc. including tree trimmings and fallen limbs or any other items that appear to have been discarded. The only exception is during the Bulk Trash Collection weeks four times a year.

**PARKING:** Parking is only permitted for passenger cars and motorcycles on residential streets, on driveways or in garages. A driveway or parking area must be constructed with an approved dust free parking surface. The stone must be 1/4 - 3/4 in size with a permanent border holding it in. 1/4 minus size stone is not allowed for parking. There are limits to the amount of front yard area that can be used for parking. Only 35% of the front yard may be converted to driveway or dust free parking.

**GRASS AND WEEDS:** Grass and weeds must not be allowed to grow over 6 inches high due to fire hazard, allowing the weeds to go to seed and spreading throughout the neighborhood and insect infestation.

**ELIMINATE GRAFFITI:** Keeping the neighborhood graffiti free is something we can all do. If there is graffiti on your property, please remove it as soon as possible. The Graffiti Busters Program provides paint, supplies and training to assist groups with eliminating graffiti. The City will also remove the graffiti from private property with written permission from the property owner. Call 602-495-7014.

### TOOL LENDING PROGRAM

Did you know the Neighborhood Services Department has a tool lending program? Yes, the Neighborhood Services Department (NSD) has a Tool Lending Program. Neighborhood groups and Community Cleanup organizations listed with NSD may borrow supplies and tools for neighborhood cleanups. Additionally, the Graffiti Busters Program offers paint for graffiti removal.

# CRIME TIPS:

## STUDENT LOAN BURDEN IS A BOON FOR CRIMINAL SCAMMERS

Student loan debt is a bigger burden than ever, with more than 43 million people carrying outstanding federal student loans. And while federal loan repayments have been paused again through August 31, consumers holding this debt are eager to find relief. And criminal scammers are eager to take advantage.

### HOW IT WORKS:

You receive an unsolicited contact offering to help navigate through state and federal programs to help you reduce or restructure your debt.

"Debt relief experts" may offer access to instant, easy-to-access loan forgiveness options, often connected to the COVID-19 pandemic.

These companies might ask for upfront payment or for personal information such as your Social Security number or your FSA ID (the username and password on your loan account).

### WHAT YOU SHOULD KNOW:

There's nothing that these companies can research for you that you can't legitimately find for yourself for free. Often, it is as simple as contacting your loan servicer or the U.S. Department of Education.

It is illegal for debt relief companies to collect payment from you before they get results, so upfront fees are a surefire sign of a scam.

Legitimate agencies and loan servicing companies will not ask you for information such as your Social Security number or FSA ID.

### WHAT YOU SHOULD DO:

Visit the Department of Education's [StudentAid.gov](https://studentaid.gov) site for free information on getting help with federal student loans.

Resist the urge to act quickly. Research any debt relief firm before providing them information or money, or signing any agreements. A good place to start is your state's consumer protection office or the Better Business Bureau.

Report suspected student loan fraud to the [FTC](https://www.ftc.gov) and the [Federal Student Aid Office](https://studentaid.gov).

If you've lost money to this scam, contact your local police, tell them you are a victim of a financial crime, and that you want to file a report. Push back if you're told not to bother — you will want a record of reporting the crime in the slim chance you could be eligible for restitution.

## SLIM-DOWN SCAMS CONTINUE TO MAKE GAINS

Many Americans are eager to slim down with the warm weather approaching, and scammers, as always, hope to pack their pocketbooks while we all try to unpack the pounds. In fact, according to the Federal Trade Commission, in 2021 bogus diet products and programs accounted for nearly 30% of all complaints in the category of health care scams.

### HOW IT WORKS:

A web search on weight loss pulls up legitimate-looking websites.

These sites may contain articles claiming celebrities have achieved amazing results from their weight loss program. 21

Other times, you'll see a social media post promoting new ways to lose weight.

### WHAT YOU SHOULD KNOW:

Diet and weight loss programs often encourage you to sign up for a free trial — which, if you read the tiny print, opts you in to getting charged for regular orders or additional products.

Weight loss products touted as "natural" or "herbal" don't necessarily mean "safe" or "wholesome." Some herbal ingredients are even toxic in certain doses.

Engage your inner skeptic. Ask yourself if the promised outcomes seem to match up with what the program offers.

### WHAT YOU SHOULD DO:

Seek advice from a trustworthy source, such as your doctor or a dietitian, before you commit to a weight loss regimen.

Be skeptical about a product or program promising you'll lose a specific amount of weight per day, week or month, or ads that tout weight loss products that are a "miracle," "revolutionary" or a "scientific breakthrough."

If a product claims to be backed by scientific studies, look up those studies to independently verify that they exist and are credible.

Check out a weight loss company's reputation by searching with the [Better Business Bureau](https://www.bbb.org).

## FRAUD PREVENTION EDITION

Year after year, a destructive flood of fraud sweeps the nation, leaving countless victims in its wake. Unfortunately, new and improved technology only gives fraudsters an edge. This makes it easier than ever for scam artists to siphon financial data from unsuspecting consumers. This personal data fuels a long list of financial crimes. Here are eight important tips that can help you avoid being a victim of fraud.

### 1. Never Wire Money to a Stranger

Whether you receive an email from a wealthy traveler who needs your help getting back to the U.S. or your long-lost cousin who claims to be in an emergency situation — NEVER wire money to a stranger. Once you wire cash (especially overseas), it's virtually impossible to reverse the transaction or trace the money. If you're worried about a family member or friend, check separately. They're probably safe at home. Be sure to alert them that their email has been hacked.

### 2. Never Give Out Financial Information

Never reveal sensitive financial information to a person or business you don't know whether they reach out to you via phone, text or email. This common scam is known as phishing. Scammers will contact you claiming to be from a retailer, financial institution or government agency. They may say your account has been compromised or needs to be updated. Remember, your bank or credit card company will never contact you and ask for your personal information. If you receive a suspicious call or email and are concerned about your account, call the credit card company or bank directly to check on your account status.

### 3. Never Click on Hyperlinks in Emails

If you receive an email from a stranger or company asking you to click on a hyperlink or open an attachment and then enter your financial information, delete the email immediately. Even if the email appears to be from your bank or credit card company, it's more likely a scam known as pharming.

#### 4. Use Tough-To-Crack Passwords

These days, a password like "12345" or "P@ssword" just isn't going to cut it. Hackers can easily crack passwords that are simple number combinations or a common pet name. Create passwords that are at least eight characters long and that include lower- and upper-case letters, numbers and special characters. You should also use a different password for every website you visit.

#### 5. Install Antivirus and Spyware Protection

Protect the sensitive information stored on your computer by installing antivirus, firewall and spyware protection. Once you install the program, turn on the auto-updating feature to make sure the software is always up-to-date.

#### 6. Don't Shop with Unfamiliar Online Retailers

When it comes to online shopping, only do business with familiar companies. If you're interested in purchasing a product from an unfamiliar retailer, do some research to ensure the business is legitimate and trustworthy. You can visit the [Better Business Bureau's Website](#) or search online for consumer feedback and complaints.

#### 7. Don't Download Software from Pop-Up Windows

When you're online, be wary of pop-up windows that appear and claim your computer is unsafe. If you click on the link in the pop-up to start the "system scan" or some other program, malicious software known as "malware" could damage your operating system.

#### 8. Make Sure the Websites You Visit Are Safe

Before you enter your financial information on any website, double-check the website's privacy rules. Also make sure the website uses encryption, which is usually symbolized by a lock to the left of the web address. When you see the lock, this means the information you're entering is safely encrypted and protected against hackers.

#### What's New: Fraud Trends to Watch for in 2022 Deepfake Audio Fraud

Deepfake Audio is an advanced form of voice phishing. The quality is typically high, meaning that it is extremely difficult for the human ear to discern a real voice from a deepfake. The fake audio uses machine learning and artificial intelligence to listen to the way a particular person speaks in order to mimic accent, pronunciation and pitch. Scammers take audio clips from interviews, announcements, speeches, presentations and other public events to create a fraudulent request for confidential information.

#### Peer-to-Peer or Real-Time Payment Fraud

As cash continues to go by the wayside, there's been a rise in payment fraud using peer-to-peer (P2P) or real-time payments. P2P payments are processed by some commonly-known apps such as Zelle, PayPal or Venmo.

P2P is simply an electronic transaction sent to another person using a mobile device. You may have a P2P app on your phone or built into your bank's mobile app.

#### Common types of fraud associated with P2P methods include:

- Scammers try to obtain money for a fraudulent charity, for goods or services, or debt payments. The FCC reports they are now asking for money to be sent to them via P2P instead of their previously used method of gift cards.
- Smart fraudsters convince customers to give out credentials and secure access codes to gain access to their payment apps or online banking.
- People falling prey to scams in which they're asked to process a refund by transferring money to themselves. In reality, the funds get transferred to the scammer.

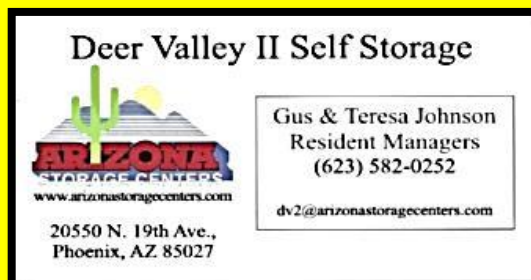

### Community Assistance Program

*For when you need help*

**When you need help, where do you turn?**

That is the question many Phoenix residents have when dealing with a crisis. Sometimes it's not clear what is the right place to call for help, especially when the issue involves someone having a mental health crisis.

**That's where the City of Phoenix Community Assistance Program (CAP) comes in.**

CAP is the City's program to respond to mental and behavioral health issues that might otherwise be addressed by police or fire department personnel.

The Phoenix City Council recently approved an expansion of the CAP to improve service delivery to individuals, contacting 911 experiencing behavioral and mental health issues or in need of emergency crisis response.

**Behavioral Health Specialists**

**What is CAP?**

It's an all-civilian group that includes five crisis response units with 17 full-time and more than 20 part-time positions, managed by licensed civilian professionals in social work and counseling.

**Why is CAP Important?**

Many times, police are called out to situations that don't require a law enforcement presence and can unintentionally increase the stress of someone experiencing a crisis. With CAP responders available the person in crisis can be helped to find the assistance they need.

**What does CAP Provide?**

- Grief support
- Mental and behavioral health supportive service
- Substance use disorder supportive services
- Short term case management
- Connectivity to community resources and supportive services
