Application for Use of Facilities - 2025

Trail Horseman's Society (THS) is located on Highway 22A, almost opposite Trail Regional Airport, and boasts many fantastic facilities including:

- ❖ Large steel fence enclosed main riding arena with bleachers and announcer's booth
- ❖ Dressage arena with bleachers and judge's booth
- ❖ Jump arena with full set of jumps and judge's booth
- ❖ Mountain Trail course
- ❖ Two large round pens
- ❖ Clubhouse equipped with kitchen, bathrooms, shower and hot and cold water (not potable)
- ❖ Two barns with stalls and power
- ❖ Outdoor pens
- ❖ Outhouse
- ❖ Parking for large number of vehicles
- ❖ Lots of space for camping with access to power at the barns
- ❖ Fire pit with bench seating and picnic tables
- ❖ Network of trails

This application form is a contract between the applicant and Trail Horseman's Society. Applicants must:

- ensure all participants follow THS policies and rules, which can be found on the THS web site
- ensure all relevant fees, including camping, stall use and non-member fees are paid to THS
- complete and submit an Event Reconciliation form on completion of the facility rental, along with any outstanding fees

All facility users must pay a 50% deposit to secure dates and cover potential damage or cleaning required. Deposit will be applied to total, or refunded, provided all damage has been rectified and cleaning completed.

I agree to the following terms and conditions of the rental of the Trail Horseman's Society facilities:

1. 50% of the applicable facilities use fee is required in advance as a damage/cleaning deposit
2. All facilities will be left as they were found.
3. Any damage incurred during the rental period is to be rectified, or paid for.
4. Trash will be picked up and removed.
5. Manure will be removed from stalls, pens, arenas and round pens put on manure pile.
6. Failure to clean up trash or clean stalls etc will incur a cleaning fee at \$15 per hour, which will be deducted from any deposit refund, or added to the final payment from the renter.
7. Instructors, coaches and clinicians must provide proof of their insurance, which must mention Trail Horseman's Society as an insured party.
8. All equestrian users of the facilities must have current HCBC (or equivalent PTSO or similar) membership and be prepared to show proof.
9. Any equestrian user of the facilities under the age of 19 must wear an approved helmet when riding or dealing with a horse.
10. Dogs must be kept under control and on a leash at all times.
